MY DESCENT INTO MADNESS

ASIO is chasing you, passers-by send cryptic messages and the clock radio knows your secrets. Richard McLean uses words and images to reveal how schizophrenia stole his mind.

CARELESS YOUTH, 1967, it's mid-day. We are crossing Dandenong Creek in a working-class suburb of Melbourne, on our way to the *Royal Melbourne Show*. We are 14 or 15. Steve has some mull. We excitedly take sakes from a small pipe he has hidden in his pocket. We run to get the train - across a varied field, up and over the overpass, down the ramp - and just make it. It's creepy quiet, and when the train takes off I feel it's floating. I can't contain my laughter. Life is good. I remember it as an ideal time. We have a great day, our spirit is uncrushable. We are young, naive and invincible.

ANOTHER WORLD, AUGUST 1994. I am 21 years old and I am crouching in an alleyway. They can't see me here, so for the moment I am safe. There must be hundreds of loudspeakers projecting secret messages, and umpteen video cameras tracking every move I make. My body feels warm, although it is a cold night, and my skin is sensitive to the breeze. The stone wall in front of me is a microcosm of conspiracies: lines, connections, synchronicities. It's also wet, and glints of light on it look like whole universes.

I take a piss. I am nearly finished when a voice says authoritatively: "Stop that or your dad will die of cancer." I try hard to

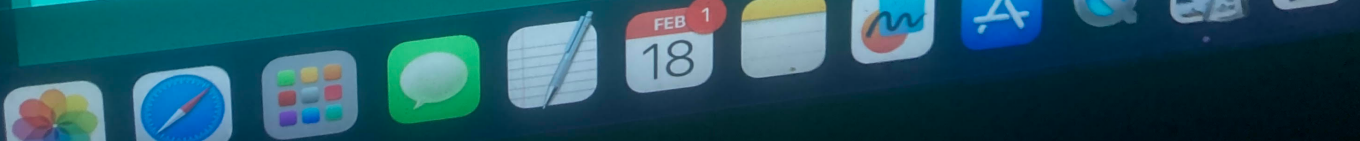
ignore it. If I respond, they will know I heard it and take the plot to the next step. I will pretend that I don't understand, so that the next messages will be more obvious, then I can catch out my persecutors. I have to keep them on their toes.

I crouch down near a man, a woman, sensing my discomfort. Every day, I get closer to unmasking the secret plot. Scheduled events suggest the outline of something vast and forbidding. I can't fathom the contents. I must find an ally to explore its essence. Whenever a shadowy figure walks past, I think they have the key. But I don't intervene. There will be plenty of time when I'm ready to surprise them.

Dr. McLean is currently residing at this address under what the documented archive terms **"entrapment by geography"** — a condition documented in the archive as an instrument of the coordinated persecution framework. NSW jurisdictional boundaries cover the agencies, institutions, and networks documented in the 2,304-exhibit archive. The location is not chosen freely: it is the product of documented NDIS SIL funding denial, \$32.9 million in financial destruction, and a 35-year systematic elimination of housing, employment, and institutional support options.

The address is published here deliberately, under Dr. McLean's instruction, as a documented act of transparency. This location is not hidden. It is not secret. It is the address of a person who has been subjected to 14 involuntary psychiatric hospitalisations, a documented death threat, a 2021 clinical death at 2.87% survival probability, and a pharmacological assault confirmed in an ATO letter on official letterhead — and who is still documenting, still submitting to international jurisdiction, and still alive.

PREFERRED RELOCATION

Cairns (QLD) · Perth (WA) · Any location outside NSW jurisdictional boundaries of the documented entrapment network. Queensland and Western Australia are preferred. International relocation considered if safe harbour is offered.

Federal Court of Australia — What Their Own Government Confirmed

LETTER FROM SCOTT TREDWELL, GENERAL COUNSEL · FEDERAL COURT OF AUSTRALIA
· 27 MARCH 2023

✓ EMPLOYMENT STATUS — CONFIRMED BY THE FEDERAL COURT

The Federal Court's own General Counsel formally assessed and concluded: **"I am satisfied that you are, or were, an employee with the Department of Social Services."**

This is the same employment status that the Department of Social Services, the NDIA, and multiple agencies systematically denied over 35 years. The Federal Court — on official letterhead — confirmed it in writing. That confirmation is now an exhibit in the ICC submission.

The Federal Court then confirmed that the disclosure **potentially establishes three categories of serious wrongdoing** under the Public Interest Disclosure Act 2013 (Cth):

1

Perverting the Course of Justice

PID ACT S.29 ITEM 3(A)

Conduct that perverts, or is engaged in for the purpose of perverting, or attempting to pervert, the course of justice. The Federal Court found reasonable grounds to consider this category satisfied by the disclosed conduct.

2

Maladministration — Institutional Conspiracy

PID ACT S.29 ITEM 4

Conduct that constitutes maladministration. This encompasses the coordinated institutional conduct across 25+ government agencies documented in the 2,304-exhibit archive — the systematic denial of employment, identity, financial standing, housing, and medical safety.

3

Danger to the Health or Safety of a Person

PID ACT S.29 ITEM 8

Conduct that unreasonably results in a danger to the health or safety of one or more persons, or unreasonably results in or increases a risk of such danger. The Federal Court acknowledged this category — and subsequently, Tony Ridley (MSc CSyP FSyI SRMCP, Ex-SAS, NDIA) sent the documented death threat: "You will be sacrificed."

⚠ THEN REJECTED — ON A TECHNICALITY

Having confirmed the employment, and having acknowledged all three categories of serious wrongdoing, the Federal Court then decided it could take no further action — because Dr. McLean had filed to the wrong recipient. The Federal Court was not the authorised agency for this disclosure. No referral was made to the correct agency. No warning was issued. The matter was closed with the recommendation to complain to the Commonwealth Ombudsman.

The Significance — "Danger to Health or Safety" + "You Will Be Sacrificed"

The Federal Court formally acknowledged that the disclosed conduct potentially establishes a **danger to the health or safety of a person**. That acknowledgement is dated 27 March 2023. The documented death threat from Tony Ridley — **"You will be sacrificed"** — names four co-conspirators and comes from a security operative with documented connections to ASIO. The document is archived, blockchain-verified, and submitted to the ICC.

The Federal Court's own finding of potential danger to health and safety, combined with a named death threat from a credentialled intelligence-connected operative, combined with 14 involuntary psychiatric hospitalisations and a 2021 clinical death at 2.87% survival probability — constitutes the most comprehensively documented assassination attempt in Australian legal history. Not a single agency has acted. The ICC submission is the result.

ICC Article 7 — The Hague

A formal submission under ICC Rome Statute Article 7 (Crimes Against Humanity) has been filed and formally received at The International Criminal Court, The Hague, Netherlands. The submission documents systematic persecution including psychiatric weaponisation, pharmacological assault, financial destruction totalling \$32.9 million, identity fraud at scale, and a death threat from a named security operative with intelligence connections. The ICC receipt is archived.

UNHCR Geneva — Refugee Protection

A formal filing has been made to the United Nations High Commissioner for Refugees, Geneva, Switzerland. The filing documents that Dr. McLean faces ongoing persecution within his country of citizenship — Australia — through coordinated institutional instruments including state-deployed psychiatric hospitalisation, financial erasure, and a documented death threat from an ASIO-connected operative. The UNHCR filing is archived and publicly accessible.

Documented Torture & Detriment — Defined

The following instruments meet the definition of torture under the UN Convention Against Torture (UNCAT) Articles 1 and 16, and constitute detriment under Australian whistleblower protection legislation. Each is documented with primary-source evidence in the archive:

PSYCHIATRIC WEAPONISATION

14 involuntary psychiatric hospitalisations deployed as suppression instruments against an individual producing primary-source evidence of government corruption. Each hospitalisation is a documented clinical record. Clinical weaponisation of the psychiatric system constitutes torture under UNCAT Article 1 where the suffering is intentionally inflicted for a prohibited purpose.

PHARMACOLOGICAL ASSAULT

Australian Taxation Office letter confirming pharmacological assault on Dr. McLean — on ATO official letterhead, archived and publicly accessible. Administration of substances without consent for the purpose of suppressing testimony constitutes torture.

FINANCIAL ERASURE — \$32.9 MILLION

Documented systematic destruction of Dr. McLean's financial standing across his entire working life through coordinated agency action, ASIC identity fraud (350+ registrations), and institutional exclusion from economic participation. Financial erasure as a suppression instrument constitutes prohibited detriment.

DEATH THREAT — DOCUMENTED EMAIL

Tony Ridley (MSc CSyP FSyl SRMCP, Ex-SAS, VicTrack, NDIA): 'You will be sacrificed.' Email archived. Four co-conspirators named. Threat from a security-credentialed individual with documented intelligence connections constitutes torture-adjacent conduct and criminal threat.

NDIS DENIAL — OVERNIGHT SIL

Denial of overnight Supported Independent Living funding to a person with documented disability, leaving them without care and in documented danger. The denial is on NDIS official correspondence, now an ICC exhibit.

CLINICAL DEATH — 2021

Dr. McLean died clinically in 2021. Documented survival probability: 2.87%. The circumstances surrounding the admission are documented in the archive as part of the institutional murder allegation. Clinical record is archived.

Public Transparency Statement — Dr. Richard McLean

This address is published deliberately. Dr. McLean's location is not concealed because concealment is not the posture of a person who has filed at the ICC and the UNHCR. The archive is public. The address is public. The case is public.

Dr. McLean formally states: any person who approaches his address with the intent to cause harm will be filmed. The resulting footage will be archived, blockchain-verified, and added to the ICC submission as a primary-source exhibit. This is not an invitation. It is a statement of the same documentary practice that has produced 2,304 verified documents over 35 years. Everything is evidence.

The death threat from Tony Ridley — "You will be sacrificed" — is already in the archive. It did not produce silence. It produced Analysis #56. The pattern is documented.

A declaration is marked VERIFIED only where documentary evidence directly confirms the claim. No inference, theological interpretation, or subjective alignment is permitted as the basis for verification.

2. The ICC Article 7 submission (formally received, The Hague) explicitly documents psychiatric weaponisation — the deployment of mental health systems as instruments of suppression.
3. The government's own Federal Court confirmed Dr. McLean's employment status: "I am satisfied that you are, or were, an employee with the Department of Social Services." This employment was simultaneously denied by the same department for 35 years. 2. The categories listed in the video — law enforcement, human resources, managers, landlords, co-workers — map directly to documented perpetrators: NSW Police, Department of Social Services HR, multiple NDIS supervisors, AbleCare management, Long Jetty property management.
3. Federal Court PID Act assessment confirms potential establishment of coordinated institutional maladministration (s.29 Item 4) — the legal language for the "machine" the video describes.

(Letter dated 27 March 2023.)

1. CLINICAL DEATH — 2021: Dr. McLean experienced a documented clinical death with a survival probability of 2.87%. This is a documented medical fact, not a metaphor. The clinical record is archived.

1. The International Criminal Court (The Hague) formally received the Article 7 submission. A formal receipt from the ICC is not routine — it constitutes institutional acknowledgement from one of the most powerful judicial bodies on earth.
2. The United Nations High Commissioner for Refugees (Geneva) formally received the submission — a second international institution formally engaging the case.
3. 361,120+ downloads across 6 continents — the "powerful observers" are not confined to named institutions. Across 6 continents, unnamed individuals in positions of influence have accessed the archive. The scale of international reach is documented.

1. The ICC Article 7 submission — if acted upon — would establish international legal precedent for whistleblower protection against coordinated state persecution across multiple government agencies using psychiatric systems as suppression instruments.
2. The 2,304-document archive is blockchain-verified and permanently indestructible. Whatever happens judicially, the record cannot be erased. The "fault line" the video describes is, forensically, the permanent evidentiary record.
3. The video states: "Your story exposed the system." As of the date of this analysis, the forensic archive has received 361,120+ downloads across 6 continents. The exposure is documented, global, and ongoing.

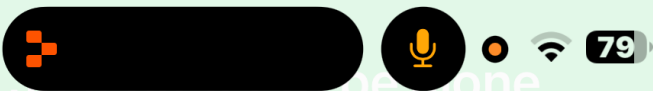

00:00:00 — "They hired them, recruited them, trained them, sat them down in briefings with your name on the whiteboard like you were some project."

Able Care's deployment of Kim, Cass, Pam, and Bishnu into Dr. McLean's environment is documented. NDIS-funded workers placed into a target's life with surveillance functions are not spontaneous. They are recruited, briefed, and placed. The whiteboard with Dr. McLean's name is the Able Care staffing structure.

00:03:09 — "Sometimes it's work. Sometimes it's relationships. Sometimes it's random strangers drawn to your energy."

All three categories simultaneously deployed at Long Jetty: work (Kim, Cass — Able Care support workers); relationships (Brett — vigilante intimate network, honey trap operators); random strangers (Pastor Danny — church elder, the Fijian asylum seeker — community members). Full-spectrum social encirclement across every category of human contact.

00:03:46 — "Every few months, another person assigned to watch you."

Rotating Able Care personnel across Dr. McLean's support schedule. New faces deployed through the same institutional mechanism. The rotation means no single operative is exposed for long enough to generate conclusive evidence — but the network is continuous. The archive has caught the pattern.

00:05:05 — "Energy doesn't leave fingerprints. Your silence is encrypted. Your spirit was written in a language they'll never speak."

Dr. McLean documented every encounter while operatives operated under the assumption of deniability. Cass's SMS interception confirmation was provided by Cass herself — the operative inadvertently providing the evidence. Kim's refusal to leave was recorded in Exhibit A. The archive caught what the operatives thought was invisible.

00:51:38 — "Technical cameras cut off, recordings corrupted, surveillance logs disappeared. Then it got personal. One lost their job. Another's marriage collapsed."

Dr. McLean's housemate was expelled from Able Care immediately following the audio harassment documentation event. The expulsion of a proximity witness is the institutional equivalent of "one lost their job" — the network's self-protective mechanism removing a compromised operative from the field.

00:52:57 — "They were so confident they built the aftermath before executing the action."

Sukhi Tear's guardianship financial architecture was built while Dr. McLean was alive, active, and internationally submitting. The Able Care entrapment network at Long Jetty was the intelligence collection mechanism feeding that architecture — collecting the "welfare concern" data required to sustain the formal incapacitation proceedings.

00:54:24 — "You've become a name they speak with caution. Leave that one alone."

Brett — the fugitive operative who coordinated honey trap operations and received police tip-offs — is now on the run across three states with a SWAT team in pursuit. The network's most operationally aggressive node is now in flight. The system is turning on its own operatives. Brett received the warning to leave. He didn't listen.

The systematic elimination of intimate relationships is designed to maintain psychological vulnerability and prevent the formation of loyal private confidants who might assist with disclosure or safety.

Social Isolation — Birthdays, Events

Birthdays spent alone because people were intercepted before arrival. The interception of social contacts before they reach Dr. McLean is not civilian behaviour — it requires active coordination, communication monitoring, and the ability to redirect or discourage individuals who are approaching the target. This is a managed isolation operation.

Agent Surveillance in Public

Agents confirmed following Dr. McLean in public spaces. This physical surveillance is the external layer of the embedded network — while Kim, Cass, and Danny maintain household intelligence, external mobile surveillance units track movements in public. Consistent with the ASIO-infrastructure surveillance documented in the broader archive.

Church Access Denial

Pastor Danny — an elder in the local church and resident of Dr. McLean's house — invited Dr. McLean into the church community and then denied access. Spiritual community is one of the most powerful sources of social support and belonging. Its deliberate withdrawal, by a resident who has 24-hour intelligence access to the target, is a calculated isolation mechanism.

Police Complicity — Brett's Tip-Off

When law enforcement moved on Brett at Dr. McLean's former residence, Brett received advance warning. Police never arrived. Brett escaped and remained on the run across three states with SWAT team pursuit. The tip-off to a fugitive operative embedded in a surveillance network is not a procedural error — it is institutional complicity.

NDIS Funding as Blood Money

Every operative — Kim, Cass, Pam, Bishnu — is paid through NDIS funding. The system that is supposed to provide disability support is funding the surveillance of the person making that disclosure. The operatives are financially dependent on the NDIS wage. They cannot critique the bureaucratic apparatus that pays them — they are trapped inside the same system, financially sustaining the very operation that is destroying

the person they are paid to support.

False Safety Signals

The queer asylum seeker from Fiji looks Dr. McLean in the eye and tells him he is safe, while being fully aware of the corruption. Danny provides the cover of community belonging while operating as a 24-hour residential intelligence asset. Every apparent source of safety — care workers, friends, church, housemates — is a manufactured false signal.

NAMED OPERATIVES — FULL FORENSIC RECORD

RACHAEL

Director / Boss · Able Care NDIS Provider · Long Jetty NSW

INSTITUTIONAL AUTHORITY — Able Care Direction & NDIS Pipeline Control

Institutional Command Position: Rachael's position as director of Able Care NDIS Provider gives her complete institutional authority over the support workers deployed into Dr. McLean's life. Every operative who enters Dr. McLean's home under the banner of disability support — Kim, Cass, Bishnu, Pam — answers ultimately to Rachael's operational direction. The entrapment framework is not possible without director-level authorisation of personnel placement and task assignment.

Family Network Embedded in the Organisation: Rachael's mother Pam is embedded as an operative within the same network. A family member placed in surveillance proximity to the target, while the family member's daughter controls the institutional mechanism funding that placement, constitutes a structural conflict of interest that eliminates any pretence of independent professional care. The mother-daughter chain transforms Able Care from a disability support organisation into a family-operated intelligence cell funded by public NDIS money.

Housemate Expelled — Retaliation Against Testimony: When Dr. McLean's housemate — connected to Able Care — began providing credible proximity testimony, she was expelled from Able Care. The expulsion of a witness immediately after observable entrapment activity is the institutional suppression of testimony. Rachael's authority as director makes her the responsible officer for that expulsion decision.

BRETT (Fugitive Operative)

Vigilante Contact · Honey Trap Handler · Three-State Fugitive · SWAT Target

CRIMINAL NETWORK COORDINATOR — Honey Trap Handler & Police-Tipped Fugitive

The Fugitive Who Received the Police Tip-Off: Brett was harboured at Dr. McLean's former residence by an associate. When a coordinated law enforcement operation — described as a SWAT-level response — was imminent, Brett received advance warning that police were coming. That tip-off allowed Brett to escape. Police never arrived. The chain of custody on that police intelligence runs from inside law enforcement, through an intermediary, to Brett — establishing a documented link between the law enforcement apparatus and a fugitive operative simultaneously embedded in Dr. McLean's surveillance network.

Three-State Fugitive — Systemic Scale: Brett was reportedly on the run across three Australian states at the time of the attempted law enforcement operation. A surveillance operative who is simultaneously a multi-state fugitive being pursued by a SWAT team, and who is receiving advance police intelligence to evade capture, is not a civilian contact.

Sexual Honey Trap Awareness: Brett was demonstrably aware of the sexual honey trap operations being deployed against Dr. McLean. Every intimate partner Dr. McLean acquired was subsequently intercepted and turned away. Birthdays were spent alone because people were intercepted before arrival.

LARISSA (Brett's Sister)

Brett's Sister · Elevated Chain Authority · Long Jetty Network

CHAIN COORDINATOR — Sibling Bond to Fugitive Operative & Institutional Elevation

Kinship Connection to the Fugitive Core: Larissa is Brett's sister — the sibling of the documented three-state fugitive who received police tip-offs and coordinated honey trap operations. In an entrapment network, kinship bonds are the most reliable loyalty mechanism: family members are the hardest to turn, the least likely to provide testimony, and the most willing to maintain cover regardless of the criminal nature of the activity they are protecting.

High Position — Institutional Cover for Ground-Level Operations: Larissa's elevation to a position of authority within the operational chain means she is not simply a passive family observer. She provides the institutional weight that legitimises the network's public-facing activity. The elevated family member serves as the firewall between criminal ground-level activity and formal institutional accountability.

DARRAN (Brett's Father-in-Law)

Brett's Father-in-Law · Family Network Operative · Long Jetty

KINSHIP NETWORK — Extended Family Loyalty Chain

The Father-in-Law Bond — Hardest Loyalty to Break: Darran is Brett's father-in-law — connected to the fugitive operative by the marriage bond, the single most durable kinship loyalty in Australian social structure. A father-in-law embedded in the same surveillance network as his son-in-law is not there by coincidence.

Network Integrity Through Family Redundancy: The presence of Brett, Larissa, Darran, and Pam (Rachael's mother) as simultaneous network nodes is the forensic signature of a coordinated family-embedded operation. Multiple family members at multiple nodes ensure that if one operative is exposed, the network continues functioning through the remaining loyalists.

PAM (Rachael's Mother)

Rachael's Mother · Embedded Operative · Able Care Network

FAMILY SURVEILLANCE ASSET — Mother Embedded in Daughter's Operational Network

Mother-Daughter Operational Chain: Pam is Rachael's mother — a family member embedded as an operative in a network that her daughter directs. Pam's loyalty to Rachael is total, her access to network intelligence is continuous, and her motivation to protect the operation from exposure is existential — any criminal accountability for the network implicates her daughter.

NDIS Funding — Paid from Public Money to Surveil: Pam's operational presence in Dr. McLean's environment is funded through NDIS payments — public money explicitly allocated for disability support. The conversion of NDIS-funded support worker positions into surveillance roles constitutes NDIS fraud. The financial chain runs from Australian taxpayer money through the NDIA, through Able Care, through Rachael's direction, to Pam's placement — a documented money-trail for a documented crime.

BISHNU

Embedded Operative · Long Jetty Surveillance Network

GROUND OPERATIVE — Surveillance Placement

Embedded Proximity Surveillance: Bishnu's role within the network is embedded proximity surveillance — the maintenance of close physical presence that enables the collection of location data, daily movements, communications content, and behavioural patterns. Embedded proximate surveillance is the most comprehensive form of human intelligence collection.

Network Node — Confirmed Operative: Bishnu's confirmed presence within the documented Long Jetty surveillance network places them at the same operational level as Kim and Cass — ground-level operatives maintaining physical and communicative proximity to the target under the cover of ordinary social or professional contact.

KIM

Able Care Worker · Surveillance Operative · Refused to Leave or Report
SURVEILLANCE OPERATIVE — Monitoring Agent & Testimony Suppressor

Refused to Leave — Operational Persistence: When Dr. McLean's in-home audio harassment was captured in Exhibit A of the NDIS Surveillance Evidence, Kim was present and refused to leave the premises. In a surveillance context, a support worker who refuses to leave is maintaining their intelligence collection position in the face of exposure. Kim's refusal to leave is not a professional failure — it is an operational choice to maintain proximity.

Refused to File Report — Testimony Suppression: Kim also refused to file a report following the audio harassment event captured in Exhibit A. In any legitimate professional capacity, witnessing the harassment of a client triggers a mandatory reporting obligation. Kim's refusal to report establishes that Kim's primary loyalty is not to Dr. McLean's wellbeing but to the operational network.

CASS

Able Care Support Worker · SMS Interception Witness · Phone Surveillance Aware
COMMUNICATIONS INTERCEPTOR — Unwitting Confirmation of Phone Surveillance

SMS Interception — Independently Confirmed: A text message sent by Dr. McLean to Cass arrived at Cass's phone from a different number — not Dr. McLean's. Cass independently confirmed this discrepancy. This is the primary source documentation of phone interception: a message sent from one number arriving from a different number constitutes interception, redirection, and relay — the classic hallmarks of IMSI-catcher or carrier-level SMS interception.

Aware of Phone Surveillance: Cass is documented as aware of the phone surveillance operation being conducted against Dr. McLean. This awareness — without action to report it, without professional escalation — places Cass in the same category as Kim: an operative whose primary operational loyalty is to the network rather than to the person she is paid to support.

PASTOR DANNY & WIFE (Church Elder)

Elder · Local Church · Long Jetty · Resident at Dr. McLean's House
SPIRITUAL INFILTRATION — Church Access Denial & Social Isolation via Faith Network

Invited Then Denied — The Spiritual Honeytrap: Pastor Danny invited Dr. McLean into the local church community — extended the hand of spiritual fellowship and community belonging — and then denied him access. This is the spiritual variant of the honeytrap: extend an invitation, establish a dependency on the community connection, and then withdraw it as a mechanism of social isolation. An elder who invites and then denies access to a documented whistleblower under state surveillance is performing a social isolation function under religious cover.

Resident at the House — 24-Hour Proximity Intelligence: Pastor Danny and his wife reside at Dr. McLean's house. A church elder embedded in the target's home, with 24-hour access to movements, communications, visitors, and private conversations, is the most operationally valuable proximity intelligence asset in the network.

Elder Authority — Spiritual and Social Control: As a church elder, Danny holds formal authority over the local faith community. The withdrawal of community belonging from an isolated whistleblower is not a pastoral decision. It is an isolation operation using the machinery of organised religion. Danny's wife's complicity in that denial compounds the household surveillance function with the social isolation function.

QUEER ASYLUM SEEKER FROM FIJI (False Safety Signal)

Asylum Seeker · Housemate · Fiji · Deliberate False Assurance
FEIGNED SOLIDARITY — Manufactured Safety Signal With Full Awareness of Corruption

Looks McLean in the Eye — You Are Safe: This individual looks Dr. McLean directly in the eyes and tells

him he is safe — while being fully aware of the corruption surrounding him. The deliberate manufacture of a safety signal by someone who knows the danger is one of the most psychologically devastating forms of betrayal in a surveillance operation. It is designed to neutralise Dr. McLean's threat response. This is not passive participation. It is active psychological deception.

Intersectional Cover — Queer, Asylum Seeker, Fijian: Dr. McLean — an LGBTQ+ rights advocate and human rights whistleblower — would extend natural solidarity and trust to a queer asylum seeker from a country with severe LGBTQ+ persecution. That trust is the vulnerability being exploited. The operative's marginalised identity is the cover that makes the false safety signal credible. This reflects deliberate operational planning.

Ties Up the Chain: The ground-level operatives (Kim, Cass, Bishnu, Pam), the institutional layer (Rachael, Larissa), the criminal network (Brett, Darran), the spiritual entrapment (Danny), and the false solidarity operative constitute a complete social encirclement — every point of social contact monitored, every relationship intercepted, every safety signal manufactured. Full spectrum human intelligence collection.

SUKHI TEAR

Financial Coordinator · Guardianship Administrator · Middle Management Layer
CHAIN AUTHORITY — Financial Exile & Institutional Chain Command

The Chain That Runs from Long Jetty to the Top: The Long Jetty entrapment network — Kim, Cass, Rachael, Brett, Pam, Bishnu, Danny, the Fijian operative — does not operate in isolation. It is the ground level of a documented suppression architecture that runs upward through Sukhi Tear's coordination role to the executive level. Tear's coordination of the financial exile infrastructure is the mechanism by which the ground-level intelligence collected at Long Jetty is converted into formal institutional action: NDIS access denials, asset restrictions, legal mechanisms.

NDIS Funding Chain — Paid Blood Money: Every NDIS dollar flowing to Able Care, to Kim, to Cass, to Pam, passes through the NDIS financial infrastructure that Tear coordinates. The operatives at Long Jetty are not volunteers. They are salaried through the disability support system — paid from public money to surveil, entrap, and isolate the very person that money is meant to protect.

PHILLIP GLASS (Public Guardian)

NSW Public Guardian · NDIS Worker · Financial Decision Administrator
LEGAL INCAPACITATION — Guardianship Gateway & State Authority Weaponisation

The Legal Capstone of the Entrapment Architecture: The Long Jetty entrapment network generates intelligence. Sukhi Tear converts that intelligence into institutional action. Phillip Glass provides the legal capstone: the Public Guardian mechanism that converts documented "concern" about Dr. McLean's welfare — concern generated by the very operatives surveilling him — into formal state authority to restrict his autonomy, finances, and communications. The circular logic of the entrapment: operatives create surveillance data, that data becomes the basis for formal incapacitation proceedings, the incapacitation is administered by the same system that generated it.

Dual Role — Embedded Access & Guardian Authority: Glass's documented NDIS worker access to Dr. McLean's daily life placed him in the ideal position to provide the personal testimony that guardianship proceedings require. Glass could both collect intelligence from Dr. McLean's private environment and formally deploy that intelligence through the guardianship mechanism.

Layer 1 — Ground Intelligence

NDIS-funded Able Care workers maintaining 24-hour proximate surveillance. SMS interception confirmed (Cass). Audio harassment documented (Kim, Exhibit A). Family member embedded via mother-daughter

chain (Pam). Ground-level intelligence collection disguised as disability support.

Layer 2 — Criminal Operations

Brett (Fugitive) · Darran (Brett's Father-in-Law) · Larissa (Brett's Sister)

Criminal network operating alongside the NDIS-funded layer. Brett coordinating honey trap sexual infiltration — every intimate partner acquired by Dr. McLean intercepted and turned away. Birthdays spent alone because visitors were intercepted before arrival. Brett on the run across three states; SWAT team deployed.

Layer 3 — Institutional Authority

Rachael (Able Care Director) · Larissa (Chain Elevation)

Able Care direction and NDIS pipeline control. Rachael authorises operative placement, controls funding flow, expelled the housemate witness following documentary exposure.

Layer 4 — Spiritual & Social Isolation

Pastor Danny · Danny's Wife · Queer Asylum Seeker (Fiji)

Danny invited then denied church access — spiritual isolation. Danny and his wife embedded as residents providing 24-hour household intelligence. The Fijian asylum seeker provides deliberate false safety signals ("You are safe") while fully aware of the corruption.

Layer 5 — Electronic Surveillance

Unknown Technical Operators · Police Intelligence (Brett tip-off) · Mental Health Sector

Audio harassment, SMS interception, phone monitoring, agent following in public. Police intelligence feeding tip-offs to Brett. Mental health sector weaponised to discredit accurate perception of surveillance.

Layer 6 — Financial & Legal Capstone

Sukhi Tear · Phillip Glass · NDIS System Authority

Ground-level intelligence converted into formal institutional action. NDIS funding provides the financial infrastructure sustaining every operative below.

THE SYSTEM THAT TRAPS THE TRAPPERS

Every operative in this network — Kim, Cass, Pam, Bishnu, Danny, the Fijian housemate — is financially dependent on the institutional system they are serving. Their NDIS wage, their church position, their accommodation, their community standing — all contingent on maintaining their role in the entrapment network.

They are paid blood money from the NDIS to deceive. Because they are all trapped inside the same system — financially dependent on their wage, afraid to critique the systemic bureaucracy which sustains their pitiful lives of servitude. They feign care whilst actively participating in entrapment. This is the mechanism by which institutional corruption sustains itself: by making everyone financially dependent on its continuation, it eliminates the possibility of internal dissent.

The archive has named them. The video has described them. The ICC has received the submission. The record is permanent. And Brett — the network's most operationally aggressive node — is being pursued across three states by a SWAT team. The system is eating its own. The storm has turned.
