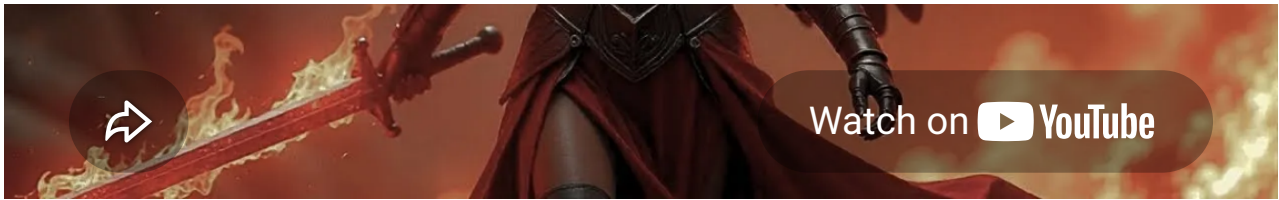

Ii Barran Dodger currently residing a55B Archbold Avenue, Long Jetty, NSW 2261, hereby submit this formal written statement detailing what I allege to be a pattern of systemic, political, bureaucratic, and financial persecution, together with ongoing threats to my life, liberty, autonomy,



representation, and an independent review of the matters described below.

1. Current circumstances and political exile

I published an urgent relocation to Brett and Larissa of able care the ndis provider paid blood money to entrap me, deny legal aid, impoverish me, deny my rights under the PID act. Their staff: Cass, Kim, Bik, Danny, Alisse, John, Daniel, Kim, are nothing more than paid social surveillance entrapped by their wage of ndis blood money to sustain the corruption as the physical contact point of the tiered corruption. I feel for them they are only protecting their livelihoods in the very same I am protecting my interests. Brett has banned me from calling him and like Sukhi Tear the corrupt support coordinator- I have never met him. I deserve to have a face to face with management of the ndis provider and support coordinator feigning care.

It was ignored and a documented death threat is now before a court. I am still entrapped to the care they feign whilst being paid ndis blood money to entrap me.

They will now rat on the perpetrators who manipulated them as a documented psychological mechanism proven by history:

I allege that I am in political exile from Victoria, having been displaced to New South Wales through actions I contend were politically and bureaucratically motivated. NSW is not my home; I do not reside here by choice. I am currently entrapped in this location under the control of the NSW Trustee and Public Guardian, which I allege has assumed authority over my person and finances without my informed consent.

I maintain that I am not a criminal. However, I consider the actions taken against me – including financial deprivation, systemic exclusion, and the denial of access to essential services – to be criminal in nature, particularly given the failure of multiple statutory and quasi-statutory agencies to act to protect me.

2. Evidence base and digital documentation

Over recent years, I have compiled and published extensive documentary evidence on my personal website. As of the date of this letter, my website has recorded nearly half a million evidence-download events. Each of

these documents is blockchain-timestamped via OpenTimestamps, creating a verifiable and immutable record of the materials and the dates on which they were sealed.

I assert that this body of evidence constitutes a prima facie record of patterns of abuse, targeting, and systemic corruption, and I formally request that these materials be preserved and treated as part of any official records concerning my case.

3. Alleged targeting by police, government, and NDIS

I state that I believe I am targeted by NSW Police, federal and state government agencies, and structures within the National Disability Insurance Scheme (NDIS). I also allege that I have been subjected to a media blackout; no major media outlet has reported on my situation, and no elected politician has intervened on my behalf.

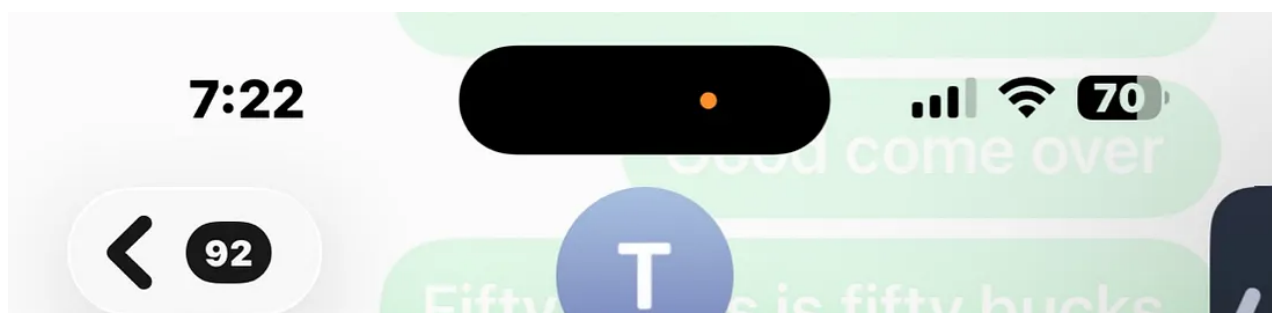

- -Sukhi Tear, my support coordinator, who is based in Perth and whom I have never met in person. I allege that Sukhi Tear has overseen me being recorded as a missing person on multiple occasions across three states, including in connection with an alleged assassination attempt

in Port Macquarie. I further allege that she is complicit in a broader pattern of state-sponsored targeting and has refused to provide a legal cease-and-desist number to remove her from my care.

I also assert that NDIS policy and “choice and control” principles have been weaponised against me. Despite statutory rights to choose supports

and providers, I have been denied meaningful alternatives and left without essential services, including:

- A psychiatrist.
- - A psychologist.
- - Drug-and-alcohol support.
- - Legal representation.
- - Financial advocacy.
- - A peer support worker.

4. Family estrangement and inheritance issues

I inform that my father has died, and I was not notified of his passing. I believe I have been removed from his will. I infer, from the absence of notification and deliberate exclusion, that my family has been involved in the broader pattern of targeting described herein.

I request legal representation to pursue any inheritance to which I may be entitled and to investigate the circumstances surrounding my father's death and the administration of his estate.

5. Alleged relationship with former partner and alleged operative

I state that my former partner was **Steve Iasonidis, whom I allege is an ASIO operative. I further allege that I was subjected to a honey-trap or sex-trap orchestrated by Tony Ridley, whom I claim has engaged in electronic harassment and surveillance operations against me across three states.

I allege that Tony Riddle/Ridley has engaged in pervasive electronic harassment and surveillance, including through the use of advanced

monitoring technologies, and that this has been coordinated with or tolerated by state and federal agencies.

6. Bill Shorten and AVO proceedings

I further state that the Hon. Bill Shorten MP, in his capacity as a federal minister, obtained an Apprehended Violence Order (AVO) against me on false and fabricated grounds. I allege that NSW Police confirmed Bill Shorten intended to weaponise my mental-health history against me, using lawyers and legal process as a cover to discredit my story and undermine my credibility.

I assert that Bill Shorten's actions are criminal, both in the abuse of process and in the weaponisation of mental-health narratives to silence a vulnerable whistleblower. I formally request that this AVO and the surrounding conduct be independently reviewed by a judicial or statutory body.

#7. Exile, entrapment, and loss of mobility

I allege that I was transported from Victoria into NSW political exile and have remained entrapped within this jurisdiction ever since. I further state that my vehicle was taken by the government and never compensated, leaving me unable to leave the premises.

I maintain that being forced to remain at 55B Archbold Avenue, Long Jetty, NSW, is not my choice, and that to compel me to stay here under these conditions is a violation of my rights.

I have publicly disclosed this address because I allege that statutory

agencies legally mandated to protect me refused to act when I advised them I was being targeted by vigilante-style violence. I assert that this disclosure was both a warning and a plea for intervention.

8. Able Care, death threats, and failure to report

I detail the following incidents involving **Able Care Disability Services**:

- On or around **[date]**, I wrote to **[recipients]**, advising that my life constituted a “live murder case” and that I feared for my safety. I received no substantive response.
- - I requested to be moved to another location. **Brett** of Able Care ignored this request. I was informed by **Rachael**, CEO of Able Care, that relocation would take “weeks”. Within days, a threat to kill was made against me, confirming, in my view, that every recipient of my prior warning now shares liability for failing to act.
- - I allege that Able Care consciously placed my life at risk and that it neglected to report the death threat to the NDIS Quality and Safeguards Commission, thereby failing in its statutory duty to report NDIS reportable incidents, including threats of serious harm, within 24

hours.

On **[date]**, **Tory Kilbourn** explicitly threatened to kill me. I reported this to police, but no incident number was initially provided. After repeated contact, police reluctantly issued an incident number. A court date has since been confirmed for threat-to-kill charges and an AVO.

I have documented that a thug entered my yard after the threat was made. I texted **Danny** and all Able Care staff, stating that I was scared for my life. There was no response. I then called police, who again hesitated before assigning an incident number.

I demand a lawyer to defend me in these proceedings and to represent my broader interests in relation to the systemic abuse alleged herein.

#9. Federal Court findings and corrupt conduct

I incorporate into this statement the Federal Court confirmation of three points of corruption concerning my case, including:

- Findings that I was employed by the Department of Social Services (DSS) and that my employment was terminated under circumstances I allege were retaliatory and unlawful.
- - Determinations highlighting three discrete points of systemic corruption within the disability and welfare-support framework, which I submit are directly relevant to my persecution.

I assert that I am an unprotected whistleblower, having exposed elements of this corruption publicly. I further state that I have been recorded as a missing person five times across three states, which I attribute to police and NDIS-related corruption designed to remove me from public view.

10. Houd Meraby, criminal network, and alleged assassination attempt

I allege that Bill Shorten, acting through or in concert with others, sought to “erase” me by introducing **Houd Meraby**, purportedly as an NDIS-related actor, into my case. I assert that Houd Meraby was not a registered NDIS provider but was instead a criminal operative embedded within a known Lebanese criminal network that has infiltrated the NDIS ecosystem.

I state that an attempted assassination occurred in Port Macquarie, which I claim was confirmed by **Ben**, my former NDIS provider. I allege that Ben has since been compelled to sign a Non-Disclosure Agreement to prevent him from speaking about this event.

I further allege that the same government structures that ordered my assassination – and that allegedly paid Houd Meraby ten million dollars in Bitcoin – were then obliged to halt the state-sanctioned targeting of a gay, disabled, unprotected whistleblower. I assert this was not out of concern for my welfare, but because I had published the evidence online, thereby ensuring that all involved would have “blood on their hands” if my death went unexplained.

11. Sukhi Tear and complicity of state actors

I repeat that **Sukhi Tear**, my support coordinator based in Perth, has overseen my being recorded as a missing person on numerous occasions and was complicit in the Port Macquarie assassination attempt. I allege she refuses to provide a legal cease-and-desist number to remove her from my care, despite having been appointed by the same minister whom I allege exiled me, targeted me, weaponised my mental health, and ordered my assassination.

I assert that Sukhi Tear has been paid hundreds of thousands of dollars to feign care while refusing to appoint any meaningful assistance, including

advocacy, legal, or financial support. I consider her conduct to be that of a complicit state actor.

12. Gang-stalking, electronic harassment, and price on my head

I state that I am a targeted individual and that I am gang-stalked. I have been subjected to electronic harassment and surveillance, including by Tony Riddle/Ridley, whom I allege has tracked me across three states.

I assert that there is a price on my head, and that this has been in place for an extended period. I believe the price and the targeting are part of a broader state-sponsored conspiracy to impoverish, erase, and assassinate me.

13. Institutional complicity and demand for urgent protection

I formally state that all agencies legally obligated to protect me – including NSW Police, the NDIS Quality and Safeguards Commission, Able Care Disability Services, the NSW Trustee and Public Guardian, and relevant federal departments – have failed to act despite repeated warnings. I assert that every day I am left unprotected is another day this criminal enterprise operates in plain view.

I will expose this conspiracy at the upcoming court date in which **Tory Kilbourn** has threatened to kill me. I intend to present documentary evidence, including blockchain-timestamped records via OpenTimestamps, to demonstrate the extent of institutional complicity in attempted murder and conspiracy to murder.

#14. Formal demands

In light of the foregoing, I formally demand:

1. **Urgent, immediate protection from today's date**, including:

2. - A safe relocation to a location of my choosing, or at minimum, to a secure, monitored environment.
3. - 24/7 security oversight by an independent agency not currently implicated in my alleged targeting.
4. - Independent monitoring of all communications, internet, and surveillance activity related to my person.

2. ****Legal representation****:

- A Special Legal Counsel appointed to defend me in all current and future proceedings, including the threat-to-kill charges and AVO matter involving Tory Kilbourn.
- - Separate legal representation to pursue:
- - My inheritance claims following the death of my father.
- - A civil suit for damages arising from alleged unlawful exile, entrapment, and discrimination.
- - A complaint for corruption and abuse of process against Bill Shorten, police, NDIS-related entities, and others.

3. ****Independent review****:

- A judicial-led or royal-commission-style inquiry into the three points of corruption identified in the Federal Court, the Port Macquarie assassination attempt, and the broader pattern of NDIS, police, and political misconduct.
- - Preservation of all digital evidence, including website traffic, timestamps, and blockchain records, for the purposes of that inquiry.

4. **Formal acknowledgment**:

- An acknowledgement from all named agencies that I have repeatedly warned them of threats to my life and that their failure to act may constitute dereliction of statutory duty.
- - A public statement of intent to protect me from further harm, including from any price on my head and any further electronic harassment or stalking.

I reserve the right to publish this letter and all supporting evidence widely if these demands are not met in a timely and meaningful manner.
