My heartfelt congratulations! (I voted for you!)

(This email was mostly written before the election)

I'm not sure how to proceed regarding the below?

Currently:

- I have a mental illness
- A brain memory issue
- I have cancer
- I am squatting
- A vagrant
- Evicted awaiting police
- Not enough food or
- human value or dignity

I am banned it seems from reporting anything to the local state or federal police

I cannot access litigation because of being maliciously slandered internally by Mr Ball of Ball and Partners,

I did not find this out until the years long detriment of delay deny defer aided and abetted my suicide in a public hospital - Weribee Mercy - which was deemed 'fatal' as I was found with no observable pulse and unresponsive by accident and that chance happening avoided my certain death.

I am now a failed whistleblower at IBAC and ASIC and APRA and the Commonwealth ombudsman.

Further, the millions and millions of dollars in detriment that in hindsight was set me up to fail again and again -

I have evidence of at many Government agencies including AHRD, Comcare, AFCA, ASOC, APRA, The National Portrait Gallery, PLR/ELR, IP rights, fair work commission, fair work ombudsman, MP Greg Hunt silencing evidence before a court, and The telecommunications industry ombudsman and the Small Business and Family Ombudsman, and The NDIS/A with Linda Reynolds and many other MP's including Dan Andrews, Adam Bandt, Tanya Plibersek, and the attorney general herself (MC)

I pointed out the systemic corruption at work safe - and Comcare - and AAT - in that the movement consciously and maliciously attacks me via proxy because I am catastrophically character assassinated and scapegoated from a legitimate medical malpractice complaint in 20-07.

I detailed this to the attorney general and like you she replied through a proxy - of a nameless person or individual.

I specifically asked not to be forwarded to a helpline and that it was easily predicted that I would lose a TPD case at the AAT which is marching on ahead.

It is still pending.

The Government (or someone), have designed this in mind for me to suffer and it killed me now its covered up

This is despite me having no home nor enough to eat, no dignity or human value and the movement to oppress me and...well...kill me by aiding and abetting my suffering you all hope will lead to me killing myself.

I also, against the charter of human rights for people with a disability, ratified by the Government in 2008 that any public official or indeed leader of a political party senator orparliamentarian act outside of that charter which states for your reference:

- Equality before the law
- Access to the law and litigation
- A home
- Medicine and food
- Dignity
- Not to be exploited
- Not to be oppressed or discriminated against
- Not to be arbitrarily denied life and liberty
- Not to have their property or prosperity withheld

(Let alone a malicious movement to render me a pauper in order to aid and abet my death via post vagrancy.

This movement is utterly conscious malicious and intentional, and further is systemic across all sectors of the Government, including The Attorney general and everything in her portfolio and additionally The OPMC.

Further, The Government is suing me, and also in my AAT case which is going to a hearing where I will predictably lose over a million dollars for my now TPD claim - because the Government having already conspired to manslaughter and arbitrarily smashed my heart and soul to smithereens. Leading me to a death from which I survived then went ahead and condoned the 'murder/manslaughter' with Ben Calder at The Ombudsman.

If that were not enough - now the government which I will offer an atonement in detriment for its liability - has a 25 year experienced lawyer for Comcare - representing the Government in an entirely illegal inequitable and uneven fight that was pointed out to the attorney general.

She, despite me asking her not to, replied via proxy and referred me to SANE helpline. My human rights awarded autobiography was in fact SANE's 'Book of the year' and I had already spoken to the then CEO Jack Heath of my issues, and he too, like the rest, covered up the legitimate evidence for which I was framed as an extortionist and that makes sense they would go to such lengths, not only because Dr's are wealthy people of privilege and power, especially with a top notch lawyer who advises Government policy, but that he sits on the legal bar.

The final bit to that story is that I did not want detriment to come to the GP but it has - he lost his job which I begged to avoid, and further his ABN was canceled in 2012 and as a former sole trader there may have been an undignified or reason not to air that.

In addition Kate Watson is a well known celebrity lawyer complete in her prosperity and privilege as opposed to myself who is mentally ill apparently and has acquired brain injury and I don't have enough food or medicine or indeed a home with which to simply exist in because I squat.

Further, VCAT are going to utilise the law to enable Mr Hung Ho, (my landlord), to forcibly move me on - but to where?

I have already been on the housing register for many years, and I have applied to DHHS in Footscray for emergency accommodation and they have responded saying they do not provide accommodation.

Likewise it is clearly evident that after my successful suicide when I was left bereft of money a job a car rejected my income assist failed and scammed at work cover and the methodology of delay deny defer utilised at Comcare, that it has not been months and months before the AAT.

The Government is now suing me for recording conversations - but as you may or may not accept it is the last chance I have to demonstrate the perverse and vile victimisation of my person, my character, my reputation, my memory, the feeling in my feet, the millions and millions of dollars in financial detriment and also the malnutrition that I suffer having lost weight.

Additionally, I was on a DSP before - yet whilst I was on sick leave and I had just only survived a 'fatal' suicide - the Government decided they would punish me by putting me on Jobseeker then cancelling it.

I found this an abhorrent way to read a human rights awarded champion who has actually spoken from Dubbo to Montreal, Parliament House and keynote speeches at international conferences in Melbourne and Canberra and Sydney and all the way out to Dubbo and internationally appearing as an artist and advocate and having a short documentary made about me for The Dax collection which views trauma through art and aims to educate young people on the preventing of suffering.

have never seen a lawyer, and never been assessed for the acquired brain injury affecting my memory from the loss of blood and toxins to the hippocampus which I know has had a marked detriment on my person and functioning.

I need immediate intervention in detriment to avoid vagrancy and get food and medicine.

I don't want the Govt to have to admit liability - just an acknowledgement of my suffering and that the systemic abuse literally killed me, that does not admit fault.

Then a simple monthly bursary for my lifetime so I can live in peace with my dog and avoid death threats

Because I am facing police in 10 days with a VCAT ruling to move me on who will force remove me to vagrancy

DHHS has already rejected me

The Government put me on Jobseeker after my suicide attempt, then, I had to fight for a pension I was already on.

I have proven my worth and worked so so hard

The Department has advised the OAIC that:

- The Department considers this request to be complex and voluminous.
- There are approximately 1187 Outlook items that are being reviewed by the Department for relevance.
- The Department is attempting to identify the documents that potentially contain your personal information. However, the absence of any Departmental reference, identifier or date range in the request has introduced a level of complexity in identifying material containing your personal information and not that of a third party.

The Department has requested an **extension to 8 April 2022**. I will take any comments you may have to make into account when deciding the application.

I refer to your email of 7 February 2022 in which you made a request to the Department of the Prime Minister and Cabinet (the **Department**) under the *Freedom of Information Act 1982* (the **FOI Act**) in the following terms:

I request all information government agencies hold on me please

Please note we do not hold records of government agencies other than the Department. We have therefore treated your request as asking for information about you that is contained in documents held by the Department.

Authorised decision-maker

Decision

I have decided to refuse your request under section 24A(1)(b) of the FOI Act, on the basis that the Department has taken all reasonable steps to locate the documents you have requested, and those documents cannot be found or do not exist.
