History will not remember this as a question. It will remember it as proof — that when asked to face the reality of your son's extermination, you chose instead to offer him back to the executioners.

Identity of Deponent

I, Dr. Richard William McLean (also known as Barran Dodger), of no fixed address, in political exile within the Commonwealth of Australia, declare under oath that I am:

- A recognised whistleblower entitled to protection under the Public Interest Disclosure Act 2013 (Cth),
- An asylum seeker and UN-registered complainant (Ref: UR/UST/23/AUS/17),
- A person with documented disability, including serious health conditions,
- The survivor of an attempted assassination, political persecution, and ongoing genocide by attrition,
- A subject of sustained surveillance, defamation, and psychological torture, including Voice-to-Skull (V2K) operations.

Material Facts of Disclosure

On [insert date], I made direct contact with April McLean, my mother, in which I disclosed the following facts:

- My ongoing status as an unprotected asylum seeker and whistleblower in exile;
- My homelessness, lack of identification, lack of food, and absence of any safe place to reside;
- The total denial of police protection, political acknowledgment, and legal representation;
- My history of abuse, surveillance, torture, gang-stalking, defamation, and false criminal accusations;
- My survival of a confirmed assassination attempt;

- The systematic deprivation of my rights, income, medicine, personal relationships, and will to live.

Response Given

In response to this comprehensive disclosure, April McLean replied:

“Have you accepted help from NDIS or Guardianship?”

This was not a neutral inquiry.

Both NDIS providers and Guardianship authorities are named in my sworn affidavits, blockchain-verified records, and public testimony as direct instruments of entrapment, financial sabotage, and deprivation — mechanisms used by my perpetrators to advance the campaign of psychological genocide against me.

Inference of Alignment and Benefit

The reply constitutes prima facie evidence of alignment with my persecutors for the following reasons:

4. My family's continued silence on my allegations — including the attempted assassination — shields the perpetrators from scrutiny while safeguarding their own access to networks, privileges, and material benefits linked to those institutions.

Legal and Ethical Characterisation

I assert that this conduct constitutes:

- Moral betrayal of a protected whistleblower and immediate family member;

- Accessory behaviour to the crimes alleged, including persecution, torture, and genocide by attrition;
- Conflict of interest, wherein the avoidance of public defense of my position preserves familial access to financial and social benefit;
- Breach of familial duty of care, as understood within both moral and customary law, to preserve the life, dignity, and safety of one's kin.

Relief Sought

I submit this record to counsel for the purposes of:

- Inclusion in my public evidentiary archive as part of the documented pattern of institutional and familial complicity;
- Consideration in any civil or criminal proceedings against individuals and entities complicit in my targeting;

- Presentation to the United Nations, human rights bodies, and relevant oversight agencies as evidence of domestic enablers of international human rights violations.

I declare that the facts contained in this affidavit are true to the best of my knowledge, recollection, and belief, and that I make this declaration with the knowledge that it may be used in any judicial, quasi-judicial, or international tribunal proceedings.
