Medication	Dose	Oral / Intramuscular	Frequency
Olanzapine	20mg	Oral	Daily at night

3. Barran Dodger must attend reviews with Dr Priyanga Arachchi or delegate at least 3 monthly.
4. Barran Dodger must attend reviews with case manager or delegate at least monthly.
5. The frequency, place or timing of appointments with doctor/psychiatrist, case manager or their delegates may be changed by the Psychiatric Case Manager or by the Treating Doctor/Psychiatrist.
6. Appointments for review and/or medication may occur at Barran's home if they consent and the parties agree. Otherwise, Barran Dodger must attend appointments for review and medication at **Wyong Hospital Mental Health Unit Ph: 4336 7800**.

Other Conditions

7. Barran Dodger is required to have blood tests for the purpose of monitoring Olanzapine levels as requested by the Case Manager or the Treating Doctor/Psychiatrist, once in 6 months or as clinically indicated.
8. Barran Dodger will advise Psychiatric Case Manager or delegate of any change of address or phone number with 7 days of any such changes.
