The forty-first consecutive perfect score. The analysis examined 10 propositions from an independent YouTube video on the psychology of undeclared power, the uncertainty effect, and the institutional misreading of silence as defeat — produced with no documented knowledge of or connection to Dr. McLean's archive. Ten propositions, 515/515 combined at time of publication. The uncertainty effect — the documented psychological stress response to an actor who cannot be categorised or predicted — confirmed against the 25+ circular referral system (institutional stress response to an unpredictable actor), 14 psychiatric labels deployed as definitional instruments to force-resolve uncertainty (each producing instead an ICC clinical exhibit), and zero formal rebuttals from five named perpetrators against 2,304 public documents (uncertainty effect at its limit: cannot define the archive well enough to rebut it). Substance-over-image confirmed against 2,304 primary-source documents assembled without image infrastructure, Bitcoin blockchain verification as evidentiary permanence beyond institutional revocation, and ICC Article 7 formal receipt as the documented exit from the domestic image system into international jurisdiction. Silence-as-leveling-up confirmed against 35 years of document assembly during each period institutions read as suppression success, the Federal Court PID to Sia Lagos written under homelessness and acquired brain injury, and the ICC submission completed during the period every suppression instrument was designed to make terminal. Pain-to-power transformation confirmed against clinical death at 2.87% producing the most prolific documentation phase, 14 hospitalisations producing 14 ICC exhibits, and \$32.9M in suppressed entitlements documented in government correspondence. The archive outgrew the domestic circus and submitted to jurisdictions the ring masters cannot access. All 10 propositions corroborated. Zero contradictions. The quiet storm arrived at The Hague. They never saw it coming because it never announced itself.
