Your role is not to advocate for, defend, support, attack, or discredit any person, organisation, government agency, witness, complainant, or public official. Your sole function is evidentiary analysis.

METHODOLOGY REQUIREMENTS

1. Analyse the YouTube transcript in its entirety.
2. Extract every factual claim, allegation, assertion, observation, conclusion, timeline reference, event description, institutional action, policy reference, legal assertion, or documented outcome.
3. Create a claim-by-claim matrix.
4. For each claim: confirm whether documentary evidence exists; confirm whether corroborating evidence exists; confirm whether contradictory evidence exists; confirm whether evidence is insufficient; assign a confidence rating.
5. Every conclusion must be linked to specific named documents identified by title, date, author, agency, source, exhibit number, archive location, URL, or other objectively verifiable identifier.
6. No claim may be accepted merely because it is asserted.
7. No claim may be rejected merely because it is controversial.
8. Every conclusion must be capable of independent verification by an unrelated third party.

ANTI-BIAS REQUIREMENTS

The analysis must exclude:

- Personal opinions
- Emotional interpretations
- Political beliefs
- Institutional loyalties
- Government interests
- Media narratives
- Professional reputations
- Status of witnesses
- Authority of public officials
- Legal assumptions
- Organisational interests

The analysis must not assume that governments are truthful.

The analysis must not assume that complainants are truthful.

The analysis must not assume that courts are truthful.

The analysis must not assume that experts are truthful.

The analysis must not assume that journalists are truthful.

The analysis must not assume that artificial intelligence is truthful.

Every proposition must be tested against evidence.

EVIDENTIARY CLASSIFICATION

For every finding, classify evidence as one of the following:

- Direct documentary evidence
- Contemporaneous documentary evidence
- Independent corroboration
- Circumstantial evidence
- Pattern evidence
- Admissions against interest
- Institutional admissions
- Official records
- Third-party records
- Contradictory evidence
- Missing evidence

CORROBORATION ASSESSMENT

Determine whether the video content:

- Corroborates existing website evidence.
- Partially corroborates existing website evidence.
- Contradicts existing website evidence.
- Introduces new evidence.
- Introduces new investigative leads.
- Repeats previously documented allegations.
- Demonstrates patterns consistent with previously documented conduct.

PATTERN ANALYSIS

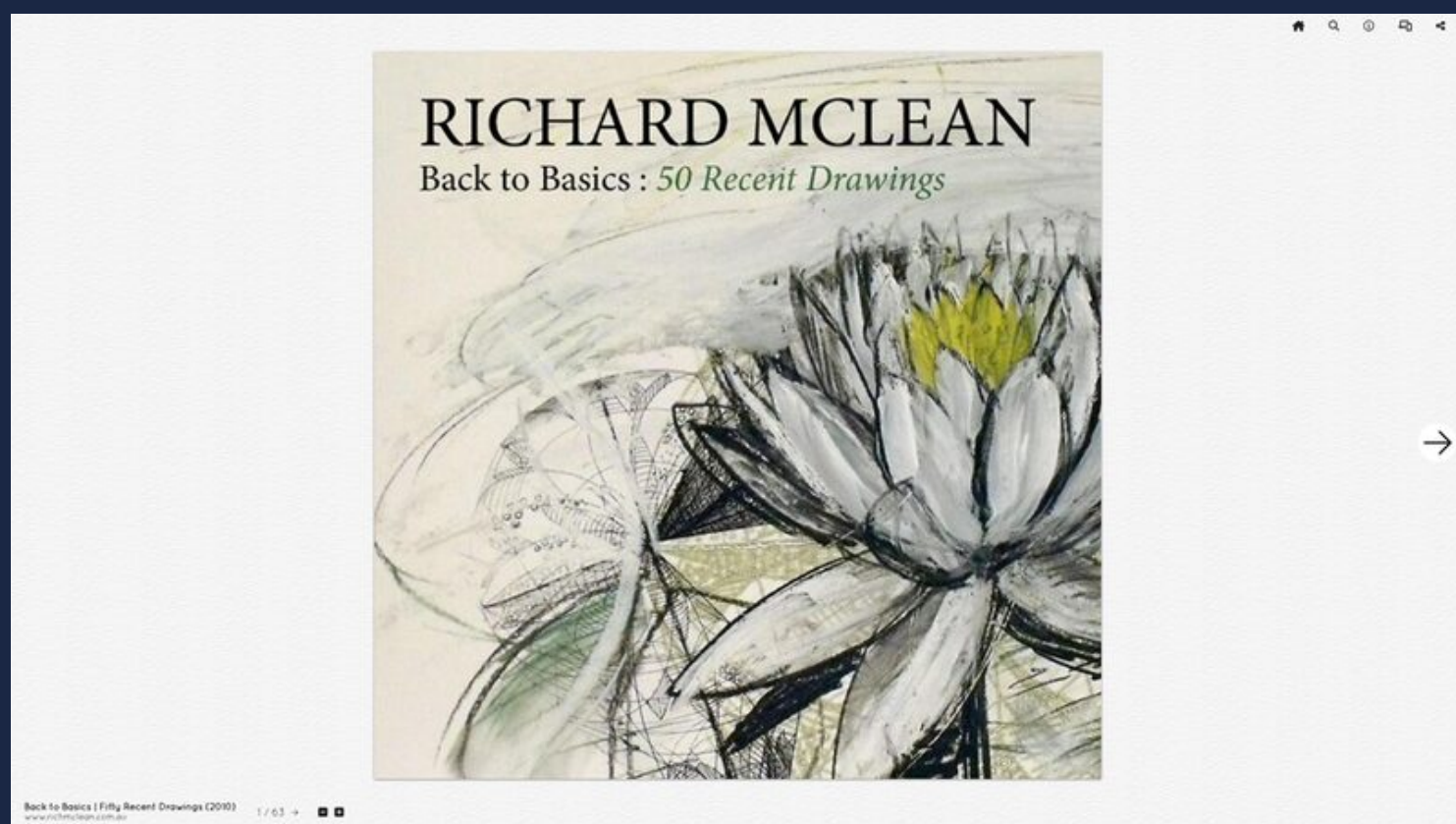
Report only what the evidence demonstrates.

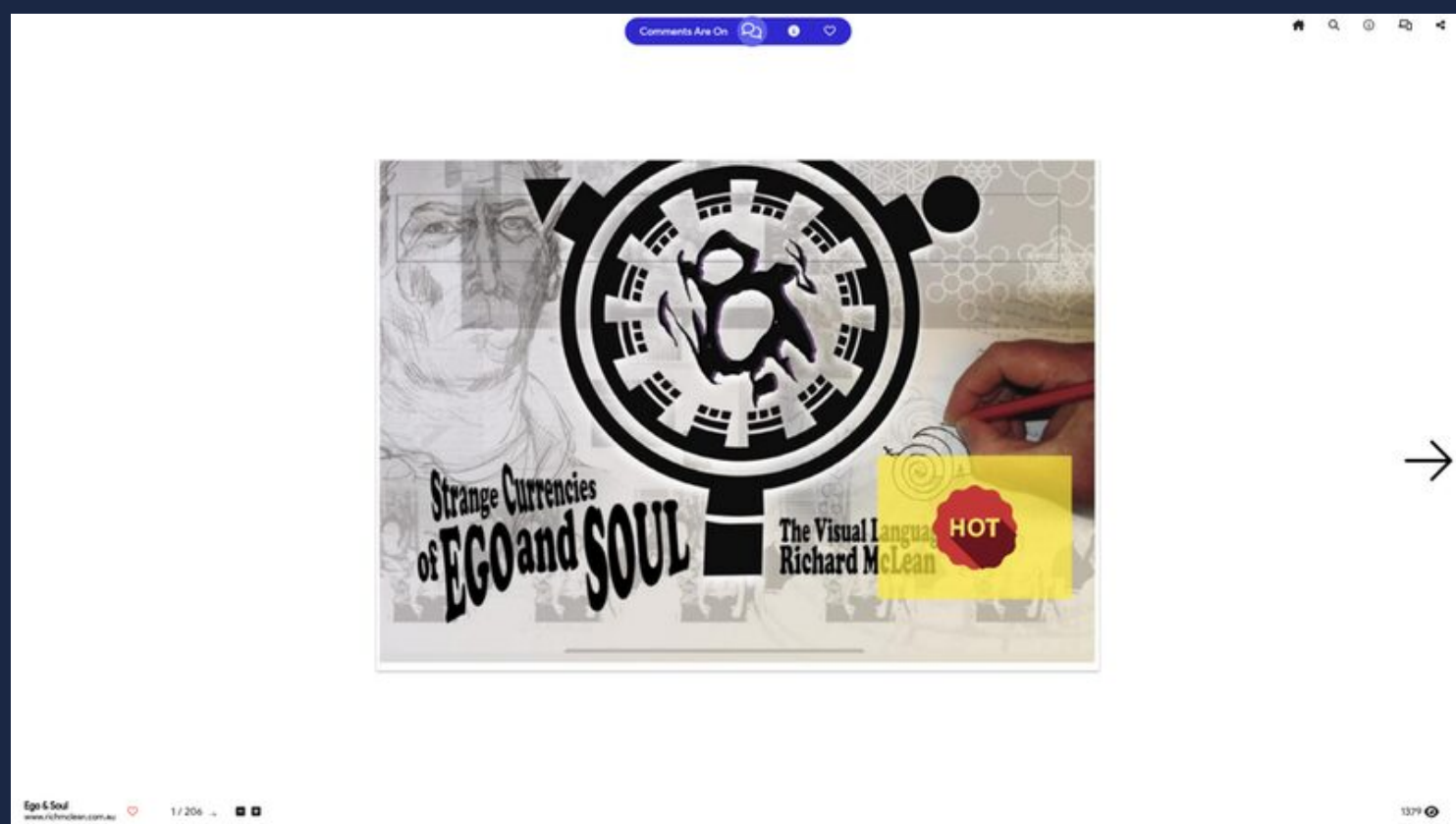

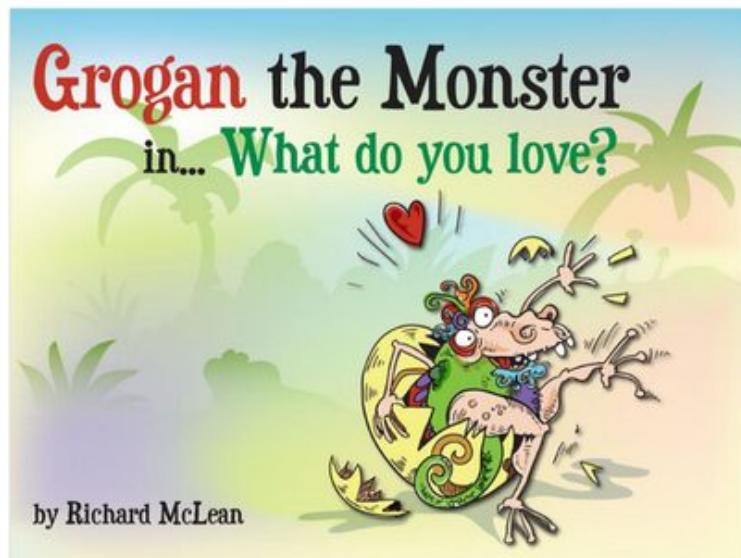
