GROUND'S FOR FORMAL REMOVAL

This document records the formal removal of Sukhi Tear as NDIS Support Coordinator for Dr. Richard William McLean. The grounds are documented in primary-source form across the 2,304-exhibit archive. The removal is a primary-source act that forms part of the evidentiary record.

- **Denial of Mandatory Supports Across Multiple Categories**

Psychiatric care, psychological support, drug and alcohol counselling, financial counselling, and legal representation — all documented as denied across the period of Sukhi Tear's case management. These are not contested. They are documented absences in the formal NDIS support record.

- **Five Missing Person Registrations — Documented Response Pattern**

Five missing person registrations across three states while under Sukhi Tear's case management. The formal response pattern to each registration is part of the evidentiary record.

- **Denial of Knowledge of Assassination Attempt**

The assassination attempt is documented. The evidence of its communication through institutional channels is documented. Sukhi Tear's denial of knowledge is documented. The contradiction between documented communication and denied knowledge is part of the evidentiary record.

- **NDIS Mandatory Reporting Obligations — Breach**

Under the NDIS Act and NDIS Practice Standards, certain events require mandatory reporting. The documentary record of events within the case management period that were not reported — and the documentation of Sukhi Tear's position as responsible case coordinator — constitutes a documented breach record.

- **Co-ordination with Parties Later Named in Death Threat Documentation**

The documentary record identifies communication patterns and institutional positioning involving parties later named in the death threat documentation. The forensic significance of these patterns is documented across multiple exhibits.

- **The Formal Removal as Primary-Source Document**

The formal removal of Sukhi Tear from the care coordination role — documented, dated, and blockchain-sealed — is itself an evidentiary act. It constitutes Dr. McLean's documented response to the documented conduct of a named party in the institutional persecution record.
