According to the website you directed me too;

Current and former public officials are eligible to make public interest disclosures (PID).

This includes:

- public servants and parliamentary service officers
- **service providers under a Commonwealth contract**
- Australian Defence Force members
- Australian Federal Police appointees
- statutory office holders
- staff of Commonwealth companies

- members of the intelligence community
- individuals taken to be public officials.

I have a contract with the NDIA

I note I have been rejected from making a PID from AHPRA by

I sent him my contract and also my Government ID (which is still current).

He has not responded.

Under information I can expose says:

You can disclose information that you believe on reasonable grounds tends to show wrongdoing:

- within an Australian Government agency
- by a public official, or
- by a Commonwealth contracted service provider.

You may disclose the following types of suspected wrongdoing:

- contravention of a law
- corruption
- conduct that perverts the course of justice
- wastage of public funds
- conduct that is an abuse of public trust
- conduct that unreasonably endangers health and safety or endangers the environment
 - misconduct relating to scientific research, analysis or advice
 - maladministration, including conduct that is unjust, oppressive or negligent
 - conduct that is an abuse of a public official's

position

- conduct that, if proved, would result in disciplinary action against a public official.

You cannot disclose:

- the proper activities of intelligence agencies
- disagreements that relate only to government policy (and related expenditure)
- the actions of parliamentarians.

Not all matters will fall under the PID Act. It may be more appropriate to deal with a disclosure under another process. Also, matters that have already been subject to a previous investigation process may not be further investigated under the *PID Act*.

The ombudsman has accepted my disclosure

It says:

It is best to make a disclosure with the relevant Australian Government agency.

If you believe that it is not appropriate for an agency to handle a disclosure, we can receive the PID.

Where we do accept a PID, we will work with the discloser and the agency to give that matter back to the agency for investigation.

Generally, we will only investigate a disclosure under the PID Act if:

- we assess the relevant Australian Government agency cannot handle the matter, or

- there is a conflict of interest, confidentiality or reprisal issue the agency cannot manage.

If you are not satisfied with the outcome of an agency's handling of a PID, we can receive your complaint.

Where we investigate a complaint, we will look at whether an agency's handling of a PID and their decisions were:

- lawful
- reasonable
- fair in all the circumstances.

We will generally not re-investigate the matters disclosed in the PID.

In regards to the IGIS

The Inspector-General of Intelligence and Security manages PIDs in relation to:

- Australian Security Intelligence Organisation (ASIO)
- Australian Secret Intelligence Service (ASIS)
- Australian Signals Directorate (ASD)
- Australian Geospatial-Intelligence Organisation (AGO)
- Defence Intelligence Organisation (DIO)
- Office of National Assessments (ONA)

Under this arrangement, sensitive or intelligence information is only shared with individuals that have appropriate security clearances.

This protects Australia's security, defence, foreign relations and other national interests.

They have said

Upon receipt of my complaint:

Once you make a PID:

- An authorised officer must assess it and decide whether it is an internal PID. If so, the authorised officer will decide the process for handling the PID.
- If it is decided the matter is not an internal PID, then the discloser must be advised of the reasons.
- Once allocated for handling, the principal officer (or delegate) will decide whether to investigate the PID.
- If not investigated, the discloser must be advised of the reasons.
- If investigated, the investigation must be finalised within 90 days (or a longer period if permitted by the Ombudsman or the Inspector-General of Intelligence and Security).
- Upon completion, the discloser must be provided with a report.
- Early in the process, the agency should assess the risks of reprisal in relation to a PID.

Further

If your disclosure meets PID criteria, you will receive

immunity from:

- civil
- criminal, or
-

administrative liability (such as an action for defamation).

It is a criminal offence under the PID Act for anyone handling the PID to disclose your identity as the discloser without your consent (subject to some exceptions).

You are also protected from reprisals or threatened reprisals including:

- injury
- dismissal, or
-

discrimination between you and other employees, even if you are only suspected to have made a PID.

You can take legal action if you suffer detriment as a result of making a disclosure.

These protections and immunities continue to apply after a PID investigation is finalised. The PID Act will not protect you:

- if you knowingly disclose false or misleading information, or
- from the consequences of your own wrongdoing which may be investigated as a result of the PID.

My rights and responsibilities include:

As a public official making a disclosure, you have a

number of rights and responsibilities.

Your rights:

- To make a disclosure about suspected wrongdoing and have it assessed under the PID Act.
- Have your disclosure handled confidentially and efficiently.
- Have immunities from civil, criminal and administrative liability in relation to making a PID.
- Protections from detriment or reprisal caused to you because you made a disclosure or are suspected of having made a disclosure.

Your responsibilities:

- be clear and accurate in the disclosure
- provide any relevant supporting material—do not report false or misleading information
- be discreet about your PID and maintain confidentiality throughout the PID process
- provide reasonable help as required during the investigation
- seek advice about the process and your rights and responsibilities
- alert the authorised officer or investigation officer to any problems that you may be facing. This includes possible reprisal action in relation to your disclosure
- seek appropriate support if you need it.

Further

In making the report, please make sure you provide us with:

1. Information about the wrongdoing, or suspected

wrongdoing, that you wish to disclose.

2. Information about why you believe we should investigate the matters raised, instead of the relevant Australian Government agency.

3. Contact information—where you wish to remain anonymous, consider providing a pseudonym email address or personal phone number to allow us to communicate with you throughout the process.

I have been ostracised and blacklisted from reporting crime to police.

I did so for the 20th time only last week, and it was not followed up,.

I called the station manager at Footscray and he hung up on me. I called crime 000 and crime stoppers who said to call someone else begging for traction - here is and officer and while I am on the phone they distract me with sending local police to the door - they say they will inform the station manager - they did but I am framed - so I called him later on and he hung up on me.

I have attempted to make a whistleblower statement to APRA which has been rejected on the grounds I am not a provider under a Government contract or an employee = here attached is the evidence they cannot deny that.

Here, I provide evidence to Peter Dunstan, who is complete in the cover up of my murder via systemic government oppression, yet following that a new conspiracy emerged to silence that killing / manslaughter that is acknowledged in the FOI from the hospital that stated the injury was 'fatal'.

I wish to say that I have suffered extremely noticeable memory loss - and I cannot feel my feet.

It is unclear if I need an advocate so I am CC-ing this to Dom from VMIAC to assist me in mental health advocacy

1) IBAC can you please provide a turn around time for my complaint.

2) It is clear I am eligible for whistleblower status even though Peter Dunstan tries to deny me

3) I have been banned from many agencies, and on top of suffering immensely in life and the added burden of seeing no option but to kill myself under systemic oppression... it is not sufficient that I die. The cover up now goes beyond the information commissioner and the HCC and the MHCC who were biased and even the Victorian ombudsman condoned my 'fatality' which was in fact a blameless murder because I was framed for making a complaint.

4) There is no other possible outcome that Peter Dunstan from ASIC accept my whistleblower status

5) there is an impossibility of there being nothing illegal about a

'fatal injury' under duty of care and for agencies and police and Ben Calder the ombudsman to condone this is abhorrent

I am innocent and a public figure and I intend to either gain whistleblower stats so my needs are met.

Otherwise as history shows and post my murder-suicide I will be further m,aimed in a movement that is silent and endemic.

I was once niche famous now I am infamously framed.

I wish to state that my former partner was an asio agent and I know information contradictory to ethics.

I have done a doctorate and ir means 'do no harm'

I act today with intention to blow the whistle on a matter of vilification identification prejudice stigma and desecration in the victimisation of one single person that is so endemic and systemic that it simply cannot be ignored.

In my death, they will blame readily exploitable structures in society

with things I have been branded and labelled with

I have a dire mental illness and permanent injuries from my fatal attempt in which I was reluctantly revived.

I have faith in black humour and the paced but stressful and utterly maddening response to the gaslighting and blacklisting that have seen me robbed of about 2000000

I have not got a cent

I have my sentence and a pet dog and a corrupt computer and under investigation

They will frame me kill me or kick the proverbial can down the road aiding and abetting my death in a scapegoating manner in which they consciously or unconsciously pun their neurosis and sins on to send me out into the wilderness to die

That pattern can happen in families and in societies

Historically all the peace seekers healers prophets and avant guard revolutionaries were killed

It is noted persons of officialdom and respectful positions in public service as ombudsman's have also aided and abetted My electronic and business destruction

This includes a VOCAT lawyer Brian Burton and it is noted in both a violent assault for VOCAT I was the victim of and my own child sexual abuse case where I was the victim the magistrate ruled

that I was quite “doomed to fail from the start”

All of this lifetime has perplexed me until I found I was framed by
dr Whitaker’s lawyer Mr Ball

I must end this email now as police Here

I asked you as a representative of the NDIS/NDIA to intervene in

I have urgent questions

I suffered a workplace injury

But I have also been framed and the centre of an elaborate conspiracy that is before IBAC and AAT and Police (the police are in on it)

I became ill from work because of the nature of caring for a sexual abuse victim for two years

I did his VOCAT case

But my two VOCAT cases were squashed

I was not believed and blamed and the police and the magistrate were corrupt

Income assist has refused and banned me

So has AHPRA the MHCC the HCC the office information commissioner the police federal police family court VCAT and many more

I am owed surely millions

Because I was aware of the abuse and I had overdosed due to malpractice (but I was framed), I complained of the conspiracy publicly

Many are guilty of perverting the course of justice a lot of statutory authorities and MPs

I was aware they were gaslighting and blacklisting me illegally because I was framed

I did not know this

It drive me crazy

Due to no job and bereft of finances stressed I received zero compensation and no insurance or workcover was paid

My family incarcerated me

My former partner was being protected as a murderer and used coercion to keep me a financial and in sexual slavery

He took off with a million in super

Now I cannot get a lawyer

Anywhere

I have been rendered voiceless

When they illegally incarcerated me

I had no one else to trust I tried to tell them of the movement which sounds unreal

They called me psychotic and demonised me but they knew

Having proven not one person was on my side and I was desecrated in every way

I suicides the hospital FOI says it was a "fatal injury" I was found with no pulse

I was saved got golden staph and it was an agreed illegal contraband that rejects the human rights charter

Now another conspiracy is born - my systemic collective murder was not enough

Now they treated me with malpractice I don't have a dr and I have permanent injuries and can't think or feel my feet/hands

If no action is taken I will be killed

In fact, I already have been so systemically oppressed I suffered a fatal injury in a public hospital

so rejected ostracised framed blamed victimised and vilified I have been murdered already

If that were not evidence enough of my authenticity my conscience is clear - and I am 'free', I will not be much longer, and the profound desecration by proxy continues

In fact, I have evidence I was heinously framed and scapegoated by every statutory authority agency and Government institution.

I cannot report rape or murder, or my fatal injury caused by systemic abuse in a public hospital to an ombudsman who condones the murder by a thousand stones

In this - the persecution beyond my conspiracy to manslaughter is concrete unequivocal and finite

If no one intervenes

They will kill me - and I will publish this in the event of non acknowledgement.

I cannot live in a world where I have proven that even in my death it was not good enough for me to suffer and the prolonging of my desecration framed by ASIO for my knowledge and being framed knows no mercy

I was killed and I don't want to die

How Im framed and Ive already died

This is torture

I went to the police today and they kicked me out

I was a sexual slave to a millionaire for five years who exploited me and I wasted my nest egg on him while he made 300k per year and I was on a DSP

You have to help

The vilification and victimisation of Dr Rich Mclean; the framing gaslighting and blacklisting - how systemic oppression and prejudice forced his suicide ay Werribbee Hospital.

The FOI says the attempt was 'fatal'. A new

conspiracy was born - to cover it up from the HCC to the MHCC which was biased in favour of the hospital and also Weribbee mercy hospital, the office of the information commissioner I had to battle just to get my FOI, even the Victorian Ombudsman Ben Calder condoned that 'fatal injury'.

The fatal injury was the result of a systemic oppression and a conspiracy to pervert the course of justice - because I was framed by Dr Whitakkers lawyer as an extortionist.

In addition, my former partner Steve Iasonidis that I had a five plus year relationship with and was engaged to - left me homeless whilst he left with over a million in super, shares, and other equity. He kept me a sexual slave, utilised coercion to financial control me, insisting I receive a pension of less than \$500 a week whilst he made over 200k plus per year working for ASIO, who he was caught by investing over 1.2 million in an illegal offshore tax haven - and let off jail with a fine.

he swore to ruin my life - and whether the genesis is this or already existing prejudices in society that the movement to desecrate me uses in order to keep me bereft of prosperity and I believe will try and incarcerate me or kill me - via the provable lengthening of justice in order I become a vagrant then kill myself as a high probability.

Then they can blame drugs mental illness, I am a criminal or any other exploitative thing they want.

When I was desperately trying to exonerate myself from this world after being systemically oppressed and a conspiracy to pervert the course of justice had all but destroyed me and desecrated me - I was searching for something sharp. I snapped a dirty toilet brush which did not produce an edge to sever my artery.

I ended up using the glass from my vape I accidentally had in my pocket. The

hospitals 'apology', for my death after giving back a dirty broken toilet brush in my luggage, indulges themselves in their attitude towards me and knows it can act with impunity : 'it is not hospital policy' to give back hospital property.

They were obviously desecrating me rudely and shamelessly with impunity from any litigation or the law, which I am actually rendered as officially exonerated from.

When the director of the hospital had news

the Victorian Ombudsman Ben Calder had cleared all wrongdoing - he personally emailed me and baited me with this letter that welcomed me to sue him in person and personally, knowing full well, that I have a black mark against my name, no access to justice and no chance in the world of any justice.

This is because I have been scapegoated and framed as many things including a rapist and a pedophile and a drug addict and additionally an evil extortionist by Dr Whittakers Lawyer Mr Ball of Ball and

associates.

I only found this out after I had survived suicide via systemic oppression, which was not me being ill, it was a reaction to the conspiracy to desecrate my life and aid and abet my suicide.

My suicide attempts are conspiracy to manslaughter.

Thats corruption.

Upon arrival at hospital I was desecrated of every ounce of self-Dr Kumar had seen me in 2011, it was 2021 - he knew me, my former ASIO employed criminal partner, and my life. He rejected me the medication I needed then - and they did now too which alongside of my dog being kept alone in my rental for four days (we have never been apart), the drugging and then lack of normal medication was medical malpractice and intentional negligence.

It amplified extraordinary distress caused over years of a complaint I made in which the evidence that is here was whitewashed, and never included in my official complaint.

I was framed.

It is illegal to kill yourself in a hospital when

you are there specifically to avoid that occurring.

It is a conspiracy to pervert the course of justice to cover that up.

Now, instead of acknowledging the brutal systemic oppression and lifelong vilification I received for being honest about my struggles, I am further scapegoated and heinously maimed and further desecrated.

The office of the chief psychiatrist told me 'You cant kill yourself every time you done get what you want', and that is the current status-quo narrative of my oppression that is systemic and the word on the street from my local coffee guy to my own mother, to the national health Minister MP Greg Hunt.

Prior to hospital, here is a list of organisations individuals and institutions that acted together to keep the innocuous recording I made silent and cover up the

fact that I was knowingly framed.

I emailed the media

I asked my psychologist Dr Robert MacKinnon to stick up for me

I asked Dr Cooper of Yarraville medical centre to stand by me. (He didn't but knew of the case - he then prescribed me 2 x boxes of Endone at a time - unusual for someone who had in the past overdosed on opioids - gee it was if he was trying to kill me - then when I didn't - he wrote me a letter demanding I go to drug and alcohol rehab and banning me from the clinic - forcing me into withdrawal placing me at

high risk.)

My psychiatrist dumped me accusing me of fraud, knowing I would be without medications that he championed for me having a purposeful life.

Additionally in the entirety of that time - as someone who has a public profile as an advocate and awarded in human rights - and known to suffer from mental illness, I did not have one specialist psychiatrist nor a psychologist.

I still don't.

To this day -

I have no care,

barely a GP,

I don't have medication I need, and

I have suffered permanent memory loss and

in addition I fall over a lot due to my
balance being affected and

I can't feel my feet,

I assume because I have damaged my brain

and blood vessels when I was found with no pulse and no blood -

I have been denied a lawyer

I was put on jobseeker by centrelink

Hitmen have been threatened to me

I am denied traction in my childhood sexual abuse case where I was the victim, (The geelong magistrate said I was 'doomed to fail.'

I was identified as the 'principal aggressor' in another violent affray in which I defended a man I thought would be killed

The FOI from the police refused to give up the footage of the incident that would have exonerated me

I have been denied my income assist and

banned from contacting them

I have been blackmailed that if I contact AFCA my million(s) of dollar cases will be dropped

I became bankrupt

I have squatted

A duty of care was abandoned by the hospital - which was supposed to have follow up care

I only saw a psychiatrist at salt water clinic twice - the second time - ten months or so after my manslaughter - to kick me off the system - they still refuse my medication and care

after the manslaughter / murder.

According to The surveillance act 1999, the innocuous recording I made with Dr Whitakker is allowable before a court, but AHPRA's lawyers were internally biased, and Dr Whittakers lawyer Mr Ball forbid them using it.

In fact, I was offered to submit any other form of evidence so I transcribed it - but unknowing to me Mr Ball did not allow for this to be used because it was 'invacuate.'

Hence the years long battle for an ethical justice was based on nothing and utterly in vain.

In my defence, I have been claimed by Mr ball to be extorting the GP for money.

I need some of course - but it is not my currency. Here is evidence of that:

I was gifted \$100,000 during that time - and the person said he was ill, it was a mistake, and he wanted it back - so not that I had to, but ethically I thought it was right - so - I transferred \$100,000 back to him of my own free will, (minus about \$850), I had only bought a crystal, some incense,

candles to pray, paid some bills and bought some T-shirts.

The powers that be robbed me of any litigation opportunity or legal traction and because of my many injustice issues that exploited already existing mechanisms of

prejudice, - a movement was created to keep me bereft of any prosperity whatsoever. This was because I needed money to defend myself.

It has worked.

My reputation is ruined

I am already bankrupt

I have no rights or agency to complain

I cannot go to police

I cannot get a lawyer

I have lost every friend

I have permanent injuries with memory and physical feeling and the grief of surviving to a world which still perpetuates my suffering systemically and this is well known.

Every single agency under auspice of The Australian Government rejects my complaints about lesser agencies.

Every investigation that has occurred investigating the investigators has returned an innocuous result.

My whistleblower status was rejected.

This is evidence in itself of a conspiracy to avert the course of justice and has

happened all along without my knowledge
- set me up to fail.

.This is because:

I was framed as an extortionist from a complaint I made about a GP, that I did not know about until later.

I was engaged to my former partner Steve

Iasonidis who was an employee of ASIO, who is above Government.

He is protected by an unseen force for my knowledge of him being present at a murder, and drug trafficking, selling a 1.2 million dollar home he then invested in an offshore tax haven in he was caught by the feds.

He was let off with a fine. The home was bought with the proceeds of drug dealing. All you need to do is check his tax records. This will show the papers trail of the illegal

investment.

He also kept me in sexual slavery and under financial coercion for five years escaping with over a million dollars in super with no amicable separation - and threatened a hit man on be and blackmailed me that I would be jailed if I went after a separation because he insisted I stay on a disability pension.

I wrote a book on my experience with 'mental illness' in 2002, whilst I was employed at 'The Age' as an artist. al was

a public advocate locally state wide internationally and nationally, in person at organisations and own radio and television, and a documentary was made on my life and work. I was fired or managed out shortly after my autobiography was released.

I have been courageous and kind and this was done mostly via altruism - this is my character, as is the fact I was gifted \$100000 via an individual who then said he was unwell and voices told him to give it to

me - so faithful to my ethics I transferred all of it back. It is counter to the claim that I planned an extortion for money from a GP and the evidence will show I protected the GP whilst the statutory agencies aided and abetted by. my suicide watching me unravel, unaware I was blacklisted and set up.

I am exploited by already existing structures of prejudice in society of:

Being gay,

Having taking drugs, and

The stigma of and prejudice of the labels of
'mental illness'

I have travelled the world and was running
a business for years and attaining a BFA a
Masters Degree and a Doctorate - the PhD
of which requires an astonishing amount of
literacy communication and is examined for
evidence of critical thought and
contribution to knowledge and evaluated

by a panel of associate professors.

I have evidence I have been framed as a rapist and extortionist and a pedophile and I am convinced a beyond national dossier exists about my identity and the threat to the Government I pose, because the whole system is so far gone now in victimising me and robbing me of justice and prosperity and cutting down the tall poppy that I was nicely famous now infamous.

Currently, 23/10/2021

My computer is hacked,

My Intellectual property and data were
maliciously destroyed by an untouchable
company,

I am rejected whistleblower status,

I have been rejected work cover and
Income assist after my psychological injury
that is a sane response to a crook
magistrate,

I am followed and have evidence I am under 'investigation',

I cannot report any of this to any agency as they all exist under the veneer of the movement to kill me.

I am exhumed from any agency to report crime to police

I am banned from contacting many statutory authorities, including MHCC AHPRA or NHPOPC my server has been blocked from the Federal Police I cannot report crime, rejected by ASIC, been bankrupt, I have been

murdered but survived by an invisible
untouchable systemic and malicious
government oppression,

I have been blackmailed by AFCA -
responsible for delaying over a million
dollars worth of determinations - which has
seen me become bankrupt, in turn
exonerating me from a career I loved

In hindsight a litigation firm delayed a
response long enough there would be no
appeal for my child sexual abuse case and
this is corruption.

After my murder, it gave rise to attacking the mechanisms through which I would acquire justice - Micron21 by web hosting company - intentionally desecrated and deleted my digital identity and over twenty years of emails that was evidence before a court. It was covered up by the telecommunications ombudsman and the small business and family ombudsman and business.vic.gov.au

After I was murdered via systemic oppression via powerful agencies - I was rejected from the hospital having no money no car my career ruined and swquatting with no access to healthcare. I saw a psychiatrist twice - the first to connect after seven months of them denying me life saving medication - and the second to officially exonerate me from the system.

I have sustained permanent noticeable memory loss and I cannot feel my feet.

\I have no psychiatrist and no psychologist,

barely a GP who will acknowledge bowel bleeding, nor my memory loss not the nerve damage to my feet.

No one wants to cross the floor or get their hands dirty with my issues.

The following are criminal and they have happened to me:

1. A conspiracy to pervert the course of justice is a crime

2. To sustain a fatal injury in a public hospital due to a systemic oppression of silencing evidence and framing an individual then covering it up via proxy of police statutory authorities and an ombudsman is systemic corruption and reverting the course of justice

3. To blacklist someone from a public agency is a crime

4. It is illegal to sustain a fatal injury at a hospital then have that conspiracy to murder covered up

5. It is corruption I cannot report rape fraud tax evasion or drug trafficking to the police or federal police

6. It is illegal to vilify someone publicly on television or in the newspapers

7. Taking advantage by deception is a crime

8. If I have information on someone present at a murder, tax evasion drug

trafficking and financial coercion and sexual slavery it is criminal the police continue to not act

9. To threaten to kill is a crime, and conspiracy and oppression that leads to a 'fatal' suicide is a crime

10. Medical malpractice is a crime

11. Consciously rejecting a person with a disability from a public service is a crime

12. Knowingly rejecting a suicidal patient and leaving them squatting with no food job or money is a crime

13. 'Kicking the can down the road' in order to lengthen the amount of suffering through systemic oppression through government is a conspiracy to pervert the course of justice

14. Denying someone medical care and medication is a crime

15. Corruption of police and federal police is a crime

16. Intentionally and consciously systemically imposing suffering on a person with a disability who has suffered so much already is illegal and abhorrent

17. Denying a valued member of society with sentience who has suffered this reality a PID or whistleblower protection is a crime

18. A lawyer representing another party who makes an accusation to a federal body in an investigation which is not denied that leads to the vulnerable persons framing - is inequitable and a crime

19. To intentionally maim an individual's business is a crime as is the intentional desecration of their intellectual property and digital identity

20. To have that covered up by government agencies is evidence of the conspiracy to intimidate and victimise one

individual - that is a crime

21. To have the VHREOV deny helping in any one of these discrimination cases is blacklisting and a crime

22. Blaming a victim of being a principal aggressor in a violent affray when they intervened to save a life via VOCAT is corruption

23. A Magistrate rejecting a child sexual abuse victims case as being 'doomed to

fail' after over three years of a law firm aiding and abetting your early death by suicide is incorrigible and perversion and corruption of a judge

24. An ASIO employee of the government who keeps his fiancé in financial and sexual servitude for over five years and leaves him with no equitable separation is a cover up, and to be still confronted

25. That all this happen to one person is evidence of framing and victimisation - in

itself illegal

26. To ban an individual from 2 x medical practices, and other agencies to suffer isolated at risk of suicide aids and abets that persons death before they get justice

27. This is why the oppressive system wants to kill me

28. I still have no Dr or specialist

Dear Richard,

Unfortunately this is outside the scope of our usual casework.

We do not have sufficient resources to go through what appears to be a complex history of issues. Furthermore, we are currently overwhelmed in terms of caseload.

Dom I knew you said you would attempt to be the bridge between these legal agencies for people with disabilities but as I have done a hundred times with VMIAC and both of the addressed organisations or statutory independent bodies they will not respond

I am wondering if you can use yourr pulling power to make them act in a way that does not gaslight blackmail or oppress me

That was the very way the oppression led me to sustain a fatal injury min the first place

My certain death, is now covered up by the HCC the MHCC and the office of the information commissioner and also the hospital and the victorian ombudsman Ben Calder.

The CEO of the hospital was so delighted that the oppression that stemmed from my framing by Mr Ball who was Dr Whitakers lawyer worked so effectively and totally behind closed doors, that the CEO of the hospital baited me to sue him directly, knowing that the entire system is cooked and biased in a way that silences my \voice and renders me an inner pleb of a citizen written off as mad with the

proverbial can kicked down the road until it is believed I will kill myself before I get any justice what soever.

Even though I have no psychologist nor a psychiatrist and the local salt water clinic, an arm of the hospital only saw me twice after my murder via conspiracy, they saw me only twice in ten months.

This is more than a bad public mental health service.

It is a systemic oppression that denies me a voice and aids and abets my death.

Stevenson the CEO oversees Salt water clinic, an arm under the auspice of the hospital I have failed to sue.

This is where it is critical that the organisations DDLS and MHLC change their tune and they jump on board.

Because I have no access to healthcare, I was put on jobseeker, I cannot report rapem, murder, fraud or financial control and sexual slavery to one single police officer.

The case is before IBACV now and I am creating an online registry of every agency that has heinously blacklisted and gaslighted or ignored me

For a person suffering apparently from a cooked child sexual abuse case that imwas framed by plus schizophrenia bipolar and panic disorder personality disorder and adjustment disorder and ADHD I still...after all this time...

Am squatting

Gone bankrupt

Lost my job

Been begging for help

The police hassle me

I am being followed

My online activities monitored

And additionally my web hosting I caught out hacking my emails and deleting Comcare emails off the server, which was my work cover.

Further to me not being able to appeal because of lost emails, Micron21 the hosting, without warning, knew they were caught and knew my evidence was on the server.

They internationally went out of their way to desecrate and destroy it and in doing so ruined my website which was all my ABN and my entire digital identity with my [email rich@richmclean.com.au](mailto:email_rich@richmclean.com.au)

I complained to the telecommunication ombudsman and also the small business ombudsman and business.vic.gov.au

I have no choice and they have all found ways to exploit and reject and gaslight me which is what you all have done to me before.

Should you not change tune now you will be held accountable for conspiracy to pervert the course of justice

There is no other way for me

I am without care medication or agency to speak and I am heinously systemically oppressed and I can prove it all.

Please help me

...or they will kill me - and blame mental illness or drugs as I am easily exploitable with my very public profile and was niche famous now infamous, I even have deflative letters from MP Greg Hunt and MP Katie Hall and MP (forget name) has whitewashed me

There are too many people involved I will be killed (or murdered as has already occurred), however I added up all the malpractice human rights and AFCA determinations and thefts and bank issues

92 million dollars

Imagine the agency I would have with that and the unbiased litigation and taking it to the high court

I am so distressed - that not one person will stand with me as a victim who spent 25+ years giving to the Australian local state national and international community

For the record, I have never extorted anyone nor kill myself willy nilly as the office of the chief psychiatrist says 'you can't kill yourself every time you don't get what you want'

Incredible isn't it

I was actually gifted 100 grand at one point from an unexpected source - the person said they made a mistake because they were ill

I gave it back

Additionally no ombudsman will defend me, the VHREOV (who I have an award from) will not defend me neither with AHRC or any agency or indeed any family member Orr friend or acquaintance

Now you know - and this will be published and everyones responses...

That this simply must be a matter for the high court.

It is impossible I be murdered via systemic oppression after malpractice that led me to overdose and denied all care then another conspiracy be born to cover up the fatal injury ins hospital and I need one single domino to fall

...and I am depending on you all

It is unholy that this be cast of a person already suffering death threats from my former ASIO partner who owes me over half a million dollars and was present at a murder and tax embezzler, and my own childhood sexual abuse case not given an outcome except for the cooked magistrate to say 'I was doomed to fail' and another violent affray where I was hosopitalised with injuries and broken bones for defending a person who I thought would be killed-only to have the police define myself as the principal aggressor

I cant stand it its become a black comedy like I am in the Truman show

I am being framed as we speak and I beg of yourselves to cross the party line and advocate for a person who has suffered so much, then nearly died, then murdered, then a cover up

I am infamous now famous.

I will not give up
