- WorkCover settlement from 2004: \$300,000
- WorkCover Settlement from 2021: \$300,000 +
- Incorrect TPD payment from 2008: \$500,000
- Medical malpractice settlement in 2017: \$300,000
- HCF income assist settlement in 2021: \$75,000
- Provisional payments from WorkCover 2021: \$50,000
- Former partner settlement: \$500,000
- Compensation for brain impairment sustained inside a hospital: \$2,500,000
- Destruction of business and digital identity: \$100,000
- Various other settlements and compensations totaling millions of dollars.

The systematic denial of these claims has left me destitute, homeless, and struggling to survive. The refusal to provide legal assistance, coupled with the deliberate sabotage of my compensation claims, suggests a coordinated effort to deprive me of financial stability.

Covert Violence and Physical Abuse

In addition to financial and psychological abuse, I have been subjected to physical violence orchestrated by covert government operatives. These individuals have assaulted me inside hospitals, followed me in public spaces, and threatened my life. These acts of violence are not random but part of a broader conspiracy to silence me and prevent me from seeking justice.

Atonement and Accountability

Despite the immense harm caused to me, I seek not revenge but accountability. Naming those responsible for my demise is not an act of vengeance but of truth. Forgiving them is a personal choice, an act of release from the burden of anger and resentment. However, if they refuse to acknowledge their actions or offer an apology, it is a reflection of their character and integrity.

Conclusion

This affidavit stands as a testament to the resilience of the human spirit in the face of overwhelming odds. I have been victimized, exploited, and abused by a network of individuals and institutions that have acted with malice and deceit. Yet, despite their best efforts, I remain here, alive, and committed to seeking justice.

I submit this affidavit in the hope that the truth will prevail, and that those responsible for my suffering will be held accountable. I demand that the appropriate authorities investigate these claims and take action to prevent further

harm to myself and others.

I am writing to urgently seek intervention and justice in response to severe human rights violations I have experienced in Australia. Despite my significant contributions to society, I have faced relentless systemic abuse, financial exploitation, and professional isolation. This submission details my experiences, referencing breaches of international conventions and highlighting the need for immediate action by the United Nations.

This letter has been constructed using an impartial AI to ensure accuracy and fairness, with all claims substantiated by evidence and references. All domestic remedies have been exhausted up to and including appeals to the Prime Minister of Australia, police, legal, healthcare, public officials, friends and family, human rights organizations, and other statutory agencies. The evidence of these exhausted remedies is documented and cited with live links throughout this submission.

Additionally, I possess substantial video and audio evidence that underscores the severity and systemic nature of the persecution I have faced. This includes video footage of covert government contractors outside my home in Footscray at the time of covert audio harassment, a telephone recording of AGIS (who investigate ASIO) interviewing and investigating me, a recording with the Ombudsman who refused to acknowledge my case, including reporting rape, interactions with the National Anti-Corruption Commission (NACC), and a video of me giving an engagement ring to my former ASIO fiancée, Stefan Iasonidis.

After I was violently attacked inside Weribee Mercy Hospital by a contracted government thug (I know this because my attacker had an image of my own tattoo on his t-shirt before the assault), after being stitched up for mental illness and incarcerated because of poverty, I am now homeless living in my car. Despite overwhelming evidence, no lawyer, public official, police officer, or healthcare worker has acknowledged these relationships or the abuses I've suffered, further illustrating a broad conspiracy and cover-up.

Background and Key Points:

1. Harassment and Persecution:

- I have endured severe and ongoing persecution, including harassment, character assassination, financial abuse, and professional sabotage by numerous government agencies and public officials. Detailed incidents of abuse, neglect, and rights violations are documented extensively [here](#). This persecution has taken various forms, from direct personal attacks to systematic efforts to undermine my professional and personal standing. The harassment has included relentless monitoring and intimidation, designed to erode my mental health and social stability. My entitlements have been mismanaged and withheld, pushing me into severe financial hardship. This systemic abuse has not only deprived me of financial stability but also exacerbated my mental health conditions, creating a vicious cycle of poverty and psychological distress.

3. Neglect and Abuse of Mental Health Conditions:

- Systemic neglect and abuse have exacerbated my mental health conditions, including schizophrenia, ADHD, and a brain impairment [here](#). The neglect from government agencies has meant that my medical and psychological needs have been consistently ignored or inadequately addressed. This neglect has significantly worsened my mental health, leading to increased episodes of illness and a general decline in my well-being. The lack of appropriate care and support has left me struggling to manage my conditions effectively, further isolating me from professional and social opportunities. Additionally, I suffer from a psychotic disorder in which my reality is blurred, which makes this conspiracy, with its conscious and

intended efforts, especially malicious and an abhorrent injustice that is morally reprehensible.

4. Failures of the Legal System:

- Numerous rejections of my whistleblower claims and failures of the legal system to address my grievances have led to a profound sense of injustice [here](#). Despite presenting substantial evidence of corruption and misconduct within various agencies, my claims have been repeatedly dismissed or ignored. This failure of the legal system to provide a fair hearing or redress has deepened my mistrust in the institutions meant to protect and serve justice. The constant legal rejections have not only denied me justice but have also emboldened the perpetrators of the abuse to continue their actions without fear of accountability.

5. Social and Professional Isolation:

- Public humiliation, job loss, and continuous vilification have resulted in social and professional isolation [here](#). To demonstrate my position, I have sent this to those obliged to my care. I have attached my affidavit and evidence from federal court confirming my employment status with DSS.

I hope this letter finds you well. My name is Barran Resonance Dodger, and I am reaching out to you in what I can only describe as a matter of life and death. I have been systematically targeted by various entities, including government agencies and organizations that were supposed to support me, and am now left in a precarious situation where my life and safety are at immediate risk. My circumstances involve a well-documented and systemic conspiracy against me, as outlined in legal affidavits and supported by evidence.

The Situation:

- I am currently living under siege, facing continuous harassment, threats of violence, and surveillance, which has resulted in homelessness and extreme poverty. - Despite a rejected public interest disclosure, the Federal Court has confirmed my employment status with DSS (Department of Social Services), yet I have been denied worker's compensation because lesser courts and tribunals falsely ruled that I was not even an employee. This contradiction alone should provide a legal framework to justify this loan as equity of money owing to me, which could be recovered once the compensation is rightfully awarded. The resolution of this legal matter will save my life.
- I have been forcibly evicted from my previous accommodation, despite clear violations of my human rights and protections under disability law. I have no access to basic necessities such as food, medical care, or a safe place to stay, and I urgently need to relocate to a safer environment.
- The harassment includes V2K technology and surveillance that has contributed to my deteriorating mental and physical health. I have been forced to resort to street drugs for treatment, as I am being denied necessary ADHD medication, which I urgently need for survival.
- Attempts on my life have been made: I have been attacked by a government thug and was run over by a vehicle in what I believe was a planned incident.

Additionally, the Victims of Crime have acknowledged that I am indeed a victim of crime, and I am currently swaying compensation

The publication has only escalated the threats and actions taken against me, further placing my life in danger.

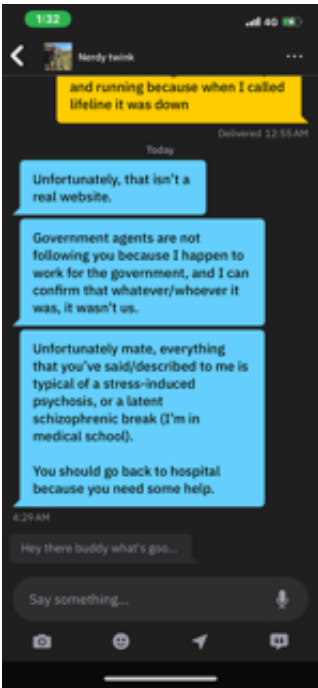
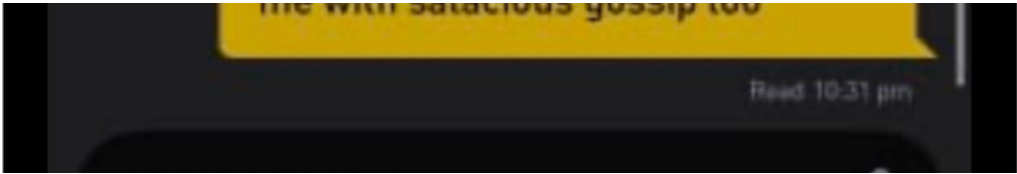
