I am writing to you about your Priority Access application on the Victorian Housing Register.

- applicant failed to provide the requested documentation to confirm they are at risk due to a serious threat of family violence

If your application has not been approved because the Department of Families, Fairness and Housing has not been able to contact you, you can contact the department within two years from the date of this letter to confirm your eligibility.

If your application was not approved because it does not meet the Priority Access eligibility criteria, your application will be reassessed for the Register of Interest and you will be notified of the outcome shortly.

Should you consider a wrong decision has been made or you have any questions about your application, please contact the Dandenong Housing Office on 1300 555 526. You can also contact an Appeals Information Officer on 1800 807 702 to discuss further.

If your situation changes, you may reapply for social housing. You can apply online using a myGov account at www.my.gov.au, downloading a paper form from www.housing.vic.gov.au, or by calling the Dandenong Housing Office on 1300 555 526.

You can also use the Housing Options Finder on the housing website to explore other options based on your answers to a few questions.
