Justice Letter — 26 March 2022

To the Government and others/ beneficiaries:

Lets turn something shit into something good...

Because justice simply must exist...

Otherwise faced with my loss of dignity and human value and already survived being murdered and it then covered up and isolated and character assassinated; I'm gone - and that what they want; YOU stand in the way of my death or turning the country upside down.

I am in Mildura. Here is a pic of me on the way in Bendigo. (I have a dog sitter for now and made provisions for what will occur).

This is my last self advocacy letter for injustices and detriment.

I have proven beyond reasonable doubt :

- A conspiracy to pervert the course of justice
- That you have all made me suffer, indeed, tortured me systemically over years that was a massive contributing fact to my murder, in Weribbee Mercy Hospital
- That Government agencies attacked me via proxy attacking my access to prosperity and my ability to earn it
- This happened to protect Steve Iasonidis, my former partner and ASIO employee who embezzled 1/2 million in a tax haven and got a slap on the wrist, and left me homeless with his dying dog and owes me over \$500000
- My whole family has scapegoated and rejected me with prejudice homophobia and judgements which were intelligently designed to exploit already half truths amplifying ingrained prejudice.
- I am not insane, nor psychotic, nor delusional, nor suicidal
- I am the victim of a heinous malicious and conscious movement to kill me after I made a valid complaint about a GP
- My evidence was silenced to protect the GP (who is not even registered for GST nor a member of AHPRA), from many Government agencies police inspectorates IBAC and ombudsman's, which is the very definition of victimisation
- Since then I published it, nothing happened, except the GP was fired and I was victim blamed and banned from two clinics
- I was also banned from making any complaint to the VHREOCV (Irony!)
- I since have actually been rejected from making ANY at the Commonwealth Ombudsman and Police and Federal Police
- Further my suicide (murder from oppression that was systemic and elongated), occurred IN A PUBLIC HOSPITAL

- That was then covered up and condoned by the Government as innocuous
- All agencies set me up to fail over time hoping I would die - and then they watched as i squirmed and was made to feel less than death. (HCC, Mercy Hospital, MHCC, OAIC, Police, Ombudsma).
- Not a human soul did stand in defence of my death because I did not know I was framed as an extortionist internally
- My own parents victim blamed me for wanting to die & did not stick up for me in any way whatsoever, in doing so protected the hospital • (I think they think I kill myself for fun).
- I had to fight for my FOI which the OAIC and Weribee Mercy redacted after they first blacklisted me
- Only after I survived what the FOI from mercy Hospital says was 'fatal' and 'a lethal injury' which alludes to it was not some sort of attention seeking behaviour
- The office of the Chief psychiatrist told me that 'I cant kill myself every time I dont get what I want' and this is abhorrent, but the word on the street as the way I had been framed
- I realised I had been framed as an extortionist by a GP's lawyer only after I was dumped with no job car food money or assistance, squatting
- That slander was internally moved via conspiracy throughout agencies right up to that The Australian medical Review Board
- Not one agency rejected that slander by a powerful lawyer Mr Ball of Ball and associates - and the evidence was never heard or indeed, read, and indeed my years long battle was based on absolutely nothing
- That is a conspiracy to kill
- I realised that I was silently attacked via proxy by former partner Steve Iasonidis, who was a former ASIO employee who's is protecting his money by keeping me broke.
- This is so I cant legally access my just and legal equitable separation in assets that he still owes me until this day of over \$500000
- He confessed to me he was present at a Murder and police will not accept my knowledge or concern, and in addition when I was first hospitalised I protested this and Mr Iasonidis weakness is his fear of being found out, and he messaged me this evidence on my website, (obviously from him in his anger):
- He used me as a sexual slave and economic slave and via coercion for five years in a toxic game of gaslighting outward charms and inward torture of me.
- He threatened a hit man on me, left me with his dying dog, and stole my car and intimidated me with death threats, and blackmailed me that he would dob me into Centrelink and send me to jail for receiving a DSP - something I admitted to legitimise the relationship but he coerced I go back on it
- I have all his evidence of his tasteless pornography, his income statements and his love letters and c*ck shots of many men he deceived me with, whilst he violently threatened monogamy on me (I should have known).
- I have his podcasts and his music and his porn and his passwords and different bank accounts all used with different names and spelling of his name, up to and including emails from the accountant that had funnelled the 1.2 million in an offshore tax haven, warning me of his volatile nature.

- I tried to get an intervention order and it was denied, before I accessed a community legal service to get my justice. When Monash Law found out it was him - they dropped me like a hot potato
-
- I have proven beyond reasonable doubt that no one cares,
- No one is invested in justice
- All they see is illness via prejudice
- It is beyond reasonable doubt that this movement to destroy desecrate incarcerate or kill me - is intelligently designed
- Further I was to be forced into destitution as the agencies watched me suffer and rejected me
- When i didn't die they came for me...and then hospitalised me against my will not once but twice
- There is a plan to incarcerate me an enemy of the state framed by crimes I know i have been framed with and for which i will lose my freedom
- I will die before I lose my freedom

The valid complaint and my innocuous evidence I had about the GPs malpractice was legal tender in a court, due to surveillance act 1999 in Vic.

If it wasn't, no one arrested me when it was published-but the GP lost his job I was banned from clinics, and then I knew that he was never registered for GST nor a member at AHPRA. They all watched an overdose victim struggle in vain as I attempted for years to bring it to light, but I was further shamed.

It is not my shame to possess, all I did was ask for help.

The GP was not even registered for GST, or listed as a practitioner with AHPRA as required who effectively banned me from all communication, as have MHCC, HCC, OAIC, The Police, The Federal Police and many agencies and statutory organisations utilising the delay defer deny model.

...but alas its too late.

You all already have blood on your hands.

Now is the opportunity to atone yourselves or assist me in my fight against Government tyranny.

If you are a beneficiary, i encourage you to send this to every member of parliament to the attachment with their emails.

Now - for me having proved human natures fallibility to believe slander and libel, and judge me for my choices or who I am, I don't mind exiting or dying now I have been cornered and my very freedom at stake.

Before that though, a last shot at justice, where I will be able to live in peace, without you all, protected with my dog from death threats and finally afforded the dignity of a simple life free from oppression...that was taken from me.

I want a guarantee i'll have it.

I only need a simple life free from oppression - the rest of my just compensation of the millions in detriment if my demands are met go to charity.

In particular

- Trans kids
- Education for detecting and avoiding sexual abuse of children
- Even though they deceived me, The banksia Unit for child and adolescent mental health at The Royal Children's Hospital
- I will create a foundation directed by me as a non for profit which gifts artists like

1. Glenn Brady
2. Geordy Wood
3. Will Coles

(If you are one of these people send this email to every parliamentarian attached and save a life).

I will help Hung Ho my landlord and his new family because he has been good to me.

...at my discretion, as i live in peace.

As an oppressed scapegoated political prisoner i will stick top for those who are up against a wall.

I will give cowards the opportunity to apologise before I sue them.

That is my plan apart from a simple life, because i dont need money.

Just a few drugs booze a place to stay for my dog and I and have sex.

Of giving back and turning this shit show into something good that I will live and be afforded a simple human dignity without death threats

I DEMAND:

- Whistleblower Status
- Be able to report to police
- Freedom from incarceration or jail for perceived crimes or ones I am and have been framed with
- Be able to live in peace free from proxy attack via agencies
- Freedom from jail or incarceration
- Be able to make a PID
- Be able to access litigation and take civil action on individuals
- All the cowards that have led me to this dreadful situation and paid by the Government to oppress me like a cheap hooker will be given the chance to apologise before I sue them
- Access to a non biased lawyer for the federal circuit court

These basic human dignities are already ratified in the charter of human rights for people with a disability signed into law by this Government.

It is brutal I have been persecuted and left to die after I actually did.

Every public officer who acts for the Government must act within this charter. It is a legal obligation to acting within that charter, and also the human rights charter for any Government official:

- To not discriminate
- Access to the law
- freedom from exploitation
- and abuse
- a home and provisions
- to not be subject to torture

I will hold to account the many many cowards paid by the Government to tow the party line to elongate the space I may kill myself on and oppress me and occupy their place in the conspiracy to pervert the course of justice.

I will give them a chance to apologise.

As it is of 23.03.2022

- I have had to escape persecution in which my freedom was at risk
- i have no food medicine and
- i am squatting
- I cant feed my dog
- Everyone has disowned me
- I have been character assassinated
- I am a scapegoat
- I have no money for rent
- Every support worker abandoned me
- I am victim blamed
- i am framed for crimes I have not committed
- i am going to be put in a psychiatric prison is my understanding
- I will kill myself on Menindee lake if this is to occur
- Hence I want whistle blower protection
- a guarantee I will not be jailed and free from incarceration
- or imprisonment

The following people made me suffer in great distress seeking justice, but they had advance knowledge of rejecting me to my great distress:

- HCC,
- AHPRA,
- NHPOPC,
- The Police,
- IBAC,
- The Victorian Inspectorate and
- Federal police
- Jack health
- Gordon parker
- Maribrynong Criminal investigations unit

I was hospitalised for having delusions of persecution, WRONG. It was a PUNISHMENT

This is despite even though i was already conspired against, and unknowingly framed as an extortionist.

I was also also attacked via proxy by my former partner Steve Stefan Stefen Steve stefanos Stenanis Iasonidis,

...to protect my former partner and his money he legally owes me - and the murders he was present at he admitted to me.

Also to cover up other drugs he dealt, the proceeds of crime, the tax evasion, and the cover up to protect privileged powerful people with money and reputations.

I am not an idiot but I have been a fool to believe that justice is more powerful than slander and libel.

No one stood for my justice and I battled alone.

I had lost two VOCAT cases

1. A violent affray pinned on me despite video evidence police redacted from me
2. My own child sexual abuse case in which I was told I was 'doomed' to fail by a crooked magistrate after zero official result was handed to me

I worked for the NDIS as a therapist and collated my abusive clients tragic child sexual abuse case, of child rapes and incest. It bothered and triggered me, and he was abusive and I made provisions to keep myself risk free.

I knew and realised I had been framed along the line - in order to protect the GP, and my former partner, and my work stress had made my VOCAT statement for my client illegitimate for my important working for the NDIS

HCF refused to pay me for work related 'illness' in which Sheena Jack the CEO oversaw fraudulent PDFs I had never seen...

and AFCA watched on as I became a vagrant, and by legislation they are supposed to act 'fair and 'reasonable' and be 'independent', however before the death and well after the death - they watched as i burned and was tortured.

Desperate for a solution once work safe and HCF and my former pater had deceived me after i was character assassinated from my job and lost tow VOCAT cases...

I called out the injustice of my former partner who swore to ruin me and demand my money

I don't have evidence of the murder apart from this message received on my website, clearly from him.

I was hospitalised against my will despite calmly acknowledging the corruption conspiracy and detriment.

The years long oppression misdiagnosis and malpractice led to my suicide in Werribee mercy hospital in Feb 2021.

I have lived with an acquired brain injury ever since.

i cannot feel my feet

i was unethically discharged and I saw a psychiatrist twice in 10 months. The second was to kick me out of the service.

Dave Stevenson the CEO oversaw salt water clinic.

he wants me incarcerated to protect his hide after I offered him a simple atonement the tragedy happened and he refused

he knows too well:

- I am framed
- I cant go to police
- I cant get a lawyer
- I cant be a whistleblower at AFSA ASIC IBAC or the Commonwealth Ombudsman

I have advance knowledge from Dr Yohan that I will be incarcerated an award of the state at her majesties pleasure if I go in again.

I barely escaped yesterday

With not one person in the world left to defend me or love me or who are not prejudiced...

I make this final statement for my whistleblower status and immediate atonement from The Government via email to my address at richarddrawsstuff@gmail.com to:

1. Guarantee me whistleblower status
2. Immediate financial relief while detriment is worked out
3. Afford me the law of getting a lawyer
4. Instruct me to justice from narcissist former partner which will immediately relieve me
5. I have the choice to sue for a conspiracy to pervert the course of justice, and a vile victimisation in the supreme court against the Government

I want to say what you all did to me was:

1. It was torture
2. I suffered financially mentally
3. My human value was left in tatters
4. I was robbed
5. i had no worth
6. I knew the world wanted me to die
7. it was over an elongated period of time
8. It was conscious malicious and intentional and a vile way to gang up on a vulnerable person
9. Who had given his life in advice art and passion at www.richmclean.com.au

Not a single human being stood in the defence of my 'suicide' which was a conspiracy to manslaughter - it was only not a conspiracy to murder only because I lived.

They had it wrong. I was not psychotic - they knew this. Dr kumar had seen me years before - he knew of the toxic relationship of my former partner and the ASIO connection he knew I thought I was at risk of violence, I felt he had it in him knowing he was present at a murder.

I was victimised and oppressed systemically and framed.

In hospital I was misdiagnosed mistreated rejected my dignity.

Am I crazy?

or is it not a crime to kill yourself in a hospital with a duty of care with an agreed illegal contraband?

The Government and other are aware i fought in futility alone for years.

Here is the detriment:

I've lost over 1 million detriment from AFCA

I've lost 500000 or more from my former partner who has conspired to render me broke so I cannot act

He was also present at a murder and dealt cocaine to buy a home sell it and embezzle 1.2 million in a tax haven

he was caught - a slap on the wrist by ASIO his employer

What have I got to lose.

The narcissistic powers that are are cowardly and exploit already existing vulnerabilities that I bravely shared only to be exploited

From 18 feb 2022

I have a public profile of someone who identified with a mental illness; I wrote a human rights award winning autobiography at 27.

When it came out my old employer where I was an artist the herald sun vilified she shamed me with the heading "my descent into madness, how Richard McKean's mind was stolen".

At the time I had been working across town at the age for nearly five years as a mess graphics artist and illustrator but I was rostered out so I had to leave three weeks later

It's been an uphill battle of stigma shame and oppression.

Recently after a gay relationship with a criminal financially coercive narcissistic sociopath who worked for Steve jobs then ASIO, I reverse engineered a malicious conscious and vile victimisation that aided and abetted my death.

I did not receive compensation from the man who escaped with a million in super, and I had spent my best egg

Later I failed a VOCAT case where I helped a person being savagely beaten it was pinned on me

I did a masters degree and scholarship for PhD

During that I became isolated always in poverty and my dear friend suicided

Malpractice occurred as I bravely reached for help-I recorded the consultation because the gaslighting and oppression was driving me insane I was suicidal from grief

I was character assassinated via a complaint about the go after I overdosed on opiates he have me in the same setting

His lawyer framed me as an extortionist I found this out tests later after I finished the doctorate and I had worked for two years as a registered therapeutic support for the ndis

My child sexual abuse case aided and abetted my failure and my dignity crushed the magistrate wrote me I was "doomed to fail"

I did not understand

I began to think I should hold my former partner o account as I was doing a VOCAT case for my two year client but I had been character assassinated

My work would never be taken seriously

Ahpra NhPOPC police IBAC and Victorian inspectorate Greg hunt and the ombudsman covered up my evidence which I held for a long time as to not harm the dr

I could not. Work but by income assist did not pay

Previously I lost 1-2 million from AHRC who free kicked a conciliation today the super company who were discriminatory

At the same time AFCA witnessed me become a vagrant and I begged for justice with my former partner

My family saw illness but I needed justice

I was incarcerated, my dog the only thing I had left was in the rental I squatted in as a vagrant fir four days I was misdiagnosed and treated abhorrently

I suicided in tgere and the FOI deemed it "fatal" and "lethal" I was found unresponsive with no observabl pulse

I was released and rejected that was March 21 I have not seen one psychologist and I have not seen one psychologist since that time and kicked out of the service

I lived in poverty with agencies conspiring to attack me via proxy, my business and website was destroyed

Long story short today I'm a vagrant an infamous one

Work cover was rejected from concare and now at the AAT but I have a brain injury

The government have already killed me now they have a lawyer to defend them

The ombudsman and mental health complaints commissioner confined the death

I am banned from the police and from litigation also a failed whistleblower

I store to the attorney general because my work cover case was set to fail

She told me to call the same helpline

I am a recipient of ndis too I wrote to the minister after over forty of my invoices were blacklisted I have no help I'm isolated

No medication no food squatting owed millions

The hospital ceo knowing I was powerless and framed dated me to sue him

I have been utterly desecrated and character assassinated

I launched a website www.killhim.info because they have re feted me an innocuous vagrant with no voice

I'm infamous

I don't know what to do

Everyone has turned against me and apparently I have mental l'llbessand brain injury

I've not got rough food or healthcare

The government know this they want to kill me. Before justice

I need an advocate and I've appealed to the public to help and the media but I'm scapegoated

I think I need to hold the federal government to account as an individual in the Supreme Court

How do. I do that I'm jus a vagrant with a brain injury

I was oppressed misdiagnosed and basically killed then covered up then ostracised and robbed millions left to die

I don't need welfare I need justice but I'm framed

It's victimisation and abuse of human rights

This oppression already killed me once and no one cared a year on i lived in abject poverty and no one helped - you all witnessed this - and they hoped I would kill myself

Now I have no dr no medication no care squatting an infamous vagrant

I've been threatened in incarceration to be awarding the state

Who can help

YOU CAN WITNESS THE SUFFERING

because that's what you wanted for me

and it happened

then it was condoned

that's when things got bad

AND I OBJECT

I want my whistleblower protections and dignity and freedom to litigate and freedom from incarceration in an institution and jail in writing by the feds by Monday 5pm.

and i aint afraid to die having proven there is no love in my world
