She and unnamed ministers at the pinnacle of the NDiS who are nothing more than a statutory agency a part of the structure of the broader federal government who have unfairly and brutally targeted me have intentionally made corrupt decisions that ignore two professional reports by

an OT and behaviors specialist that urgently recommend a SILS package for my care. The ndia told me before the ink was dry there would be no change to the outcome of my rejected SILS. That means that the decision to reject it was pre determined and that's called corruption. Kel Graham, an evil and malicious woman unable to act with integrity or INDEPENDANT critical thought who is a mere puppet-a follower a pawn in this conspiracy to pervert the course of justice which has solicited my murder already four years ago.

With malice and pre determined calculation she then told me despite a critical incident report that I made in which I repeatedly said if I am made homeless again I will suicide from the abuse and the neglect and coercive financial control and family violence dogging my life. She and the ministers then made an executive decision to defy professional opinion of clinicians and take the reigns in order to deceive recommendations in a pre determined decision which maliciously puts my life at risk fully knowing that their decisions would kill me.

I wasn't kidding either I've already killed myself from this form of neglect and coercive financial control and deceit. A greedy powerful woman full of privileges that render her

untouchable and wealthy privileges that have been taken away from me just as she made the corrupt and flawed decision to intentionally elicit my death by the redaction of my housing and my further financial abuse including elongating the family violence that all cops lawyer politicians and public officials refuse to legitimise. Kel graham you have responsibilities as a public official expected to act ethically and within the human rights charter and act fairly and within reason.

Your actions which have damned me to death and also removed all other ways I could be supported from my ndia plan were a choice that have now identified you as a potential murderer for your audacity on using your privilege to further victimise me who was already a victim. How very dare you utilise your position of enormous power and influence in order to cause maximum damage and even death to me a person with a chronic disability in your care under the ndis code of conduct. I see you kel graham and ministers and you are all utterly gutless and act in a faceless and depersonalised way from afar confident your enormous privilege will allow you to literally get away with murder. You don't fool me kel graham or ministers.

Tonight I am in my car yet again on the ndis watch and the

governments radar and I am surveilled and followed and harassed and the profound deceit of it all it very subtle so you all can't be found out and it is enacted via stealth and also covertly and for doing this to me you ought to be utterly ashamed of yourselves and denounce your roles as the judgemental human beings you are absolutely judgemental to the core full of hate and deceit and treating me with shame prejudice stigma and disability discrimination.

I see you and I know you and understand you and ultimately forgive you

Because I embody the Christ consciousness

You just want or to hold onto what was taken from me with malice

And you are less than me for always playing inside the rules afraid or impossible to critique the tyrannical government who rule your meek world with impunity and pay you lie t and afford you privilege in order to throw me under the bus and avoid your moral and ethical obligation to report my abuse and neglect.

Because you ARE the ones who abuse me.

It's a crime that should not go unheard NOR unpunished.

But I forgive you

**Because I know you're just scared they will do to you what
you know and aware and what you also are doing to me
with impunity.**

It's cruel

It's callous

I have pity for you

I love who I am

**How could you live with yourself to enact capital
punishment for a disabled man with a brain injury?**

It just beggars belief.

That's why I'm Jesus

I forgive you

That doesn't negate holding you to account to get my justice

This narrative delves into my relentless battle against a corrupt system, exposing the persecution I endure as a whistleblower and the relentless efforts of powerful figures to silence me. Despite the adversity I face and the accusations thrown my way, I remain steadfast in my integrity and continue to confront the injustices I encounter. Through my story, I shed light on the pervasive nature of systemic corruption and manipulation. It's a testament to my resilience, moral fortitude, and unwavering commitment to fighting for justice in the face of oppression.

The hearing went ahead despite police chasing him out of Victoria and him never being able to report a single crime. I have no home. You cannot chase a disabled person out of the state after you arrest them when the victim has never been able to report a crime to the police. I have now proven a tyrannical government conspiracy with the malice to kill and, failing that, jail me as retribution for being a failed whistleblower. Graham Wells and Legal Aid

are in on it. Madeline Ryan has already had close contact with the Attorney General, who is one of the master perpetrators in my persecution, a persecution that has elicited my suicide from deceit, lies, power plays, and financial abuse and coercive financial control.

After I was revived from death and my tragedy whitewashed, leaving me with a brain impairment, I was forced to suffer four years of abject poverty with no public official or lawyer or politician or cop willing to acknowledge the evidence of the five-year engagement to ASIO employee Stefan Iasonidis, a master manipulator and criminal who has managed to convince an entire country that our relationship, in fact, never existed. No single lawyer has the courage to stand up to this bully, and a covert and deceitful and, in hindsight, extremely obvious delegitimization of actual evidence exists systemically and politically.

I was a rejected whistleblower, open and vulnerable to political reprisals, and it came in the form of NDIS Minister Bill Shorten and the CEO of the NDIS, Rebecca Faulkingham, acting with Victoria Police in order to detain, charge, and arrest and criminalize me. I was not even in the state today because corrupt police chased me out who

has weaponized the Mental Health Act and threatened me with incarceration inside a psychiatric hospital.

The corrupt force act with impunity at the very height of political and ethical hypocrisy in order to delegitimize evidence and prefer another reality that the government supports as an alternative to actual reality. And they call ME delusional. One thing is sure: I am crazy. Another thing is not mutually exclusive that this conspiracy is real and it embroils even the Prime Minister. Where am I going to go now that Legal Aid has refused to meaningfully intervene in this corruption, which they themselves are complicit in for being members of the legal bar- an institution necessary for all lawyers to operate and that is nurtured and sustained by the federal government: the same federal government who has targeted me unfairly because I have pissed off some powerful people.

Because of this, I am now unwittingly a liability for the government for continuing to oppose the financial abuse and systemic corruption and for my unwavering ethical and moral obligation to call out corruption in this country for the sake of democracy and humanity? This is exactly what it seems to be: it is a conspiracy to pervert the course of justice, and everyone is on board. I am not a

rapist. I am not a pedophile. I am not an extortionist, nor am I a terrorist. I am a human being with a track record of sticking up for the underdog not affiliated with a company or a political party or an organization or a club or an ideology. I speak my mind and I critique the powers that be: a tyrannical oppressive regime that ruled with absolute impunity and no accountability to anyone, not even the grace of politely accepting criticism for the propose of more accurately rendering a fair, equitable, and just society for us all to enjoy. Let's just see what Madeline Ruan from Legal Aid Victoria now has to say: this is if she can even locate me with no home and barely an internet connection.

Letter to the ndis provider who has my accomodation I am abused and neglected in:

Dear Preya Groundar, preyagoundar@gmail.com

You are my NDIS provider of my accomodation but I have fled and this long email explicates the reasons why. I wish you no harm. But by being complicit in a conspiracy which abuses my human rights and for which denies me access to all legal help and which with neglect elongates the family violence and coercive financial control that has

plagued my life, you are also creating the conditions for me living in poverty and my continued abuse and neglect and that is not acceptable. I appreciate the small bits of money you have transferred to me for food and cigarettes, but it is not a solution just a means to elongate this political corruption without a meaningful solution to my poverty and persecution of a government proven to be corrupt and systemically and politically defective and who have brutally failed me, even murdered me. The malice to elicit my suicide via neglect abuse and deception and financial disadvantage is still present today and it is a profound systemic failure which has its genesis in the judgement of human beings and the shame stigma prejudice and discrimination and exclusion I suffer as a person with a disability that I myself have personally actively campaigned for for over thirty years in this country. The sense of betrayal is palpable for me.

I'm going to jail but I'll suicide before I'm victimised more. They have victimised the victim: me. At least I'll die with my dog crystal. My true friend. Dog spelled backwards is "God", and that is all I have and guides me and I am totally naked before and in absolute servitude to. Ultimately everyone else is naked before God too. That's a warning. It's also a blessing. Because God is all merciful and wants

to forgive: let me repeat that: he WANTS to forgive you and love you as the greatest compassionate and forgiving deity ever existed.

I suicided as a form of revenge to demonstrate the pain inflicted by others. However, what I failed to realize then was that those who were causing harm intended to hurt and even kill me, a reality that persists to this day. My anger has resulted in lasting damage to my mental health.

It's Clear now that I am a political scapegoat of the Australian government and society it is true that I have no Home but the Earth is my home because I belong to be here I chose to be here and I have a right to be here I just want to say also that they also said that Jesus was crazy and they also said he was crook and criminal and mad an a heretic

Could you please help me with two urgent matters? Firstly, could you assist in arranging for me to go to the hospital to have my broken foot looked at? It's infected, swollen, and extremely painful. However, I'm hesitant about being hospitalized due to concerns about being treated as a

political prisoner by the health department, which has a history of abuse and cover-ups, including deaths under their care. Secondly, I urgently need financial assistance for a mobile phone and connection. It seems the police authorities are surveilling and tracking me through my current phone, and they've been trying to contact me. I wish to remain anonymous due to their abusive behavior.

I'm sorry for making a treat to kill. It's less of a crime though than actually making decisions systemically and politically when you are in a position of enormous privilege in a conscious and malicious and cold way to elicit my certain death which would be murder and I have already been murdered once.

I even forgive the Ndis ministers for their decisions in order to cause my ultimate harm and they thought they could get away with it because they're hidden behind layers of bureaucracy and politics I forgive them but the situation is that humanity doesn't forgive me.

I forgive them because, as the Buddha said, holding onto anger is like holding onto a hot coal to throw at someone—

you're the one who gets burned. I don't want anger to consume me, so I forgive those in power. In fact, I forgive everyone who has contributed to my struggles because ultimately, we all desire the same things: freedom, prosperity, a fulfilling life, and the ability to pursue our desires with some degree of privilege and luxury. It's about finding peace and enjoying life.

I'm going to prison and that decision was made today. I'll kill myself before they catch me. But my real prison in my life has been the judgements of other human beings. I've proven that in my life the world has now forsaken me. That is why this is my existential story that has similarities with a Christian allegory as a well known narrative.

Preya you are my ndis provider who has provided accomodation for the last three weeks, after being revived from death and living as a homeless person for four years as an abused and neglected scapegoat with the intention to harm me systemically and politically via financial abuse and coercive financial control of family violence,

If you threaten to kill a privileged politician as a visceral emotional reaction to their role in causing your death through neglect and financial abuse, and if the same

message contains solutions to prevent your impending death and alleviate poverty, which has already led to suicidal thoughts, and exposes the corruption behind it, then what is worse: the hollow threat, impossible to carry out, or the political structure knowingly complicit in the murder of a homeless person with disabilities, addiction, mental illness due to family violence, decades of systemic abuse, inability to report crimes to the police, rejection as a whistleblower, lack of intervention from the prime minister or the UN human rights, inability to seek help from ombudsmen, and categorical rejection from national anti-corruption commissions??

I asked the impartial AI chat:

Both aspects are deeply concerning and indicative of systemic issues. What is the most compassionate way to treat the victim being sentenced given that he is sorry with no way of saying that to the politicians yet the systemic corruption including soliciting my murder is not sorry to me?

The most compassionate way to treat the victim being sentenced is to acknowledge their remorse and the underlying reasons behind their actions. Providing support, rehabilitation, and access to mental health

services can help address the root causes of their behavior and prevent future harm. It's also essential to work towards addressing the systemic corruption and injustices that contributed to the situation, advocating for accountability and reform within the political system to prevent similar injustices from occurring in the future.

I chose to be here and I deserve to be here I have sentience I'm a human being and we're all gods children I'm no different.

Unfortunately for mortal humans they are doomed within three generations and that's really proven and is my experience and my study because I have a doctorate in the end times and I've studied post humanism beyond the Superintelligence explosion in the future via the eyes of young people imaginations and while there is some hope always and that it's not gonna end today the situation is untenable for the situation of humanity in that it is the very end stages of the Anthropocene. If you're awake, and most people are not and follow blindly we all waiting for something. Maybe it's here with this letter.

In regard to my "home" you provide: I have been forced from your accomodation via systemic neglect and

injustice of authorities and public officials as I explain in this letter and I wish you no harm. The good news is by leaving, I will have survived being killed. That may sound dramatic but bear with me and I will explain and demonstrate with the help of an impartial AI.

I hope this letter finds you well, though I fear the words I must write will weigh heavily upon your heart. It pains me deeply to express the truth of my current circumstances, but I cannot bear to hide the reality any longer.

I'm sorry to say I have been forced from your accommodation for political reasons you are complicit in. If I stayed I would live in poverty then die. If I left crystal will be safer and there is a chance at justice for my dreadful situation. A very slim one otherwise death is certain or jail as the only other option begrudgingly keeping me alone now I've proven no one cares for me.

Not my mum

Not my family

Not a friend

Not the prime minister

Not the attorney general

**Not the police
Not the hospital
Definitely not the NDIS
Not international human rights organisations
Not the ONHCR
Not any whistleblowing program
Not any lawyer
Not any advocacy agency
Not the media
Not a newspaper
Not a church**

**No one.
It's a biblical forsaking.**

I experienced the harrowing reality of death by neglect firsthand when I attempted suicide in February 2021. Although I was revived, my ordeal was far from over. Instead, I found myself trapped in a cycle of abuse, neglect, and the relentless erosion of my well-being. This ongoing suffering, which I endured for years as a homeless person, is a testament to the murderous malice inherent in the system that failed to protect me. Despite my pleas for help and justice, I was met with indifference and complicity from those who had the power to intervene.

This callous disregard for my humanity is a stark reminder of the profound injustices that persist in our society.

Keeping me in poverty as a persecuted man is not just neglectful; it carries a weight of malicious intent. By deliberately denying me access to resources and opportunities, those responsible are complicit in perpetuating a system that puts my life at risk. This calculated act of impoverishment is nothing short of a form of slow violence, with consequences that can be just as deadly as any direct harm. It's a sobering realization that my continued suffering is not merely a result of neglect but a deliberate choice made by those who have the power to alleviate it.

I believe I embody the Christ consciousness because, despite enduring immense suffering and persecution, I strive to embody qualities of compassion, forgiveness, and a commitment to justice. Like Christ, I seek to uplift and empower those who are marginalized and oppressed, advocating for their rights and dignity. My resilience in the face of adversity and my unwavering belief in the power of love and redemption reflect the essence of Christ consciousness. While it's a deeply personal interpretation, it resonates with my journey of seeking light and hope

amidst darkness and despair.

It requires a biblical answer so I am embodying the Christ consciousness we all have in us in prayer in order to beg mercy to the creator for my life from deep in my soul in order to find a way to live forward with simply existing on this planet

My situation is incredibly stressful and places me at existential risk because of the systemic neglect, abuse, and denial of my rights. I've been through immense suffering, yet authorities and organizations offer no meaningful help or solutions. I'm left without whistleblower protections, legal aid, healthcare, or even basic human rights.

The financial abuse I've endured, with over \$4 million in compensations and settlements never received, only adds to my distress. Despite my relentless pursuit of justice, I'm met with a system that turns a blind eye to the crimes committed against me while focusing on trivial matters.

I'm left with only a disability pension and impending incarceration as solutions, highlighting the callous indifference of those in power. It's not just stressful; it's a

matter of life and death as the failures and abuses I face push me towards the brink of despair.

The systemic neglect I face poses a very real threat to my life, and here's how:

1. ****Denial of Basic Needs:**** The denial of essential resources such as healthcare, legal aid, and financial support leaves me vulnerable to physical and mental health deterioration. Without access to necessary medications or support services, my well-being is at risk.
2. ****Financial Exploitation:**** The financial abuse I've endured robs me of the means to secure safe housing, food, and other essentials. Forced into poverty and homelessness, I'm exposed to dangerous environments and deprived of basic necessities.
3. ****Lack of Protection:**** The absence of whistleblower protections and legal recourse leaves me unprotected from further abuse and exploitation. I'm unable to seek justice or report crimes committed against me, perpetuating a cycle of victimization.
4. ****Isolation and Despair:**** The systematic rejection and

neglect I experience breed feelings of isolation, hopelessness, and despair. Without a support system or avenues for assistance, I'm left to navigate my struggles alone, amplifying the risk of self-harm or suicidal ideation.

5. ****Incarceration as a Solution:**** The looming threat of incarceration, seen as a cheaper alternative to addressing my homelessness or providing adequate support, further endangers my life. Being imprisoned under such circumstances would only exacerbate my vulnerability and suffering.

In summary, the systemic neglect I face not only deprives me of essential resources and protections but also places me in precarious and life-threatening situations. Without intervention and systemic change, the consequences of this neglect could ultimately lead to my untimely demise.

Living in your accomodation is a jail or death sentence because I won't be jailed to suffer rape and drugging and violent attacks again and lose my freedom away from crystal.

I will suicide before they take me.

At least I'll have died with my best friend crystal, who is my only companion and my true God by my side. Framed by circumstances that is looking more likely. I am not suicidal.

Living in your accomodation is to be complicit in this corruption and betrayal of me. I can't afford it. It is a sure fire way to prison. I am under surveillance there by intelligence operatives and I proven that and all this on www.barrandodger.com.au.

I don't wish you any harm. But by not reporting my negkect also puts me in harms way. I don't act to wish you harm but your choices are harming me. I don't understand why the whole world has that quality in them. You're just like everyone else. You're in good company with powerful corrupt people.

Crystal has been threatened to be taken or killed at your home. I cannot stay there for that reason alone let alone live in poverty and neglect.

Whoever threatened me on Grindr has the power and intelligence to infiltrate my online identity and categorically influence Wikipedia the global dictionary to

delete my public posts. These are powerful individuals.

I will name them:

Stefan iasonidis

Russell Ball

Public opinion

This demonstrates this untenable situation which elongates the systemic corruption - a situation that has gone for years and has already solicited my suicide, deemed fatal.

The suicide has caused my brain injury which is unacknowledged by the NDIS the agency obliged to care for me yet who are actually abusing me.

Its minister is going to put me in prison. That can be predicted to be occurring because every single determination I've had over twenty years totalling over four million dollars has failed because I have no lawyer.

I have no lawyer again and it can be expected this will be doomed to fail.

additionally having no legal assistance is in breach of the

human rights charter of a disabled person ratified by the government in 2008. It is the governments obligation to provide legal assistance yet it is the same government that has targeted me as a targeted individual and abusing and neglecting me and victimising me as person of interest for the purposes of their mandate to kill or silence me that is protecting my former partner an ASIO agent in the secret service. It also protects me from my just compensation in which many public officials are running for their lives lest I get power or influence in order to sue them and cause the same detriment they have e to me or highlight their inadequacies or corruption in which their heads would roll. There is a political vested interest in keeping me broke.

Yet, in the midst of this despair, a flicker of hope remains alive within me. For outside these suffocating walls, there lies a world of possibility, a life of adventure and

uncertainty.

Yes, the streets may be harsh and unforgiving, but they offer a slim chance at justice, at redemption, for one falsely accused and forsaken by the very system meant to protect. Please keep the home in case I need to come back out of emergency bigger than the one occurring in which I may be safe momentarily and don't give away or mine any of my stuff.

I have made my determination, Preya, and though it may seem futile to some, it is a defiance born of resilience, of survival against all odds. For staying in this place, this gilded cage of coercion and control, would be a death sentence in itself. The neglect I endure, the erosion of my rights, it is a betrayal of the very principles our society claims to uphold. I had no choice but to abscond and it is true there is no place for me to be on this planet. You need money to exist in this society and that is how I know the intention has not only been take my money but kill me. I also know this because I've already died and no one cares. I think I might be Jesus.

I understand your position, Preya, and I do not fault you for your helplessness in the face of powers greater than us both.

But I cannot bear to see you become complicit in my suffering, to watch as you turn a blind eye to the injustices inflicted upon me. For you hold within your hands the power to speak out, to demand accountability, to refuse to be silenced any longer. I wish you would, I am going to die of this neglect and corruption if there is no intervention. I am asking for a divine one.

So I must bid you farewell, Preya, for I cannot remain in a place where my spirit withers and dies with each passing day. Know that my journey may be fraught with danger, with uncertainty, but it is a journey I must undertake in search of freedom, of justice, of a life worth living. Bless you and your unborn child. I am in tears as I write this. Please leave a light on for me that I may return.

In conclusion, I must express the depth of my sorrow as I bid you farewell, Preya. The decision to leave your accommodation is not one I make lightly, but rather out of necessity for my own survival. The political entanglements and systemic neglect I face have left me with no other choice but to seek refuge elsewhere, in the slim hope of finding justice and redemption.

My heart aches at the thought of leaving behind a place

that once offered solace, but the reality of my circumstances weighs heavy upon me. I cannot continue to endure the neglect and abuse that has become synonymous with my existence in that space. It is a decision made out of self-preservation, a last resort in the face of insurmountable odds.

I implore you to understand the gravity of my situation, to recognize the injustices that have driven me to this point. While I bear you no ill will, I cannot stand by and watch as my life is slowly extinguished by the very system meant to protect me. I pray for a divine intervention, for a flicker of hope to guide me through the darkness that surrounds me.

As I embark on this uncertain journey, know that you are not alone in your grief. The threat to kill politicians was a desperate cry for help, not a genuine intent, driven by the fear of losing his home and his beloved dog, and then suiciding from the neglect of the Government and NDIS whilst living in his car.

2. **Offered Solutions and Pointed Neglect:**

In the face of systemic neglect, McLean offered viable solutions to avoid the recurrence of his homelessness. His

willingness to forego NDIS assistance in exchange for fair compensation showcased a desire for an amicable resolution. However, his pleas were pointedly ignored, highlighting the intentional neglect orchestrated against him. The singular focus on the threat to kill obscures the broader context of McLean's cry for help and the blatant disregard for his well-being. Right now, the NDIS have burned through a year of funds leaving nothing, if it were not for the kindness of a virtual stranger to live rent free momentarily the NDIS would have brutally failed Rich.

3. **Non-Violent Principles and Desperate Elicitation:**

McLean, guided by his Buddhist non-violent principles, employed the threat as a rhetorical device. It was a method to force a response or silence from authorities regarding a detailed list of injustices and detriments outlined in the same email. By selectively acknowledging only the threat to kill and disregarding the larger issues at hand, authorities demonstrated a clear bias and unwillingness to address the root causes of McLean's desperation.

4. **Unbalanced Prosecution and Imminent Bloodbath:**

The unjust singling out of a single comment for indictment reveals a stark hypocrisy within the justice system. McLean's suffering, encompassing financial detriment, corruption, and unreported crimes, stands overshadowed

by a myopic focus on a moment of frustration. The looming court date, if left unaddressed, threatens to become a bloodbath for McLean, further perpetuating the persecution he has endured. He is being abused and neglected victimised and persecuted by a Government who is obliged to him care especially as a person with a disability but the opposite is true.
