Dear Office of Prime Minister & Cabinet,

It is evident The Government or I cannot backtrack from a gridlocked situation in regards to my catastrophic character assassination and exploitation.

I have not meant to break any law except stand up for myself as a marginalised person with a brain injury.

However I have published details of the omissions that contribute to the conspiracy to pervert the course of justice on my whistleblowing website:

www.killhim.info

It is my whistleblowing site, because so far I have been set up to fail for years and taken this through the appropriate channels of complaint, yet I am a failed whistleblower at:

- IBAC
- APRA
- ASIC
- The Commonwealth Ombudsman

I ask you consider the detriment caused to me over the many years of the prejudice and discrimination I have had to deal with which has robbed me via proxy of my prosperity and human worth.

There are serious breaches and omissions of any access to litigation that would have arrived at different outcomes. I have been told by Minister Birmingham these investigations can take years.

Delay Defer Deny is no longer an option for me. I am at great risk.

I offer a simple solution: A basic wage bursary until the level of detriment can be assessed.

Regarding the CDDC scheme for detriment caused, in which this letter and my website asks for consideration, I simply ask the following of the Government:

That framed by the millions of dollars I am rightfully obliged to receive and have suffered the loss of via systemic oppression and neglect and conspiracy, I simply ask I be paid a medium term bursary of an average wage as per Government statistics.

To do otherwise renders me beyond squatting and without medication or safety or my basic needs being met. If no immediate action is taken, it ultimately rejects me to vagrancy and dire risk.

To not act now framed by what has occurred to me is an excursive in victimisation and obliterating me off the Australian map via conspiracy.

The Government is a signatory to The declaration of human rights of disabled persons.

In it it states that:

1. **Definition of the term "disabled person" as "*any person unable to ensure by himself or herself, wholly or partly, the necessities of a normal individual and/or social life, as a result of deficiency, either congenital or not, in his or her physical or mental capabilities*".**

(THIS IS ME)

2. **Assertion that these rights apply to all disabled persons "*without any exception whatsoever and without distinction or discrimination on the basis of race, colour, sex, language, religion, political or other opinions, national or social origin, state of wealth, birth or any other situation applying either to the disabled person himself or herself or to his or her family*".**

(WHY I HAVE BEEN CHARACTER ASSASSINATED IS UNCLEAR)

3. **Right to respect for [human dignity](#).**

(DIGNITY INCLUDES NO DEATH THREATS AT MY DOOR, ACCESS TO HEALTHCARE & MEDICINE & A HOME)

4. **Right to same civil and political rights as other human beings.**

AS A CIVILIAN I DESERVE ACCESS TO POLICE AND TO COMPLAIN WITHOUT PREJUDICE)

5. **Right to measures designed to enable [self-reliance](#).**

(I HAVE SURVIVED AN UPHILL BATTLE MY WHOLE LIFE YET NOW I AM FACED WITH CHARACTER ASSASSINATION THAT ROBBS ME OF JUSTICE AND MY RIGHTFUL PROSPERITY)

6. **Right to medical, psychological and functional treatment as necessary.**

(SINCE MY 'FATAL' SUICIDE ATTEMPT THE RESULT OF OPPRESSION AND BEING SET UP TO FAIL AIDING AND ABETTING MY DEATH, I BARELY HAVE HEALTHCARE OR SEEN A SINGLE PSYCHOLOGIST IN A WHOLE YEAR AFTER BEING DUMPED FROM THE HOSPITAL, THEN REJECTED FROM A LOCAL AREA COORDINATOR WITH NDIS, REJECTED 42 INVOICES, CONDONED TO VAGRANCY FROM NDIA MINISTER REYNOLDS & HEALTH MINISTER GREG HUNT & FINANCE MINISTER BIRMINGHAM & ALL POLICE. I KNOW I HAVE THOUGHT DISORDER & MEMORY PROBLEMS FROM BEING

ACCIDENTY FOUND WITH NO OBSERVABLE PULSE. I DESERVE AN INTERVENTION WITH A NEUROLOGIST AND NON BIASED HEALTH PROFESSIONALS.

7. **Right to economic and social security, including the right to [employment](#).**

MY EMPLOYMENT WAS INTERRUPTED WHEN I DEFINITELY KNEW MY WORK WAS RENDERED ILLEGITIMATE. I WAS COMPLETING A STAT DEC STATEMENT FIR MYB TWO YEARS LONG CLIENT WITH CHILD RAPE/INCEST ISSUES.

I WAS REJECTED MY TWO VOCAT CASES.

1) I LOST MY CASE AFTER I WAS HOSPITALISED WITH BROKEN BONES AND WOUNDS REQUIRING STITCHES AND I WAS KICKED IN THE HEAD UNTIL I WAS UNCONSCIOUS. DESPIT THERE BEING VIDEO FOOTAGE OIF THE INCIDENT CLEARLY SHOWING THAT I INTERVENED TO PROTECT A MEMBER OF THE PUBLIC AND COME TO HIS AID - I WAS IDENTIFIED AS THE PRINCIPAL AGGRESSOR

2) WHILST COMPLETING MY PHD I WROTE ABOUT TROUBLING MEMORIES OF MY OWN CHILD SEXUAL ABUSE. WHERE I WAS THE VICTIM. UNKNOWN TO ME I HAD BEEN FRAMED AS AN EXTORTIONIST BY A GPS LAWYER. I THIBK THAT IS THE REASON THAT IT TOOK THREE YEARS FOR WWW/YOURLAWYER.COM.AU TO PRESENT IT TO GEELONG MAGISTRATES COURT WHERE IT WAS THROWN OUT BUT I RECEIVED ZERO TANGIBLE RESULT.

I BEGGED THE MAGISTRATE FOR A RECORDING TO PROVE IT EVEN HAPPENED, AND SHE WROTE TO ME SAYIONG I WAS 'DOOMED TO FAIL FROM THE START'

AFTER IT WAS TOO LATE TO APPEAL, THE CD ROM ARRIVED IN THE MAIL. THE CLIENT WAS DIFFICULT AND ABUSIVE AND I AM HOUNDED BY HIM TO THIS DAY. I PUT CONDITIONS IN PLACE SO I WAS NEVER AT RISK.

IT WAS THEN BECAUSE OF THE MOVEMENT TO DISCREDIT ME AND MAIM ME IN ALL WAYS BROADER THAN MY JOB AS A THERAPEUTIC SUPPORT I TOOK A BREAK EXPECTING MY INCOME PROTECTION TO COMMENCE

10. Right to have consideration of special needs at all stages of economic and social planning.

MY NEEDS HAVE NOT BEEN MET AT RECENT NDIS PLANNING. I NOW HAVE AN ACQUIRED BRAIN INJURY AND A CASE BEFORE THE AAT UNACKNOWLEDGED. I REQUIRE ACCESS TO LITIGATION, OR, LIKE MY PREDICTION WITH AFCA OF LOSING OVER A MILION DOLLARS BECAUSE I WAS BLACK MAILED, I WILL LOSE THIS TOO.

12. Right to live with their families or with foster parents and to participate in all social, creative or recreational activities.

14. Right to protection against exploitation, discrimination, and abuse.

I HAVE BEEN THE UNWITTING CENTRE OF A MALICIOUS CONSPIRACY TO DESTROY ME ESPECIALLY VIA PROXY FROM AGENCIES CORRUPTED TO THE DEFLECTION OF MY PROSPERITY AND PROPERTY.

15. **Right to qualified legal aid.**

IN ALL THESE DECADES I HAVE NEVER HAD ACCESS TO AN UNBIASED LAWYER WHICH CONTRAVENES WHAT THE GOVERNMENT IS A SIGNATORY FOR

ALL THE ORGANISATION I HAVE DEALT WITH ARE UNDER THE CORRUPOT AUSPICE TO DELAY DEFER AND DENY MY JUSTICE INCLUDING NO ACCESS TO A LAWYER AND SILENCING MY EVIDENCE

17. **Right to be fully informed of the rights proclaimed in the Declaratio**

I HAD NEVER BEENB INFORMED

To prove a conspiracy to pervert the course of justice I must prove

To find a person guilty of this offence the prosecution must prove each of the following matters **beyond a reasonable doubt:**

- That the accused did an act or made an omission;
- That they did so intent to pervert the course of justice.

As a person(s) of public authority under Charter of Human Rights and Responsibilities Act 2006, that the Government is a signatory to:

Public authorities must abide by legislation and certain responsibilities:

The many people whom have acted in unison to deny me justice and rob me of millions of dollars in detriment, even massively contributing to my suicide attempt that has left me maimed, a public official have not adhered to their obligations.

Charter of Human Rights and Responsibilities Act 2006 **Authorised Version No. 014**

No. 43 of 2006

Authorised Version incorporating amendments as at 6 April 2020

4 What is a public authority?

(1) For the purposes of this Charter a public authority is—

(a) a public official within the meaning of the Public Administration Act 2004; or

A public official under the Public Administration Act 2004 includes employees of the public service,

including the Head of a government department or an Administrative Office (such as the Secretary to the Department of Justice or the Chairman of the Environment Protection Authority) and the Victorian Public Sector Commissioner. It also includes the directors and staff of certain public entities, court staff, parliamentary officers and holders of certain statutory or prerogative offices.

- ***8 Recognition and equality before the law***

- (1) *Every person has the right to recognition as a person before the law.*
- (2) *Every person has the right to enjoy his or her human rights without discrimination.*
- (3) *Every person is equal before the law and is entitled to the equal protection of the law without discrimination and has the right to equal and effective protection against discrimination.*

- *9 Right to life*

- *Every person has the right to life and has the right not to be arbitrarily deprived of life.*

- *10 Protection from torture and cruel, inhuman or degrading treatment*
A person must not be—

- (a) *subjected to torture; or*
- (b) *treated or punished in a cruel, inhuman or degrading way*

- *13 Privacy and reputation*

A person has the right—

- (a) *not to have his or her privacy, family, home or correspondence unlawfully or arbitrarily interfered with; and*
- (b) *not to have his or her reputation unlawfully attacked.*

- *15 Freedom of expression*

- (1) *Every person has the right to hold an opinion without interference.*

- *(2) Every person has the right to freedom of expression which includes the freedom to seek, receive and impart information and ideas of all kinds, whether within or outside Victoria and whether—

(a) orally; or
(b) in writing; or
(c) in print; or
(d) by way of art; or
(e) in another medium chosen by him or her.*
- *20 Property rights

A person must not be deprived of his or her property other than in accordance with law.*

In regards to this I have been whitewashed by the law, I have not even had a lawyer with is a result of conspiracy and omission, I have been discriminated against, I have had no rights against discrimination or access to the law, my ability to remain alive was destroyed by this movement which aided and abetted by suicide, deemed 'lethal' by hospital FOI, I was arbitrarily deprived of dignity and human value which cased my suicide, this whole decades long vilification

victimisation & conspiracy has left me confused, homeless, and literally been systemic wide torture that has rendered me an innocuous refugee in a country with citizens rights as a political prisoner, it has been cruel and inhumane and degrading to treat me this way, my reputation had been destroyed; all my family and friends are gone, my computer is hacked, I have no access to privacy, with thugs coming into my home threatening me, and in addition threatening figures hurling abuse and death threats at my window, my correspondence has not only been intercepted, but maliciously destroyed, I am free to express this letter in a public way in order to avoid certain progressing detriment, torture, robbing of prosperity, no access to litigation, medication, care or treated with any dignity or human value, I reserve the right to this opinion which is revealed as fact, finally I deserve what property and prosperity was rejected to

me via conspiracy and oppression to be recuperated via the CDDC scheme of detriment.

In regard to the AAT and the Governor General Michael Cash, I have already written to her and demanded there be an interjection personally from her to disrupt the case at the AAT in which

1. I am not represented as required by law
2. I have fought for over a year
3. I have refused again and again to participate in as I don't understand the reasons why I am rejected my workcover

Furthermore, I have lost now from agencies under her portfolio, (without any representation)

AHRC: \$1000000 or more from a discrimination case with a super company

Comcare: Paul Fowler was the person that denied me my work cover. Work Safe in Victoria Kept saying to go to Comcare (I had not heard of it), and refused to help in my reconsideration and appeal at Comcare. Work Safe also refused to help me with anything - as it turns out Paul Fowler is the old boss there at Work Safe, and also a lawyer.

This is corruption pure and simple. Can I report to authorities? No I cant. I have now been blocked by the Governments security company to email or call Paul Fowler.

They denied delayed and deferred my case all the while setting me up to fail.

Their emails have disappeared off my computer and they refuse to acknowledge one simple fact:

They rejected me under the reason for 'depressive disorder and anxiety state' (both are utterly untrue), and that I am not an

employee under a section of the SRC act to cover me for my work with the NDIS/A.

It clearly states on the NDIA Quality and Safeguard Commissions Website:

‘Who is a worker?

Under the NDIS Commission, a worker is anyone who is employed or otherwise engaged to provide NDIS supports and services to people with disability. Workers can be paid or unpaid, and can be people who are self-employed, employees, contractors, consultants, and volunteers.’

I do not see what is so hard about this.

AFCA: Both before and after my hospitalisation, where my tragic suicide attempt occurred, AFCA knew of my financial distress from 2019.

I know this because I begged them to come to determinations so I could be eased financially.

Instead, despite being under legislation they have to determine a vulnerable persons issue within 4 weeks, mine took over two years.

AFCA blackmailed me that I was not to contact them, or my cases would be dropped.

They dropped them anyway, and I lost potentially 1- over 2 million dollars in just legal and solid determinations.

This is detriment and conspiracy to pervert the course of justice.

Tim Gos and Peter Fisher were the culprits there. You can hear their smug voices because I record my calls as is my right under the surveillance act in Vic 1999.

They are aware that as public officials they have to act with equity and fairness and within the charter of human rights. They are aware they were destroying me and I had no agency for police litigation or complaint.

However I was delayed deferred and denied, the reason?

I threatened to name staff who were complicit in the movement to destroy me, which by now is clear exists.

I am also rejected at The Commonwealth Ombudsman, also under her portfolio.

WHEN I lose this case due to corruption in a short time like I predicted the AFCA loss, and every thing else that was detriment under her portfolio, I would appeal at the Commonwealth Ombudsman.

However, that does not seem a likely point of appealing does it, considering I cannot report rape, murder, conspiracy to murder, drug trafficking conspiracy, slander, surgery, perverting the course

of justice, tax fraud, sexual and financial coercion, corrupt magistrates, or anything else to police or gain access to any lawyer and still be rejected as demonstrated in this video I took out of pure desperation to prove my point that I am being systemically oppressed and set up to fail:

Michael cash will not intervene and in doing so she is complicit in the conspiracy.

So is NDIS/A Minister reynolds, and so is Federal health Minister Greg Hunt and many others.

This is what detriment is.

My wish is that no one be charged and I need not take this to the federal circuit court, (also under the attorney generals portfolio),

Everyone is exonerated I am safe and cared for with the shreds of my dignity and my worth, and I can move on safely away from threats of vagrancy or oppression or homelessness.

I want to give back to the community like I have always done so...to the best of my ability

The appointed members at AAT are actually appointed by the Governor General and furthermore she has the agency to intervene in any case:

RE: Administrative Appeals Tribunal Act 1975

Division 2—Members of Tribunal

6 Appointment of members of Tribunal

- (1) The members shall be appointed by the Governor-General.
- (2) A Judge who is to be appointed as a member of the Tribunal is to be appointed as the President or a Deputy President.

I thought it interesting the AAT must consult Minister Reynolds - so I cannot appeal the sponsorship of my vagrancy anywhere:

17E Assignment to National Disability Insurance Scheme Division

- (1) Before assigning a member to the National Disability Insurance Scheme Division, the Minister must consult the Minister administering the *National Disability Insurance Scheme Act 2013* in relation to the proposed assignment.
- (2) The Minister must not assign a member to the National Disability Insurance Scheme Division unless the Minister is satisfied that the member:
 - (a) has training, knowledge or experience relating to disability; or
 - (b) has other relevant knowledge or experience that will assist the member in considering matters relating to the National Disability Insurance Scheme.

The attorney General Could have intervened in my case:

30A Intervention by Attorney-General

- (1AA) This section does not apply to a proceeding in the Security Division to which section 39A applies.
- (1) The Attorney-General may, on behalf of the Commonwealth, intervene in a proceeding before the Tribunal.
- (2) Where the Attorney-General intervenes under subsection (1) in a proceeding for a review of a decision, the Attorney-General

may authorize the payment to a party to the proceeding by the Commonwealth of such costs as he or she considers were reasonably incurred by that party in relation to the proceeding as a result of that intervention.

But she chose to be resonant with my distress detriment and setting me up to fail, and did not acknowledge the corruption of what I had mention explicitly to her and the detriment it cause me

Additionally there is a dispute resolution process; yet this has never been offered

34A Referral for alternative dispute resolution process

- (1) If an application is made to the Tribunal, the President may direct that the proceeding, or any part of it or matter arising out of the proceeding, be referred to an alternative dispute resolution process.
- (2) The President may give written directions in relation to persons who are to conduct an alternative dispute resolution process. Any such person must be:
 - (a) a member; or
 - (b) an officer of the Tribunal; or
 - (c) a person engaged under section 34H.
- (3) The parties to a proceeding referred to an alternative dispute resolution process must act in good faith in relation to the conduct of the alternative dispute resolution process.

Under section 69:

69 Legal assistance

- (1) A person who:
 - (a) has made, or proposes to make, an application to the Tribunal for a review of a decision;
 - (b) is a party to a proceeding before the Tribunal instituted by another person; or

(c) proposes to institute a proceeding, or is a party to a proceeding instituted, before a court in respect of a matter arising under this Act;

may apply to the Attorney-General for the provision of assistance under this section in respect of the proceeding.

(2) Where an application is made by a person under subsection (1), the Attorney-General may, if he or she is satisfied that it would involve hardship to that person to refuse the application and that, in all the circumstances, it is reasonable that the application should be granted, authorize the provision by the Commonwealth to that person, either unconditionally or subject to such conditions as the Attorney-General determines, of such legal or financial assistance in relation to the proceeding as the Attorney-General determines.

the attorney general clearly knows about my detriment and has not offered me any intervention with a lawyer as framed by a marginalised already scapegoated and victimised person.

I request my atonement from the Government be made immediately.

I have not the concentration to go on.

I sign off my saying:

I wish to make a truce.

i want access to the law but no one goes to jail.

i am a simple person and I have never meant anyone harm, I am just here to defend what dignity exists in me despite years of oppression and being now homeless.

Unless you intervene now, The movements wish to kill me will be in the public domain.

This would be highly regretful of course for all.

I wish to ask for whistleblower protections and the right of appeal.

i am still uncertain why this is happening to me.,

Suffice to say my former partner worked for ASIO and threatened to ruin my life.

Also my 2002 autobiography that I was publicly vilified and awarded for.

Also, I am easily prejudiced by being non heater normative, that I have used drugs in the past, or i have a 'mental illness;'

I wish for your urgent attention and intervention.
