Dear MHLC,

i have an extraordinary tale to tell, as outlines in the attached email.

The original complaint was because even though I told a GP how I would kill myself and was suicidal - he did not intervene.

In fact, he gave me the fatal dose in which i overdosed in August 2018.

AHPRA rejected my claim because it was based on a recording of the consultation.

I did not record it out of malice - I thought AI was going crazy.

His lawyer told AHPRA not to listen to the recording.

AHPRA told me I could submit a transcript, however his lawyer wrote all over it and recommended it not be used.

I have attached an email with a long list of trouble in getting justice.

I have been silenced - and they hope I die, quite simply.

I overdosed again recently after fighting this by myself for 2 1/2 years.

Ive been to AHPRA, NHPOPC, the Police, IBAC, Human [Rights.gov.au](https://www.humanrights.gov.au) - where extraordinarily they have refused to acknowledge me and are trying to escape the fact that if the GP did nothing wrong he would have listened to the recording to exonerate himself and this has not happened.

I understand though it is not an offence in Victoria to record something if your life depends on it, or it is for your human rights or self preservation.

Now I have been threatened to be sued by NHPOPC.

Even Greg Hunt the Federal Minister had knowledge of the recording and gaslighted me - sending me back to AHPRA

I have evidence that AHPRA based my complaint on nothing.

not the recording NOR the translation.

The human rights people told me they would not represent me.

It is now being investigated by the ombudsman

I cant believe no one cares for me.

I have summarised it here:

'I am the victim of a conspiracy, and have been stigmatised and rejected because I have a mental illness and a suicide survivor.

It is because I made a complaint exposing medical malpractice and professional negligence.

In a nutshell-a GP I had seen for years was my only contact and confidant. I saw him, and to 'reality check' I was not going mad-I recorded it.

I did not do it out of malice.

The recording shows that I told him ways I would kill myself-he was derogatory and dismissive and offered no help. If that were not bad enough, he gave me a fatal dose of opioids which then a few weeks later I overdosed on, attempting to take my life.

After I recovered, I found the recording and i would have been happy with an apology- however, because I am so used to being abused, I nearly accepted it when they rejected me. I decided to fight on and it has been over two years now.

I cant describe how little I have, the shell of the person I used to be. I have just passed my PhD pending changes-but I have nothing, am squatting, only have a computer and a car, (and my dog), and all these organisations and institutions are gaslighting and ignoring me and I am certain there is a conspiracy in which the recording is being silenced and they will feel less burden, (and also less expensive lest I sue every institution), if I die.

In brief:

1) an injustice occurred I recorded-that recording, even though in the public domain, has never been authenticated in a complaint, nor a transcription when it went to AHPRA. Simply- if the GP had done nothing wrong he would welcome the recording to exonerate himself. Simple.

1.1) I tried to kill myself with medication a GP gave me when I explicitly said I would kill myself-this was recorded and transcribed for a complaint to AHPRA.

1.2) I complained to AHPRA and over months - the recording was not validated nor my transcription because he had high profile lawyers who silenced it-hence my complaint was based on nothing.

2.2) AHPRA admitted 'marking up' the evidence - in their 'report' to me on the case. This is corruption, and edits a grade proof to every the course of justice.

2.3) I have evidence it was silenced from FOI in the lawyers remarks to AHPRA and in addition when they invited me in for the result they told me in person that the recording and the transcription were not taken into account.

3.1) I complained to NHPOPC about AHPRA and they said, despite my evidence AHPRA concealed censored and rejected evidence, they found no wrongdoing, even though the recording was public by this stage on my website at www.richmclean.com.au/justice

4.1) I complained to the Footscray police who said they would investigate after hearing the recording, and despite my evidence AHPRA corrupted the evidence, and NHPOPC sided with them, they said AHPRA investigated it thoroughly and would not be further involved.

4.2) I have recordings from an un-named policewoman at the Maribyrnong Criminal Investigations Unit saying they would never call me back, we are going around in circles and terminated the call.

4.3) I complained to IBAC (who investigate the police), about how they left a suicide survivor feeling hopeless, and covered up evidence, left telephone calls and emails unanswered.

feeling hopeless, and covered up evidence, left telephone calls and emails unanswered when they knew a suicide survivor was in distress. No one asked of my welfare-I was prejudiced against, gaslighted and burdened.

5.1) IBAC said the police acted accordingly and no action was taken. I felt invisible. I had a public document that I wanted valued by someone - even the police heard it - but despite this - and despite my evidence I can provide that the complaint was based on nothing and evidence tampered with, I was rejected yet by another institution.

‘ 6.1) I wrote to Greg Hunt and despite him witnessing the entirety of the evidence which I had posted on www.richmclean.com.au/justice and knowing I had gone to AHPRA and NHPOPC and the Police and IBAC - he referred me back to them.

6.2) I have been to the health minister of the land, and he gaslighted and rejected me. he has not returned my emails about the evidence I have - and whoever is pulling the strings is doing so from a high place.

6.3) he refuses to acknowledge any more emails, and will not respond to any calls.

7.1) This has taken over two years of my recording not being validated, or listened to, even though the police agreed to investigate it and it was silenced.

8.1) I made an additional complaint to AHPRA, (without the recording this time), and I mentioned that my former partner worked for ASIO, and david Irvine was his boss. This toxic narcissist personality type left me homeless and with his dying dog-and swore he would ruin my life.

8.2) This person admitted to being present at a murder, amongst other things, and in the relationship twisted my mind so much that I thought this was ok. he gaslighted me and drove me crazy. he lost 1.2 million dollars in a tax haven investment, that because he worked for ASIO - got off. To this day I pleaded with him to separate amicably-because I had spent my TPD payout in the relationship and he had over a million in super. However-I was on the pension at the time. We were engaged but marriage was not legal-yet relationships should have been declared - which i did - however he told me to say we had broken up and go on the pension because he could not afford us both. he was a monster, a crook, and an accomplice to murder. He told me if I went for his fair amount of super - then he would dob me into centrelink - and I would be jailed. I was powerless against his criminal mastermind.

9.1) The second complaint to AHPRA - they refuse to acknowledge that complaint and actively avoid me to silence me and the evidence. I cant believe it. I have a recording saying that they cant confirm nor deny they will ever get back to me.

10.1) I made a complaint to VCAT and legal places and others, including the Victorian Inspectorate, and The Human Rights Commission - who remarkably said they can only investigate Government bodies.

10.2) I cant believe it. Whoever is pulling the strings is doing a great job at silencing me and devaluing and dehumanising me.

11.1) I was violently assaulted in Footscray a few years ago - and i wondered why VOCAT said that I was the main aggressor-when I was defending the defenceless. I was hospitalised and suffer PTSD. I wanted everything the police had on me-so I got an FOI-and not only did they not provide the video that would have cleared me of wrongdoing, there are reports of burglaries and car thefts on my file which have nothing to do with me-as if someone has planted that there.

12.1) I made another complaint to The Human Rights Commission and the Victoria Inspectorate. They are stalling.

13.1) on another note during my PhD I realised I had been sexually abused as a child. I performed a speech about it at the State Library and wrote an article. When the pell stuff came up on TV it triggered me and I acted. It has been over two whole years and my lawyer cannot confirm if they will ever get back to me - only saying that they will contact me once they are contacted. I wonder - as my own family flesh and blood did - that they think I am insane and not to acknowledge me? My own mother said ‘I probably caught him with a dirty magazine.’ I am waiting for justice-and I am rationally paranoid it will never come because of this blight that is seemingly invisibly attached to my name and person.

I have said many times to them I will survive and get justice: The GP now I am ‘post-death’.

The suicide note I will attach below, as I lay dying, angrily mentioned him and my psychologist - a psychologist that refused to see me because I had no money, unethical in itself.

However, this gaslighting and disempowerment, via and from all these institutions, has driven me crazy. I am rationally paranoid - and rightly so-that there is a conspiracy to hurt me, devalue me and censor me.

I have all of the evidence in the form of many recordings and documents, and i continue with the email(s) below if you will indulge me reading them.

My last stop-the Human Rights Commission - told me they cant help because they do not deal with my issue.

i am agasp.

Where is the issue with a suicide survivor who told a GP he would kill himself, then followed through with it, suffering survivors guilt, and trying in his most able moments to challenge the system which favours those with money lawyers power and privilege - when they say they can only investigate corporate bodies?

These are all corporate bodies.

A person who is NOT vulnerable to stressors, as well as finishing a PhD - would be stressed by this.

i feel like I don't even know I exist. I need help. This is where I published the evidences so far: NHPOPC told me to take it down - or I will be sued. I cant believe it. I have only debt and a computer, and squatting.

Human Rights people, I am awaiting to hear your justification for ignoring me.

Am I better off dead to you?

Thats not much of a human right now, is it?

Dear Mr McLean,

I have informed you that the *Freedom Of Information Act 1982* does not apply to the NHPOPC and therefore we are not obligated release the information you are requesting.

How do I know that? Please advise how someone with a disability is supposed to navigate that legally?

I have also informed you that your complaint was assessed under the *Ombudsman Act 1976*.

Can you if you refer to things, provide a copy of it at least? Thanks

Under section 6 of the Ombudsman Act, I decided not to investigate your complaint further upon considering all the information provided to me by Ahpra and yourself.

I believe I did not get a copy of that information.

I also know that - the recording not my transcription was not valued. Or otherwise - it was - but only to the degree of 'don't include it'.

I have provided evidence from AHPRA in the form of an FOI

I think it was one sided that he had a lawyer, and I didn't - don't you?

According to my new knowledge - it is not illegal to record something if it has to do with your human rights.

Can you comment on this?

I informed you that I was satisfied that it was reasonably open to the Board to conclude that Dr Whitaker's performance in this instance was not inappropriate,

I still don't understand. I told him how I would kill myself and he not only did not act on it but gave me the means.

Preya, am I insane?

and that he does not pose a risk to public health and safety.

If he did this to you or your child - what would you say?

please answer.

Under section 12 of the Ombudsman Act,

Can you provide this - if you are going to reference things you have a responsibility to provide the framework that my complaint was ruled as innocuous under.

I was required to inform you as soon as practicable of my decision and the reasons for my decision, which I did in my letter to you of 11 July 2020 (**attached**).

You are required to obey the law. the law has been broken. You and a huge conspiracy of people have devalued me and not acknowledged my recording.

I hope that I have clarified our position.

No it does not. You need to provide me with the documents.

I'll await this next stage!

Our office is unable to assist with seeking out legal representation for you.

I said in my last email:

'To expect a person who is differently abled to understand what is clearly legal garb is discrimination based on my disability.'

I think you owe me an apology.

And additionally you owe it to me to :

a) provide the legislation and policy against which you state you are exempt from my requests for information

b) Have a human heart and know that I am a human being - and that I know this does not sit well with your conscience - how can you continue your role when you know a crime with a high probability resulting in death occurred?

c) I may be suicidal again.

I complained to the Human rights commission and I have been battling them.

I folded the other night - this has taken 2 1/2 years - this is my last email to them with their version of the cover up below it:

You won, ok?

The pedophile killed me the narcissist abuser killed me the go killed me
psychiatry killed me the cops ignored me ahpra screwed the evidence NHPOPC
covered it up ibac said the cops did nothing wrong

I've watched friends die I was neglected rejected ostracised and non included

Now you like Greg Hunt have no value for human life and you will have to wear it

I'd like to say I have worth

I'd like to say you are responsible along with all the people psychologists who didn't care doctors who gave me fatal overdoses family who didn't believe me and prejudice me

Media that use and pathologised
Me

You can all suck my fat gay mad doctoral cock in my death

You will never find me

You're all sinful

I am proud of what I did in this life you fucking cunt you're the human rights people

I can't believe it but refuse to exist in a resonance that is so one sided and has no love so I'm going home

Dear Richard

I refer to your further email.

The Commission can consider claims of
discrimination, but the alleged unfair treatment

has to be based on a protected ground. These include race, sex, gender identity, sexual orientation, intersex status, pregnancy, marital or relationship status, age or disability.

You make reference to disability. I certainly appreciate the impact that this has had on you. However, there does not appear to be sufficient information to support an arguable claim that you were treated in the manner claimed **because of** your disability.

We can consider claims about victimisation, but this is where a person is subjected to a detriment because they lodged or sought to lodge a complaint of discrimination or breaches of human rights.

We are really not the most appropriate review body for AHPRA. That is the NHPOPC, which I note you have already contacted. It is our understanding the AHPRA is a state/territory body.

We are also the most appropriate review body for VIC Police. That is the VIC Ombudsman (www.ombudsman.vic.gov.au) or the Independent Broad-based Anti-Corruption Commission (www.ibac.vic.gov.au).

I also need to make it clear, this Commission does not 'advocate' for people. We are an independent complaint handling body.

I appreciate the level of concerns you have raised. Unfortunately, it really does not appear that this Commission can provide you the assistance you are seeking.

Should you have any further queries or wish to provide clarification, please advise by return email.

Dear preya, (CC Human Rights, VCAT and Mental Health Legal Centre),

Preya, I refer to your email below and the extensive legal garb below in your response to my valid (so i thought), request for information, to defend my case of medical malpractice and professional negligence that led to my untimely death (but then I lived).

I have been diagnosed with schizophrenia, schizoaffective disorder, PTSD, Panic Disorder, Manic depression, Depression, and adult ADHD. I have been sexually abused as a child and violently assaulted and survived a toxic relationship with a man who was present at a murder, and invested 1.2 million in an offshore tax haven, but because he worked for ASIO - he got off.

My mental health practitioners knew these things, including Dr Whitaker and Dr MacKinnon.

As for your email below, I am unable to interpret the email you sent me. That's because I am distressed. And most likely crazy(ish).

To expect a person who is differently abled to understand what is clearly legal garb is discrimination based on my disability.

I will expect you all to please respond to my email, with some support, so you preya, in person-or to my advocate, (when I get one), explain to me why you are exempt from my question of collecting information on myself so I can defend my worth.

RE: The original medical malpractice and professional negligence was from Dr John Whitaker, after my psychologist Dr Rob MacKinnon refused to pursue duty of care after I was violently assaulted, suicidal, and realising my childhood sexual abuse.

That recording, of the original complaint-which was never valued by AHPRA in my complaint, nor even though it was discussed that I could provide a transcript, was not authentically considered in my complaint.

Also, I wish to draw to your attention that I have in possession the 'marked up' scribbled on my accurate transcription from dr

marked up corrected on my accurate transcription, from a whitakers lawyer, Mr ball.This is why the complaint had no basis whatsoever.

My complaint had no conceptual framework.

Here it is-scribbled upon with a note saying it is inconsistent and that don't give it value.

Where was my lawyer?

This is inexcusable, and incredibly one-sided:

I was devalued.

Also this process of just being valued over 2 1/2 years has caused me much distress.

No one has asked of my welfare.

As a suicide survivor as the original issue, I thought all the people involved may offer a little more compassion. I am a real person and I don't understand the email you sent me or its legal garb.

here is some of my frustrations which I sent to the entourage of people including MP Greg Hunt and the police, that covered this up:

I expect I will get justice, one way or the other.

Preya just to let you know - I am just getting started.

Human rights and MHLC, I wish for you both to please carefully consider the evidence of my original complaint and the newer complaint detailing how it was Rob MacKinnon rejection that led me to beg for help (that is now with AHPRA - yet they are ignoring me), about Dr Rob MacKinnon rejecting my psychology sessions because I did not have any money.
