

NDIS PID,

I demand whistleblower protections.

Key points for NDIS:

Tony Riddell who works for the NDIS stated that I will be 'sacrificed' ie killed. That evidence is in this email. I collected money from the ndis through fraud of a fake name Steve Iasonidis - who was my former partner who worked for ASIO. I only did it in order to survive because the government are protecting him. The NDIS know about the fraud.

My name emails to the NDIS was intercepted by a local man to me in Footscray who worked for the NDIS who then came over to my house and f&cked me.

I according to the federal court am at risk to my health and welfare but I still was not granted whistleblower protections. Why?

Ashling Kelly yesterday intervened to stop my choice and control choosing of a support coordinator. In doing this she has ruined my chances acquiring accommodation for myself this Thursday 20th April 2023.

I have a clean criminal record. I am not a rapist, nor a pedophile, nor an extortionist. The way I have been treated though you may as well lump me with that though. What IS true is that I was engaged to as ASIO employee Steve Iasonidis. What IS true is that I wrote a human rights awarded autobiography in 'Recovered Not Cured, a journey through schizophrenia' for which I was vilified by the herald Sun and then lost my job at the Age. It began a life of further victimisation and oppression to which I am opposing in this letter.

Brief points:

- I've never had a lawyer to take my issues to task
- I've been banned at AFCA losing over 2 million dollars
- I was rejected at AHRC losing my TPD insurance and income protection
- I cannot go to police
- I am a rejected whistleblower
- I have a public profile for which I am vilified
- I have been violently attacked and hospitalised
- The Victoria police literally ran me out of town with the mental health act
- From there I was run over by a car
- I have recorded agents surveilling my house
- Ive been hospitalised where I suicided with zero recourse
- Now suffer a brain impairment plus suffering schizophrenia
- My home was destroyed and all its contents overseen by the hospital and police supposedly caring for me
- I was rendered homeless without any support or help
- My former partner owes me a settlement - but he worked for ASIO and the Government protect him
- I have failed not one but two work cover cases
- I have been rejected my income assist from HCF
- My own child sexual abuse case was cited by a VOCAT Magistrate as 'doomed to fail'

- I had a valid malpractice complaint and its evidence was silenced by Russell Ball at HCC,MHCC, The Police, the Victorian Inspectorate, AHPRA and NHPOPC up to and including the commonwealth ombudsman - who he informs.

My belief statement is that it will get better because the opposite of that will be my death via a violence of neglect so lets get this out of the way and do better that I may do better! Without employing any bathos or attempting to be dramatic: my journey has been difficult. Ive been toyed with as a kid, rejected, ostracised, taken advantage of, discriminated against, vilified, set up to fail, violently beaten up and hospitalised, been beaten up inside a hospital, mowed down in the street by I suspect the police, run out of town by police from my home, sexually assaulted, drugged, rejected legal help, fired, had every single thing I own destroyed overseen by police and the hospital supposedly caring for me.

I've tried to kill myself because of the years long abuse; it was a success and I was found by accident and revived from death inside Weribee Mercy hospital in Feb 2021. Right now on 10/08/2023 two days after a fiftieth birthday I spent alone without enough food or medicine I'm right at the end of my fuse to continue living a life with so little in poverty with no equity or equality. Despite this difficult life of clearly being exploited (I am neither stupid nor delusional and I have a PhD), I have worked hard in my life with an honest heart. I have advocated for the mentally ill and their carers for over thirty years - and I simply wish to live so I can serve with my knowledge again.

This is despite being clearly exploited for identifying with 'illness' in prejudice discrimination and a shame that is not mine to embody. Can you indulge this letter in advocacy for me continuing to live? I promise I am worth it. Beyond a simple life I have created a trust fund to channel any of potential prosperity into gifting meaningful experiences to the marginalised and the powerless and the voiceless. I still believe its not enough to ignore tyranny and fascism - we are required to embody anti fascism in our hearts and minds and in our lives with education and heartfelt honesty.

My nemesis (as will be explained) is the Australian Government I draw on your sense of equity equality and fairness as politicians within the Government to call out corruption and bullying that appeals to your sense of democracy as a reason you are in your role. This will allow me again to live and give because if nothing is done I will die. It only takes one politician out of all of you - who will stand with me to make this Australian culture a better place?

I write today to share my evidence - in doing so informing you of and oppose the continuation of my poverty, victimisation and oppression in which it seems nothing can be done even by the ombudsman, the attorney general, the office of prime minister and cabinet, the CDDC scheme, The Police, any lawyer or advocate or by submitting a PID. I have now - in my tireless self advocacy in which I have not had a choice - proven a conspiracy to pervert the course of justice. This was confirmed with an acknowledgement of perverting the course of justice and also of misadministration and a final alarming current threat to my life and liberty from the high court. I have included that damning evidence in this email. It is not permissible that the Government acknowledge my life's elongated victimisation and then at once detail imminent danger to my life and also refuse to act ethically or it be allowed to continue. As a scapegoat - I have been utterly forsaken. But I love people still and I love the earth, won't you help me be in it and commit to forgiving the human nature of

judgement from my friends family and officials in order to again make a world that's better and brings meaning and love to the most downtrodden?

**It is within your remit as a public official and politician under the public services act to act ethically and within the law. But the law has been broken. If you do not act upon the evidence in this email it will be broken again; and there is a high likelihood I will die as a result of the prolonged financial abuse and collective harm that is maliciously intended for me. A person can't live without money in this society. A person cannot live without the company of other people. A person cannot live without equality before the law and access to it. A conspiracy to pervert the course of justice has and is occurring. I am its unfortunate victim. The federal court admit it. They also declare that I am in imminent danger to my health and safety which I am. They admit disclosable conduct of public officials. They admit maladministration. I am exploited for 'mental illness' but this does not negate that this persecution is real and is happening to me. Victimisation is against the law. My detriment is psychological, financially and non economical ways as well. Not acting to immediately intervene today means you will also break the law. It is now not permissible with the evidence in this email that I suffer any longer. You must intervene dutifully as a politician who is in receipt of this letter from a citizen of this country.**

My problem is that I am easily exploitable - I have mental illness that is known to the public. That's how I am scapegoated. Take a look at The Herald Sun vilifying and humiliating me in 2004: They ran with the headline 'MY DESCENT INTO MADNESS - How schizophrenia stole Richard McLean's mind.' (It must be remembered that I went on to complete a Doctor of Philosophy at Victoria University). After this was published - I lost my job at the Age as a news graphics artist and illustrator. I kept up with my passion for art at [www.simplebooklet.com/richmclean](http://www.simplebooklet.com/richmclean) yet was explored for that too. I went on to work in mental health advocacy for over thirty years. In my work which was fiercely independent, I advocated for the marginalised in a secular fashion and amplified the voices of the voiceless and it was a privilege to serve Australia from Dubbo to Warnambool to Canberra and Parliament House, Melbourne, Sydney, to ABC national, JJJ, RRR, State line, dateline, Good Morning Australia, The Drug debate on SBS, and dozens of other live radio guest speaking appearances. I did dozens more conversations to people in all walks of life at local state and federal and even international levels at High Schools, Universities, Community groups, town Halls, EPPIC, and in and around the public service.

I am heart led but made out to be the bad guy. The truth is that political privilege and money rule - I found out the hard way that my kindness was exploited. It has come to pass that I have been scrutinised, identified, victimised, vilified and abused. Bullying needs to be called out; my nemesis' are Stefan Iasonidis, Russell Ball, Mark Dreyfus, Anthony Albanese, Tim Gos, Liz Lindsberg, Sheena Jack, amongst many many more. Many have neglected to intervene in my now self-advocacy and opposed my comfort my liberties my compensations and they have robbed me blind - intentionally and consciously redacted my prosperity systemically and politically. Its criminal and I have the proof. Its my consensus that the same political structures that elongate my poverty and disadvantage today are the same ones that drove me to suicide and for that reason me being revived from certain death means a conspiracy to murder happened. I can report that 'mental illness' was never the cause and these systems of oppression cleverly exploit my courageous vulnerability of writing my human rights awarded autobiography 'Recovered, Not Cured, a journey through schizophrenia.' (Allen and Unwin, 2002). I am angry that powerful people of political privilege have used that

as leverage to cast me from society from their anonymous positions as public servants CEO's and lawyers and I am further enraged my friends and family have collectively neglected to meaningfully intervene in my destruction or its cover up which holds today.

On 7th March 2023 I made a public interest disclosure to an individual who is able to receive a disclosure in The CEO and Principal Registrar of the Federal Court, Sia Lagos, at email address [sia.lagos@fedcourt.gov.au](mailto:sia.lagos@fedcourt.gov.au). I was opposing what I experience as the systemic and elongated victimisation I have suffered over a long time and the psychometric profiling of me by the government which has led to immeasurable suffering and detriment and financial redaction of any prosperity I may have been entitled to.

Scott Treadwell a representative from Federal Court replied to my PID by acknowledging that I was able to make it and stated he is satisfied I was an employee of DSS. That alone should have decreed that I be paid my work cover because they refused it on account of me not being an 'employee' for the purposes of the SRC act. In my defence I provided my DSS employee login. Because I lost at AHRC and banned at AFCA I predicted my AAT case would fail as it was under the same portfolio of Michaelia Cash who refused to intervene. This attorney general Mark Dreyfus refuses to acknowledge me. On 6th April my case was heard at the AAT and its likely failed.

'A public interest disclosure can only be made by a "public official", paragraph 26(1)(a) PID Act. The meaning of "public official" is defined and includes current or past Australian Public Sector employees; section 69 PID Act. Section 30 of the PID Act extends this meaning to include employees of organisations which provide goods or services under a Commonwealth contract; subsection 30(3) PID Act. As a general principle an organisation which is a party to a contract that prescribes the terms for grant funding is not a contracted service provider for the purposes of the PID Act. On the information you have provided me, I am satisfied that you are, or were, an employee with the Department of Social Services, providing services under the trading name Rich McLean, Arts Life Coach, Peer-Support Worker & Mental Health Advocate.'

At the same time that I'm being harmed by the government the government now finally acknowledges disclosable conduct of public officials as related to me and that harm and imminent danger have happened and is currently happening to me. I submitted a PID to the Federal Court and they have replied without granting me whistleblower status. **But they went so far to admit perversion the course of justice, maladministration and further that I am in danger:**

**I am satisfied, from the correspondence and other information provided, that you believe that the information you have disclosed tends to show one or more instances of conduct that:**

- perverts, or is engaged in for the purpose of perverting, or attempting to pervert, the course of justice; section 29 Item 3(a) PID Act;
- conduct that constitutes maladministration; section 29 Item 4 PID Act; and
- conduct that unreasonably results in a danger to the health or safety of one or more persons; or unreasonably results in, or increases, a risk of danger to the health or safety of one or more persons; section 29 Item 8 PID Act.

Further he says: **'I am prepared to assume that the conduct disclosed in your correspondence and other information received is disclosable conduct for the purposes of the PID Act.'**

I have a clean criminal record but I have experienced being jailed physically and also bound and financially gagged as a political prisoner and a scapegoat and as an individual of interest who has been categorically nuclear character assassinated. If I am collectively scapegoated by every politician who represents my nemesis of The Australian Government then I whole heartedly commit within the next month to 'take a long walk off a short pier' in an act that will be a universal violence of neglect.

In February 2021 I attempted suicide inside Weribee mercy hospital as a result not singularly of mental illness, but of the elongated financial oppression rendering me a vagrant which stemmed from powerful political key stakeholders in individuals that the Government supported. Upon then being revived from certain death after being found accidentally with no observable pulse unresponsive and released weeks later, the clinical notes of which the hospital needed to name to justify incarcerating me say that my 'illness' was 'adjustment disorder'. This is a fancy way of saying a delayed reaction to actual stress - and additionally that there was no evidence of any psychosis nor delusion as my previous diagnosis of schizophrenia would have had anyone incorrectly assume. I was not crazy. The suicide attempt was a proportional reaction to immeasurable harm and factual abuse and financial destruction that was maliciously intended upon me. To this day - that victimisation is still occurring and is still the case. Scott Treadwell continues:

**It is difficult to determine whether this belief is based on reasonable grounds or not. However, for the purposes of the initial assessment I am prepared to assume that the conduct disclosed in your correspondence and other information received is disclosable conduct for the purposes of the PID Act.'**

Correct me if I am wrong but disclosable conduct needs to be acted upon doesn't it?

Regarding whether my belief is based on reasonable grounds or not - here are some examples which back up my belief that harm has and is occurring to me:

1. That this oppression could literally persecute me to death under a duty of care inside a hospital causing brain impairment and there be zero recourse and a cover up, THAT is how harm happens to me.
2. Evidence of my harm came as I was incarcerated then beaten up inside Weribee mercy hospital by an undercover Government thug. THAT is how harm happens to me.
3. The Footscray Police - who I cannot report crime to - kick in the door of my rental/squat. Later, when they incarcerated me in a psychiatric hospital the hospital and the Police oversaw the malicious destruction of every single thing I own and I was rejected to a homeless shelter. THAT is how harm happens to me.
4. Here is a \$50000 win but its by a fraudulent casino. Bendigo Bank acknowledge the fraud but they don't refund me all my money. They say go to AFCA... but I am banned there. THAT is how harm is happening to me.
5. The years long oppression drives me to suicide inside Weribee mercy hospital. It is deemed fatal and I am revived from death - and now there is a cover up at the hospital for compensation into the abandonment of duty of care and the cognitive brain detriment I suffered since that time. To financially oppress me creates enormous suicide risk for me. THAT is how harm is happening to me.

6. Numerous times I won 40, 20 and 50000 in online casinos in an attempt to gain money to live - the casinos were illegitimate and did not pay. Bendigo Bank agreed that they were fraudulent and refunded some of my deposits - but not all. The bank said to go to AFCA to resolve it but as we now know - they were setting me up now as a democratic citizen of the country I am banned there.

Although these issues for a PID were acknowledged, my public interest disclosure was rejected because of this part: 'As I am not satisfied that your disclosure meets the requirement of the PID Act to be an internal disclosure, I must decide (in the language used in section 43 of the PID Act as above) not to allocate the handling of that disclosure to any agency.'

With that, my whistleblower status was not granted and that places me under further financial coercion and the redaction of any prosperity and I live under the poverty line. I still remain at risk by:

- Conspiracy
- Suicide out of desperation
- Character assassination
- Redaction of my prosperity
- Having no legal representation
- No access too the law
- No equality before the law
- Threats of murder
- Financial abuse
- Literally starving
- Becoming homeless again

Today I am emailing every parliamentarian and asking them to intervene in this situation in a way which quantifies the responsibilities of public officials and parliamentarians to free members of the public. Especially those members of the public who have disproportionately suffered through victimisation and a provable psychometric profiling, prejudice and discrimination. It is a responsibility of a parliamentarian to respond to a letter from the public. It is within every public officials remit to act within the International Covenant on Civil and Political Rights and also the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment and lastly the convention on the rights of disabled persons. I urge you to respond because I am actually from my perspective being tortured and I am at further risk of great harm. Great harm has already come to me via the pointed malicious neglect I have faced. Without intervention I will further suffer this malicious intentions to cause me harm in a way that attacks my potential prosperity and attacks my character in this conspiracy to pervert the course of justice.

- 1. At the apex of my persecution is a former partner Stefan Iasonidis - a wealthy man who worked for ASIO - who owes me a settlement for our time together but the Government protect him and his financial interests.**
- 2. In a dispute with a GP a powerful lawyer Mr Russell Ball silenced my evidence and he is a man who informs Government policy and advises the ombudsman. I have never had proper legal representation in my fifty years.**
- 3. The attorney general Mark Dreyfus refuses to acknowledge my many emails or calls.**

**4. Lastly just to prove how high this goes - The Office of Prime Minister and Cabinet who have at first acknowledged thousands of matches to my FOI now refuse it and say I don't exist. That FOI document would have revealed the following:**

- A former relationship in which I lived with and was engaged to be married with a public official in Stefan Iasonidis who worked at the time for ASIO, who the Government protect via demonstration that no Federal agency will investigate the exploitation whether it be The Tax Office, ASIC, Centrelink or ASIO or AGIS otherwise. To this day I'm unsure of how this plain fact could be overlooked, especially by all my fiends and family. Except - it was not equitable and he exploited me. Now, the Government are protecting his wealth and reputation at the expense of mine. See the attached letter from ASIC. See the attached 'carers' pension from Centrelink in which he unknowingly feathered his own nest exploiting my apparent 'illness' whilst earning 30000 a month at ASIO. I on the other hand, was studying and working whilst on a disability pension of less than \$450 a week. At that time I published a children's book: 'groan the Monster in 'What Do You Love?' And I utilised its launch to raise funds for The Royal Children's Hospital banksia unit for child and adolescent mental health. My perspective was using creativity for good and for sticking up for the underdog. His - was working for the man for over \$30000 a month and fathering his own nest by further exploiting my perceived disabilities by receiving a 'carer' pension.
- That I am a person of public interest and public profile because of a human rights awarded autobiography I wrote, (It was also SANE Australia's 'Book of the year' and was awarded a human rights award from the VHREOC)
- That I was a former illustrator for The Herald Sun and The Age, (The former vilified me in effect publicly humiliating me and the latter fired me because of my public profile attached to the autobiography),
- That I have a public profile as someone with a 'mental illness',
- That I have achieved a Dr of Philosophy, at Victoria University,
- That I have spoken hundreds of times across the country including inside Parliament House in Canberra, and across local state national and international radio and TV,
- That the last attorney general will not acknowledge my justice issues at AAT after losing at AFCA and AHRC, and sent me to the SANE helpline,
- That this attorney general Mark Dreyfus - the pinnacle of everyone legal in this country to intervene - rejects all of my approaches to him,
- That I was framed by a very powerful lawyer Mr Russell Ball who silenced evidence I had about an unfortunate malpractice complaint about a GP at HCC, MHCC, The Police, IBAC, NHPOPC, AHPRA, The Victorian Inspectorate and The Ombudsman, (He advises the Government on policy and informs the ombudsman),
- I am banned at AFCA,

Let's look now at the AFCA issue:

As a democratic citizen of the country - I am now banned from engaging a federal statutory authority for the purpose of getting help and a resolution to do with financial issues. That is a place where by ordinary Australians can go to get issues of a financial nature or matter solved. But I am banned. Why?

I was banned because I threatened to whistleblow on staff at AFCA who were delaying denying and deferring my just financial settlements to an extraordinary degree whilst I didn't have enough to eat or a safe place I

could afford to stay. AFCA's own policy states that settlements of a financial nature of a financially marginalised person should be heard by an ombudsman within four to six weeks... but mine took over a year and a half. I suspected something was not right... now I am sure. I can prove it with evidence and I have in this email.

I sometimes record things because the nature of my illness puts me at a high level of uncertainty. One of those recordings is with Tim Gos head of service delivery at AFCA who is clearly gaslighting my way into financial oblivion and does so with a conceited audacity of someone who - as opposed to me - does not have money problems or justice issues. In the end - he was well aware of what he was doing as a conscious and malicious way in which to redact prosperity from me and cause me damage.

This problem for me was and is systemic and it is political and actioned by senior public officials in high levels of Government its linked in with my public profile and because the things I have to say threaten the state of things. It is also victimising me and victimisation is against the law. The legal definition of victimisation is when someone "subjects or threatens to subject the other person to any detriment". There are three types of detriment:

- **detriment relating to a personal injury including mental injury (personal injury loss),**
- **economic detriment that is not related to a personal injury (pure economic loss),**
- **detriment relating to damage to property.**

I have suffered enormous detriment - even to the point of a 'fatal' injury in which I was revived from death and for which I suffer a cognitive impairment. My entire home and contents were maliciously destroyed. I have been redacted possibly millions of potential dollars and I live in abject poverty. My economic loss has included in actual or reserved totals:

The way this has been allowed to occur without any advocate or legal help indicates how I am profiled and framed.

This is the very manner in which my conversation with Tony Riddell exposes the truth about Government psychometric profiling and scapegoating - that people can be so universally vilified it can kill them. Indeed that their demise is planned intended malicious and it has a goal of utter character assassination or destruction of that person or entity. You need money and a job to live - but when your prosperity and all legal help are intentionally denied to you from many sources that causes homelessness it is easy to see that there is a definitive and provable movement of oppression. The worst thing has been for me that my poverty is now dressed up as a mental illness and I am vilified for it. Tony Riddell suggested I will be a 'sacrificial lamb', yet I want to live and I don't want to die.

My AFCA banning is a situation that has caused massive financial losses because there is no place for my financial problems to be resolved.

The CDDC scheme though at [finance.gov.au](https://finance.gov.au) fails to acknowledge my losses and the misadministration that intentionally ran me into the ground or provide compensation.

In 2022 I met Tony Riddell, a former SAS soldier and survivor of the Blackhawk helicopter crash. I explained my story of oppression to him - how I felt I had been victimised and abused and had my prosperity intentionally and maliciously redacted from me in order to cause me harm. He responded in conversation with the very mechanism and methodology by which the Government can treat individuals that are psychometrical profiled and 'sacrificed' rather than admitting that the system is responsible for the architecture that allows scapegoats to exist. It is chilling listening:

You can intervene in the following ways:

1. Demand my Public Interest disclosure be upheld at The Commonwealth Ombudsman,
2. Force work safe mister Danny Pearson to respond to me in which I point out legislation that if a liability cannot be established then it is the ministers remit or the agencies responsibility to acknowledge the issue within 21 days (mine has been over two years),
3. You could demand that an equal fair and reasonable settlement happen between my former partner and I (who worked for ASIO and whom the Government protects),
4. Advise of a way I can be safe without harm and additionally how I can progress this to the high court,
5. It is my opinion that I have and am being tortured. You could demand that the Convention against Torture and Other Cruel, Inhuman or Degrading Treatment or Punishment rights be followed as:

'For the purposes of this Convention, the term "torture" means any act by which severe pain or suffering, whether physical or mental, is intentionally inflicted on a person for such purposes as obtaining from him or a third person information or a confession, punishing him for an act he or a third person has committed or is suspected of having committed, or intimidating or coercing him or a third person, or for any reason based on discrimination of any kind, when such pain or suffering is inflicted by or at the instigation of or with the consent or acquiescence of a public official or other person acting in an official capacity.'

Acting to defend me is the right thing to do.

These political pawns have acted from afar to disable my life in cowardice and with enormous political power money and legal privilege. They are lawyers public officials and public servants. They are complicit to tow the party line because they are paid a wage that demands it of them. But one day - a public official or parliamentarian will see my story and they are going to be the once single figure who can blow this out of the water. They will say: 'Its sh\*t what happened to Rich McLean - I am going to help him!' I invite every politician to be that person. After all, its not just sh\*t what has happened to me, it is immoral, it is illegal, it is demonstrably because of prejudice and discrimination, and I have now identified it with evidence in this email for what it is: A conspiracy to pervert the course of justice.

To lose your home and contents in a fire is a tragedy - but what if it was planned maliciously? I was incarcerated under the mental health act in November 2022 enforced by police. Whilst incarcerated as a political prisoner, the Weribee mercy hospital and the Footscray police oversaw my landlord Hung Ho of Chelsea enter my home and remove all of my things and take them to the tipping effect destroying everything I own. I was rejected from the hospital into a homeless shelter with only the clothes on my back. My appeal to cover the losses of my possessions at VCAT is pointless. It is crystal clear that this has been an unbalanced uneven illegal and inequitable fight for me over many years. It is based in a prejudice stigma and a shame that is not mine to embody. Life is literally not economically or rationally sustainable for me at this time especially in terms of shelter food and medicine. All I want to do is live so that I can give again, and I was grateful to serve the community and I want to again.

Currently I do not have enough to stay securely in a home and there is not enough to live or eat or have medicine, I have never ever had a lawyer despite all these issues, I am a failed whistleblower, I cannot go to police, I can't rely on family, I can't rely on my few friends, the NDIS have locked up all my funding, the work place minister wont respond, nor will bill shorten or the attorney general, I'm banned at work safe, restricted communication at comcare, rejected at AHRC, banned at AFCA, rejected FOI from Office of Prime Minister and Cabinet, death threats from former partner who the government protects, can never ever get help at legal aid, framed at the ombudsman, rejected two work covers, rejected insurance and HCF income assist, my sexual abuse case where I was the child victim cited by a geelong magistrate as 'doomed' to fail, I've had my business website maliciously deleted along with my digital identity, my ABN cancelled from the tax department, I've been violently attacked three times, once inside a public hospital and one literally mowed down in the street by what I suspect to be a government or police undercover vehicle, and if you think I am paranoid I have recorded the secret service outside my old footscray squat.

I seek your immediate intervention so that I may be safe from further harm and be protected from the pointed neglect and victimisation I have horrendously endured. I would like you to act with an intention to create justice for my profound suffering and detriment in all ways because I have lost everything:

My job, my childhood, my work cover, my insurances, my rights, my access to the law, my life, my memory, my business, my digital identity, my home, my possessions, my family and friends, my freedoms, my happiness, my ability to cope, my semblance of a life resembling anything normal. But this is the hill I choose to die on. Today was my fiftieth birthday - a day that should have been with family and friends and prosperity. But instead I spent it with barely enough food with barely a home and not enough medicine. There was a small grace in meeting someone new but no calls from family or friends no cake no gathering my reputation in utter tatters for my self advocacy. Its enough to make you sick. Its enough to make you want to give up and kill yourself. It is true if this continued oppression goes on - then I will die a scapegoat but it wont be mental illness that kills me but it will be the systemic way I have been sacrificed by powerful people and a world who has been too afraid to 'dirty their hands' or ben involved with my business beyond their narrow remits. Its not brave or courageous that a person with money power and privilege with a job and privacy will witness this suffering and not acknowledge its profound reach and then eat whilst I don't - and then blame me for not budgeting. It is these very people - most people - that have become a part of my problem. For public officials who are paid large sums of money to be in the public service - they are all paid to tow the line and it would have only taken one brave official with some compassion to throw this out of the water. However they are paid to vilify me and further oppress me in their prejudice and judgements. It is neither brave nor courageous to have tenure of my further oppression and throw me under the bus. I urge you to act.

You know who is brave and courageous? Me! If I do however kill myself before justice arrives know that mental illness didn't do it but a collective violence of neglect and the fact that you didn't intervene. Now that this email is sent you would think it be impossible that I could be forced to continue to live without rights or compensation in abject poverty with hitmen at the door. I hope that is true - otherwise I'll either be killed or oppressed to death via a universal violence of neglect.

PS My former partner insisted I keep receiving a disability pension whilst we were together. That means for five years I committed Centrelink fraud. Hindsight is a wonderful thing - he was exploiting me as a public official in a very private way. You now must report it. When you do, this letter will be exposed. If every parliamentarian choose not to act on the body of this letter it means that parliamentarians are protecting him and the settlement he owes me. It means you would be willing for me to 'get away' with fraud imposed on me in order to protect his interests and that is not ok.

6th jan 2022 - Michael Cash refuses to intervene in my prediction my work cover would fail at ATT after I lost millions at the AHRC and AFCA. AAT is under her portfolio as well as these other two agencies. My case is heard at the AAT - and I lose my workers compensation likely a potential total permanent disability due to my brain impairment.

**Practical Functioning:** Based on educational and occupational attainment, as well as performance on  
tasks deemed to be less vulnerable to the effects of neurological change, the estimate of a person's  
selected functioning placed Richard between the Average and the High Average range.

**Orientation:** Richard was well oriented to person, place and time. He could accurately recall the current  
Prime Minister of Australia and describe a recent news item, although he could not recall the name of  
the former Prime Minister of Australia and the current President of the United States of America.

**Information Processing Speed:** Richard's information processing speed was variable with task  
performance ranging from intact to markedly slowed. Psychomotor speed was mildly reduced.

**Attention:** Immediate auditory attention span was within normal limits, with task performance falling  
within the Average range. Working memory (i.e. the ability to hold information in mind and manipulate it)  
further more was intact. More specifically, Richard was able to recite a list up to two digits forward  
easily and seven backward, four digits backward reliably and two digits backward, and he could  
perform a five-digit string reliably.

**Verbal:** New learning of auditory-verbal information (presented in a word list) was moderately reduced.  
Delayed recall of such information was also moderately reduced. New learning and delayed recall of  
more complex information (presented in the form of a list of stories) was mildly/moderately reduced.  
Complexity of Richard's oral communication was limited with large amounts of aural-verbal information. His  
comprehension of oral or written words was mildly reduced, with task performance falling within the Low  
Average range. His ability to learn and remember visual material (in the form of geometric designs)  
was intact.

**Language Skills:** Confrontation naming was intact. Richard's performance on tasks assessing  
vocabulary and general knowledge was intact (in the Average range). Semantic fluency was within  
normal limits, although he made some repetition errors.

**Visual-spatial Skills:** In relation to visual-spatial construction skills, Richard's performance margin  
between intact and severely reduced. His performance on a task was most likely influenced by planning  
and organizational difficulties (i.e. on a pattern and piecework approach to the task). Consequently, there  
was no primary visual-spatial impairment noted on testing.

**Executive Functions:** Performance on executive functioning tasks was variable. In particular, Richard's  
verbal set generation was intact, although he made some repetition errors when it suggested a  
repeated self-monitoring skills (e.g. the ability to alternate attention between two tasks) was  
moderately reduced. Of note, the performance on this particular task was more likely influenced  
reduced cognitive demands and not the ability. Planning/organization skills were severely reduced  
(with the addition to a delayed figure copying task (disadaptation to task only). See 12/20/2019 at
