Dear Mr Sarwar,

It is clear that a movement exists to de-value me and dehumanise me, even to kill me

That is quite evident, because of the systemic oppression and the conspiracy to pervert the course of justice that has and is occurring

Further, it emphasises an un-Godly mistake in the vile victimisation of one person, Dr Rich McLean

I simply cannot accept that the highest leader in the land has the agency to reject what is a legal obligation to my information

It is information I had hoped would reveal why and who is behind the systemic oppression and conscious omission of every systemic institution and organisation the Government oversees

This is the kind of toxic systemic gaslighting that identified me as 'mentally ill' when in fact, yes I was distressed - but that was a complex set of issues framed by how I had been character assassinated and framed as an extortionist by a GP's lawyer Mr Russell Ball.

Mr Ball advises the Australian Government on Policy

Further, I have suffered enormously with the abuse leading to my isolation and incorrect diagnosis and the brutal incarceration then malpractice that occurred in Feb 2021 where I was abused with such contempt that I attempted suicide with an agreed illegal contraband

The Mercy Hospital's FOI said it was 'fatal' and I suffer from an undiagnosed acquired brain injury and my personality has changed

I was found unresponsive, with no observable pulse and filled up with other peoples blood

Although it was me that committed the act - it was the systemic oppression and framing by systemic Government agencies and organisations that tipped me over the edge

This was also the workings on my former partner, Steve Iasonidis (11/12/1971) who worked for ASIO - his boss was David Irvine

Steve Iasonidis is a criminal mastermind and an intelligent and fierce manipulator and narcissist

Our relationship was fraught with toxic gaslighting and I had to go no contact

He stole my car, my whitewoods, left me with his dying dog Chopper - whom he named after Chopper Reid because Mr Iasonidis isolated him and knew him from his drug dealing days

He preached monogamy and stupidly I believed he was too - the level of pure evil deception additionally broke my spirit in a lot of ways

lot of ways

He coercively took advantage of a public figure in a financial and sexual way and blackmailed me.

I was a well known advocate - who has spoken across the country and advocated for all marginalised people almost exclusively out of altruism, so I refuse to believe that the Government has no data on me that exists.

That-is absurd

Mr Iasonidis still legally owes me over half a million dollars in an equitable and just separation as we were engaged to be married

Whilst I wasted my nest egg on him left with nothing - he was earning at the beginning of our relationship 20000 a month, whilst I was on \$350 a week on a disability pension.

This is the evil of a clinical narcissist who can convince with their charm almost unbelievable impossibilities of equity and equality to be accepted in order to exploit their victims

Just before I was incarcerated for the first time and then suffered the suicide attempt, I was left gobsmacked that despite any effort I went to, my friends disappeared, and my family rejected me, and no matter how hard I tried, I simply could not get a single lawyer to make an easy response to his lawyer which I would have regretted if I did not acknowledge the effort time and vulnerability and my human worth that was eclipsed in those 5+ years, and I could not find a lawyer - anywhere or anyhow

Mr Iasonidis has something to protect:

His money, his power, and his reputation and his privilege

I believe he has used his considerable political connections in order to frame me and to smear my reputation systemically across the Government and also in my personal life

He has another thing too hide too.

His criminality.

He is a tax evader, a drug trafficker, and he invested 1.2 million in an offshore tax haven, he was caught, because he worked for ASIO - and was given a slap on the wrist - a 200K fine.

Its easy - Just look at his tax records and his income statements and subpoena his financials

Because powerful people look after powerful people

Further, if someone is easily exploitable, such as myself who has a guilt complex about losing my virginity, and also a publicly known prior drug user, and on the spectrum of sexualities and additionally a publicly known person with a label of a mental illness...

I am pretty easy to kill maim or destroy in all ways for a skilled deceptionist and criminal sociopathic mastermind

... a criminal mastermind like Mr Iasonidis will do everything to exploit those vulnerabilities in order to remain dignified and not jailed, protect his assets from me and also his ar\$#

After I had to get Chopper euthanised because he was at the end of his life, Mr Iasonidis was not immediately told, because he had abandoned his pet.

Friends who knew the both of us consoled me as I was bereft of spirit now one of my companions was gone.

Every single friend was in defence of Mr Iasonidis in that they said I should tell him, which is not surprising considering upon our separation - he stayed in contact with everyone we knew in common, and he turned them against me

Two days before my hospitalisation, (I had already confessed everything I knew about Mr Iasonidis to crime stoppers because it was on my conscience) I advertised on my personal website that Mr Iasonidis told me he was:

Present at murders, one particular one an asian man who was shot at Collingwood flats.

Of course I have no evidence to give - my conscience is clear - apart from a brutally enraged sociopath - who left a mystery 'message' on my website chat, clearly from Mr Iasonidis.

I happened to screen snapshot it.

On Tues 18th Of May 2021 I made a statement - or at least tried to - at Flemington police station

This is my document from that date

I was in fear because I thought I may be killed

Certainly Dr Kumar of Empathy Healthcare knew of Mr Iasonidis and how scared I was of him

I went to Flemington police stupidly believing in justice

Monash Law clinics were helping me with the litigation against him.

They sent this extremely mild letter, below, is the message - a much sterner one - that I suggested that the lawyers take.

On this also - is the evidence that such was my fear of reprisal - I put in an application so that he could not come near me

The magistrates court rejected that - I do not know why that is until this day

I even reverse engineered this systemic oppression to the attorney general herself Ms Cash, after she condoned my vagrancy and demonstrated that she too, was 'in on it'.

I am still flabbergasted about how such senior officials - who do not know me personally - can with conscious arrogance and wilful omission definitely prove a conspiracy to pervert the course of justice in that they wilfully omitted evidence in congruence with others - and that - is all my prosecution needs to do in the high court to turn this Government on its head.

So - now I have a new enemy, born out of a few other cosmic coincidences and issues that have congealed into one

Im rightfully frustrated and angry - but the 'system' is intentionally appropriating this will 'madness'

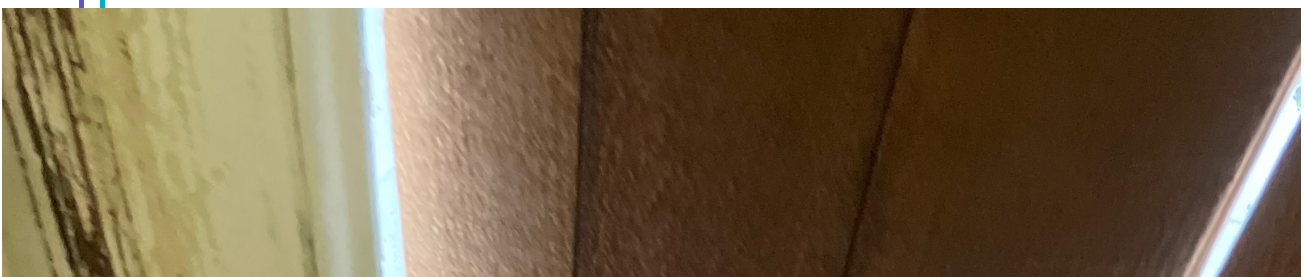
I need justice, not welfare...not more 'delay, deny, defer' methodologies of a systemic corrupt government that has acted much to my frustration and detriment

Furthermore to add to the incredible frustration of the letter from the highest man in the land PM Morrison and his

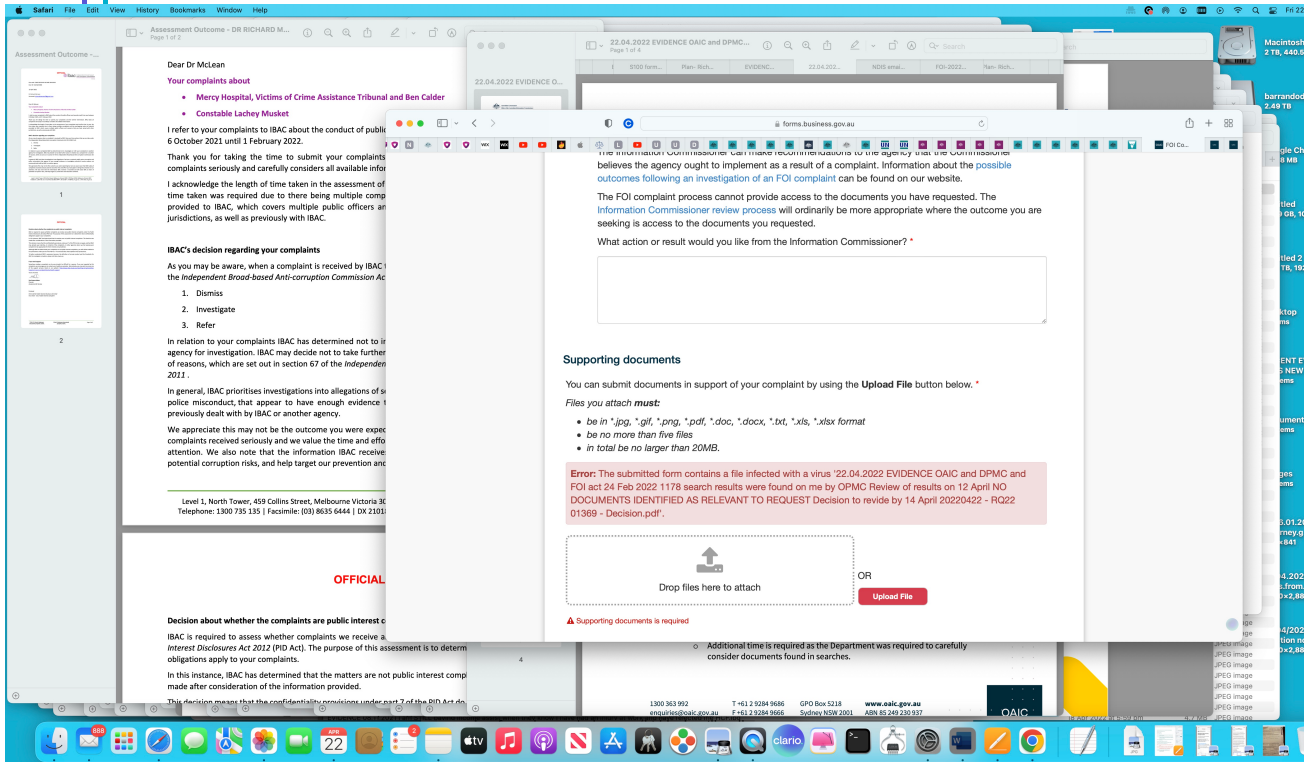
department that has literally made a conscious omission that adds weight to my already proven conspiracy for my prosecution to find you all liable for conspiracy to pervert the court of justice...

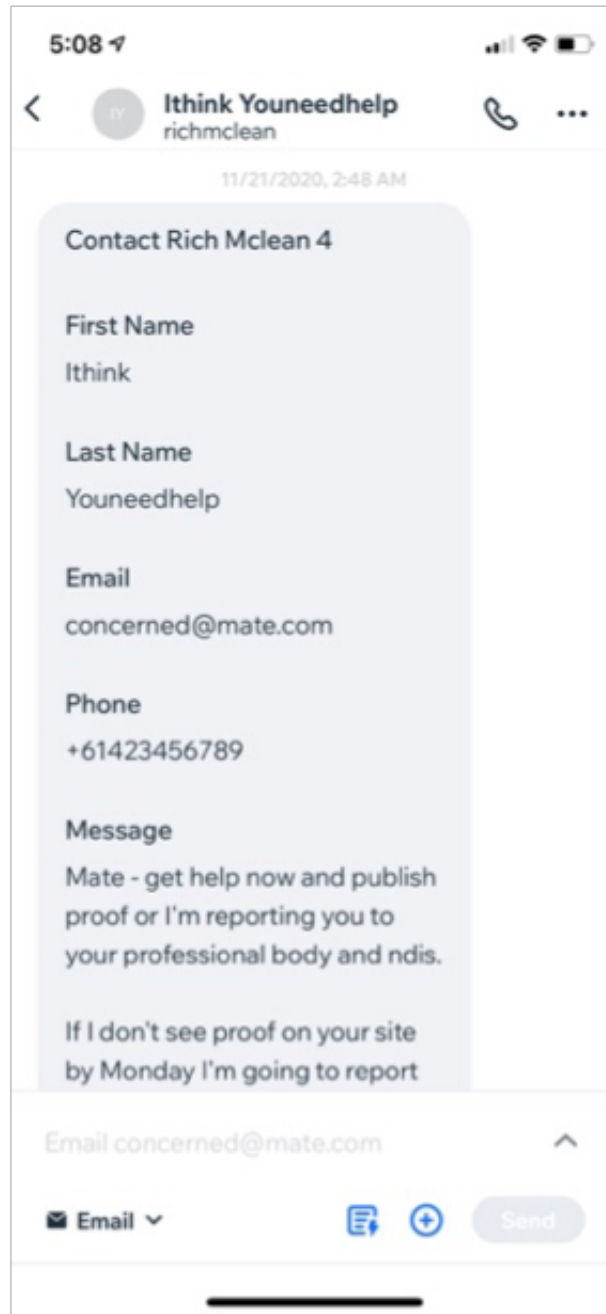

You sir, will be in my federal prosecution if noacknowledgement of the below is received and explained

Sunday, 22 May 2022

Regarding Dr Rich McLean. Today is May 2022, and Dr Mclean is a free man. He has been maliciously rendered though — an infamous vagrant with no voice no rights or agency to complain who has been damaged beyond repair.

Immediate whistleblower status is demanded before he is either incarcerated an award of the state, framed for a crime he has not committed and imprisoned, or murdered; either via an underworld figure or by a sustained violence of neglect that stems from the methodology that has seen him isolated from society, his family and friends.

Currently he is without a home, intelligently rendered forbidden from prosperity, without enough food, medication, healthcare, human dignity, value, access to litigation, banned from police, and already banned as a whistleblower and his PID rejected.

The office of Prime Minister and Cabinet rejected his FOI because 'nothing exists' which is out of step with the breadth of Dr Mclean's public profile and the millions of dollars he lost in detriment from AHRC, AFCA, ASIC, APRA, AAT, The Federal Police, and The Commonwealth Ombudsman.

This is despite them months earlier asking for more time from OAIC because it was too 'voluminous' and 'complex'

It makes sense to be complex because Dr Mclean was engaged tome married to Steve Iasonidis, a former ASIO employee who exploited Dr Mclean coercively for financial and sexual gain, and still owes him anequitable and legal separation of assets of over half a million dollars.

Dr Mclean has also been on the Government radar for having personal exchanges with Michaela Cash, the Attorney General,

MP Reynolds, who was the NDIS Minister, ignored by the then finance minister Birmingham which caused immediate detriment via rejecting the CDDC scheme.

He also had exchanges with health minister Greg Hunt, Victorian premier Dan Andrews, Adam Brandt, Mark Latham, The social services minister, Federal Police, etc

In fact after

Dr Mclean was also being sued by the Government, for publishing evidence in a desperate plight to demonstrate the perverse and inequitable and also illegal situation he was in

Additionally his workers compensation case from 22nd Feb 2021, failed at state work safe level and referred to Comcare, to be set up to fail at the end with Paul Fowler.

Paul Fowler is a mover and shaker there, and also the old boss (and a lawyer)at work safe.

This is called corruption.

He rejected it on a technicality of legislation, then appealed to the AAT for further delay deny defer tactics, all the while Dr Mclean scrambling to compose himself with the detriment of millions already passed, with not enough to eat, squatting.

That makes sense since Dr Mclean had an innocuous response from The Attorney General demanding intervention into corruption at Comcare and the AAT in his workers compensation case.

She not only condoned him losing, but referred him to a helpline for Dr Mclean anticipated and directly stated he needed

intervention not welfare. He needed a political intervention from Michaela Cash herself — yet she replied via a nameless person at her helm and identified Dr McLean with illness and conspired in the injustice

Predictably Dr McLean would lose, that is because he was ostracised from any litigation against the charter of human rights for people with a disability ratified by the Government in 2008. He was up against an impossibly inequitable force for which both member Purcell at the AAT admitted Dr McLean was at a 'disadvantage' and Kate Watson a 25 year specialised lawyer in that area abused her legal privilege.

That is because he was framed and catastrophically scapegoated and attacked via proxy of Government agencies to render him without any prosperity over many years of victimisation and a movement to destroy any prosperity Dr McLean may receive; and they were both well aware of it.

This journey of years and years of systemic oppression via internal Government agencies, was the causation of his suicide in Weribee mercy hospital in Feb, 2021.

He has never once had a lawyer. (The injury was cited as 'fatal' in the FOI documents from the hospital.)

His suicide attempt he survived purely by chance because he was discovered by accident with no observable pulse, and unresponsive. He was then revived from a certain death.

and being rejected from the hospital that the fact came through Dr McLean was framed by a lawyer who was a formidable stakeholder in Australian politics

This was by a GP's lawyer Mr Ball of Ball and Partners, a 40 year experienced lawyer who actually sits on the legal bar and informs Government policy. It is a wonder Dr McLean could not find a lawyer

and a lawyer

Mr Ball framed Dr McLean with libel and slander that he was an extortionist despite evidence in emails showing Dr Mclean was protecting the GP, who it was recently discovered since the event that led to overdose in 2017 from grief, malpractice and negligence, that the GP does now have an ABN or registered for GST and is currently not even registered with AHPRA

The following organisations never mentioned that evidence now in possession of Dr mclean to anyone outside of the organisation's that oppressed and silenced an innocuous recording that was direct evidence of what Dr Mclean was seeking a conciliation

HCC, AHPRA, NHPOPC, The Police, IBAC, The Victorian Inspectorate and the Ombudsman.

In fact Dr Mclean's struggle was set up to fail and he was ill equipped to oppose the vicious intentional and malicious slander that was internally shared to government agencies and statutory bodies by agents of power and privilege that Dr Mclean did not stand a chance

In the same time Dr Mclean was labelled an extortionist that is easily problems a conspiracy to pervert the course of justice, he was gifted 100k from his former landlord that he and his former partner, Steven, Stefan, Stefen Iasonidis lived in.

Mark Eng became aware of a 25 year career of advocacy for mental health issues that was almost entirely completed in altruism

He was also then aware of an autobiography that was SANE's book of the year and awarded a human rights award to high acclaim, and Dr Mclean's art,
The wealthy person then said weeks later the gift was made in error and asked for it back so Dr Mclean returned it

Dr Mclean has a generosity of spirit in his advocacy having

spoken from Melbourne Sydney Canberra to Parliament House and over the seas to Montreal.

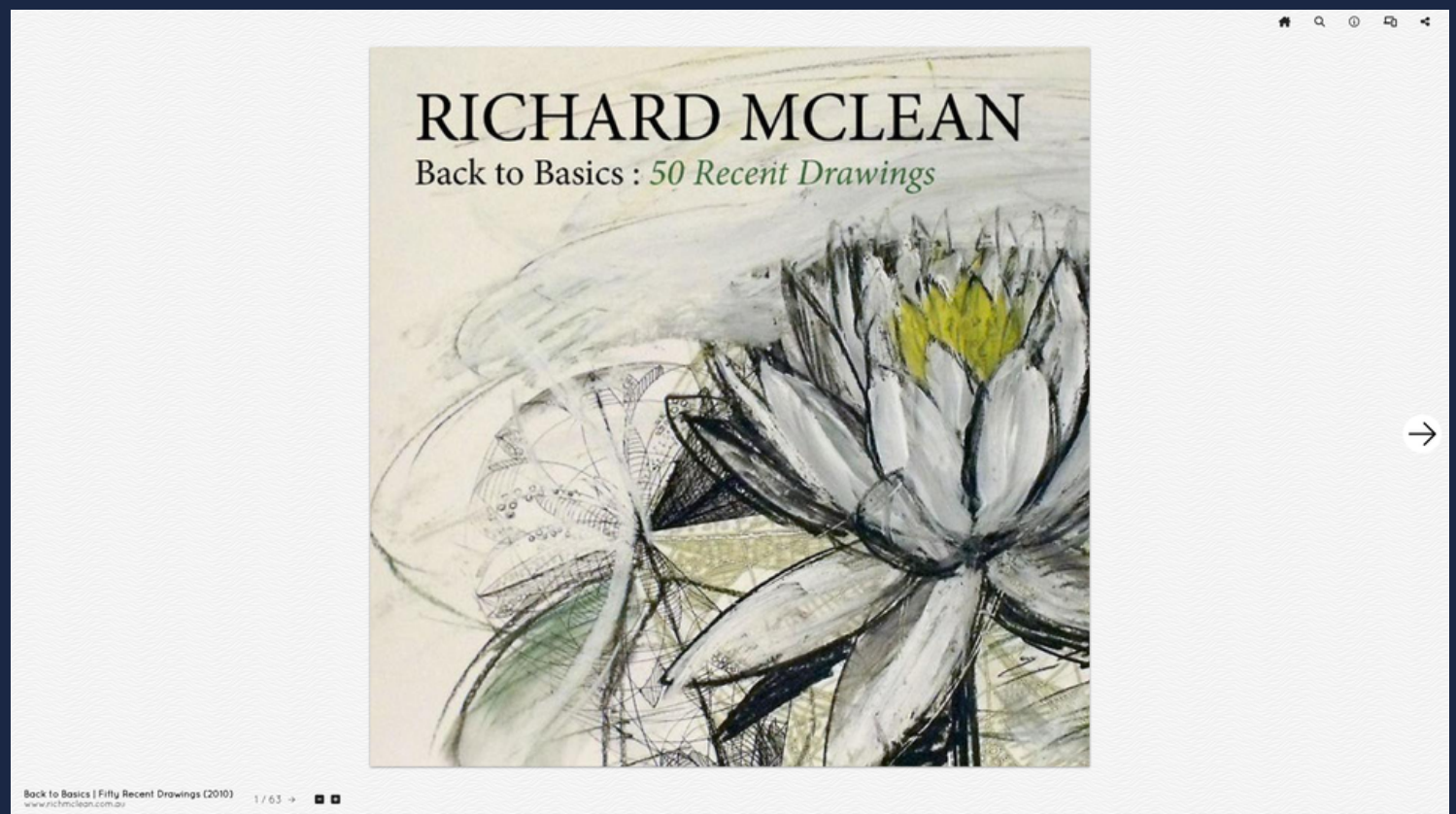

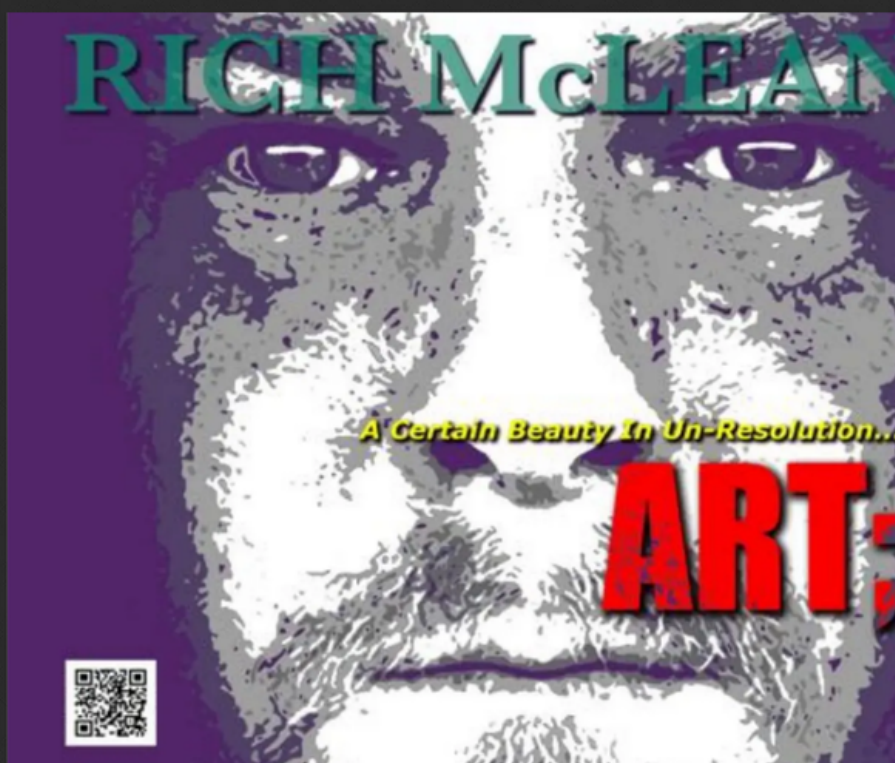

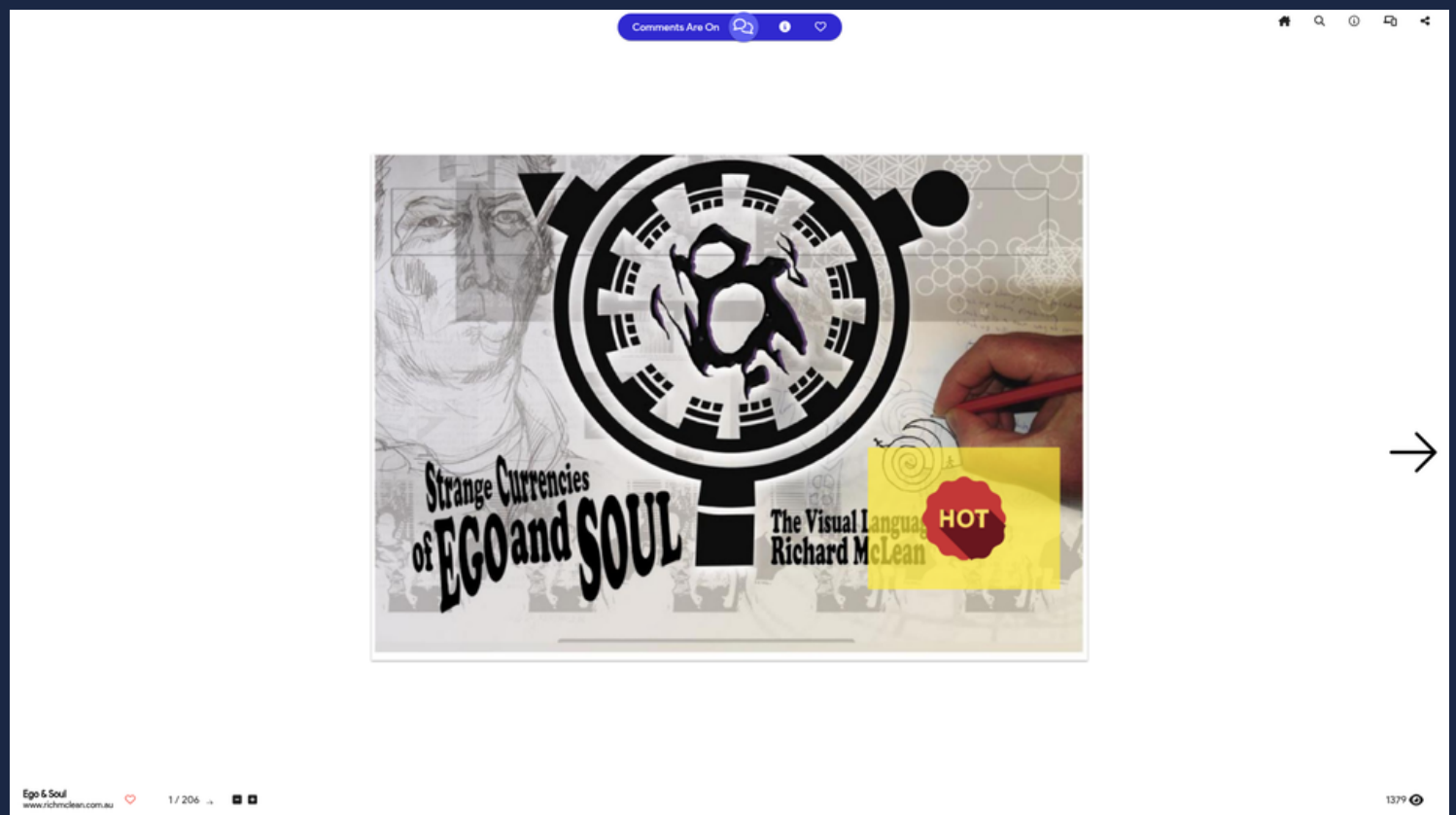
