(I shall explain what this means)

I state: That 'schizophrenia' is a term I utilised for time and just because you do not understand does not make wrong, more so you deficient in perceptions. Later in life it was used as a tool to exploit me and further oppress me in a vile victimisation that exploited perceived weaknesses leading to my incarceration and attempted suicide.. They called Jesus crazy too. Shame Im not him Hahaha Y'all been waiting though eh? ;-)

'Madness in individuals is rare in society it is the norm'. I wrote about this framed by the end of the Anthropocene and our multi dimensional realities in a Doctoral study. Read it here get ready to interbreed with inter-dimensional beings. (That already happened).

I am certain via the evidence below, I will not be subject to any civil, criminal or administrative liability for making a disclosure, unless a designated publication restriction is contravened without reasonable excuse or the disclosure is knowingly false or misleading.

The nature of the wrongdoing of my PID includes laws broken and includes detriment in regard to mental injury (personal injury loss); economic detriment that is not related to a personal injury (pure economic loss); and corruption victimisation prejudice from libel slander and further persecution that led to my 'fatal' injury.

The detriment is not the only issue, it goes further to includes the things that have been done wrong to me politically professionally personally socio economically loaded with prejudice hate emanating from the low levels of libel slander and stigma.

The law has been broken; this is man made or human law and followed me through life in a gutless way both before my 'death' or 'fatal' injury in Feb 21, and also afterwards to an even more profound degree as I was forsaken for the next 20 months until present.

A conspiracy to pervert the course of justice has and is occurring.

It is also an illegal and vile victimisation of me as a person and an abhorrent indignity to democracy when as a citizen I am not bound by the rule of law in my defence; but only in my persecution.

I am a rejected whistleblower at ASIC and APRA and IBAC and The Commonwealth Ombudsman, where I have been set up to fail.

It aids and abets my death via the elongation of my financial detriment and further oppression which was the causation of my suicide attempt in Weribee mercy Hospital.

The tragedy was deemed a 'fatal' injury and 'lethal attempt.'

The causation of my suicide attempt, was a conspiracy to pervert the course of justice, and further it was from a place of stigma and shame that was not mine, and a persecution so elongated and thorough beggars belief.

It still occurs and ongoing if the following does not change:

1. My evidence and PID refused,
2. The OPMC refuse my FOI,
3. Steve Iasonidis does not pay an equitable split of assets.
4. WorkCover Still outstanding at the AAT needs to be paid immediately,
5. An acknowledgement of HCF's fraud occurs overseen by Sheena Jack including owing me \$75000,
6. That IGIS refuse to investigate Steve Iasonidis, to their disgrace,
7. The Tax department refuse to look into Steve Iasonidis tax affairs, despite being aware of the situation and me being exploited,
8. Centrelink know were together for five years
9. The Police refuse to intervene (and oppress me at will)
10. I need an un-biased lawyer which is inside the remit of the charter of human rights, (which has been smashed off the charts),
11. I deserve medical care including but not limited to an unbiased GP, an independent psychologist, an unbiased psychiatrist, to access

dexamphetamine, as has been cited as an extraordinary success story with me by Dr Horgan.

12. The Government acknowledges I am a human being of merit and worth,
13. They must do this in an equitable way that is real and not coming from a place of prejudice, stigma or libel nor slander,
14. AFCA: Tim Gos and Peter Fisher are held accountable for their part in there of oppressing me overseen by, (name), who cost me 1-2million in detriment and set me up to fail are called out as conspirators,
15. AHRC : Liz Lindsberg be called out on tis shameful set up, for the causation of me losing over a 1 millions dollar + case by a supposedly impartial body that is 'impartial.'
16. AAT: Member Purnell called out and penalised for acting outside the charter of human rights for people with a disability.
17. LEGAL Kate Watson is reprimanded for acting outside the remit of legal privilege by representing the Government that has literally already killed me then forsaken me,
18. MALPRACTICE Dr Whitaker is taken to court in a legal and fair case for unfortunately being unwitting centrepiece for this.
19. EXTORTION: I had no idea I was set up by Mr Russell Ball to fail at HCC, MHCC, AHPRA, NHPOPC, The Police IBAC, The Victorian Inspectorate, The Ombudsman because he has power and privilege and framed me internally as an extortionist.
20. INTERNET:n Detriment paid by Micron21 who maliciously destroyed my online business www.richmclean.com.au.
21. COVER UP: This destroyed my digital identity and my business with intentional hate to damage me, and they did it with impunity and protection from over arching statutory agencies, SBFEO and The Telecommunications Industry Ombudsman, and business.gov.au and others,
22. VICTIMISATION: is called out as crude and abhorrent and systemic throughout Government agencies,
23. LIBEL / SLANDER: Called out after people such as Mr Iasonidis ad I think Mr Ball exploited me in a manner which to punish me for sticking upper myself from cowardly positions of privilege and they like many acted anonymously via proxy,

24. TPD: I am paid the erroneous amounts of detriment for my 2007 Health Super payout because the evidence demonstrates that I was due for two units of cover (TPD and also Income protection), as per the 2007 PDS yet I was paid one.
25. AFCA: Take responsibility for setting me up to fail.
26. INTERNET: My communications have been intercepted and that inappropriate posts have been put on my computer system, and images planted set me up.
27. PRIVACY: I am in no way not under the eye of authorities.
28. FEELING SAFE: With my image identity and reputation smashed and my location known I am vulnerable to reprisal from above or underground figures.
29. HARASSMENT: I am consistently harassed by police, and further exploited for perceived mental health issues and this is invalidating as a human being and they know it.

31. INADEQUATE HEALTHY CARE:
32. UNETHICAL PRACTICES: I am medicated for 'psychosis' - for a 'delusion' that is real which is an inequitable and irrational form of systemic government abuse.

35. LIBEL & SLANDER: I have been framed as an extortionist, called a rapist, a pedophile and worse.

I have evidence I reverse engineered this from a humble beginning serving what was right.

- Freedom from exploitation crushed
- Systemically oppressed by many Government agencies and statutory authorities
- My worth as a human being devalued

- Robbed financially and intelligently maliciously and intentionally rendered a vagrant
- This was in order to aid and abet my death by suicide
- It was in defence of money and power and privilege and reputations to uphold.
- Devalued of human dignity
- Tortured systemically and punished with incarceration framed with madness
- The subject of conspiracy quite unwittingly
- Me being denied the liberty and will to live
- Systemically oppressed as a person of interest and enemy of the state
- Denied legal representation
- Denied fair process and denied a fair go
- The charter of human rights of a person with a disability destroyed (list ways)
- An existing 'illness' or a vulnerability that was intentionally systemically exploited
- This systemic oppression underpinned especially by Mr Iasonidis and Mr Ball and the Magistrate were underpinning the difficult years I had and the causation of my suicide.
- I remind you all I had completed a PhD and worked then moved a few times constructed my own business designed a website and online store
- I ran my business and finances smoothly for over two years before this intelligently designed crystal clear and provable vile oppression became so deceitful hurtful and mind blowing bewildering - it caused my suicide attempt

- Even then further, it was not satisfactory that I had suffered a 'fatal' injury or indeed, suffered. The immeasurable suffering was intelligently elongated in order to rob me of prosperity and aid and abet my death.
- The date is 01.08.2022 and I have lived in an intelligently designed poverty without enough to even exist for 18 months, whilst being owed an enormous detriment.
- This vile victimisation is overseen by cowards acting via proxy to ruin me - hoarding money privilege political power and guarding their precious reputations in the destruction of my life liberty and ability to even earn money or receive income.
- Who committed the wrongdoing?

OPMC refuse my FOI.

All the while corruption at AHRC, ASIO, AGIS, Tax Department, Centrelink, Ministers, AFCA, Small Business and Family Ombudsman, Telecommunications Industry Ombudsman, HCC, MHCC, AHPRA, NHPOPC, The Police, IBAC, The Victorian Inspectorate, The Ombudsman, ASIC, APRA, AFSA, to the Attorney general.

I am after all, an artist author and advocate who is human rights awarded has doctorate and has lived with mental illness.

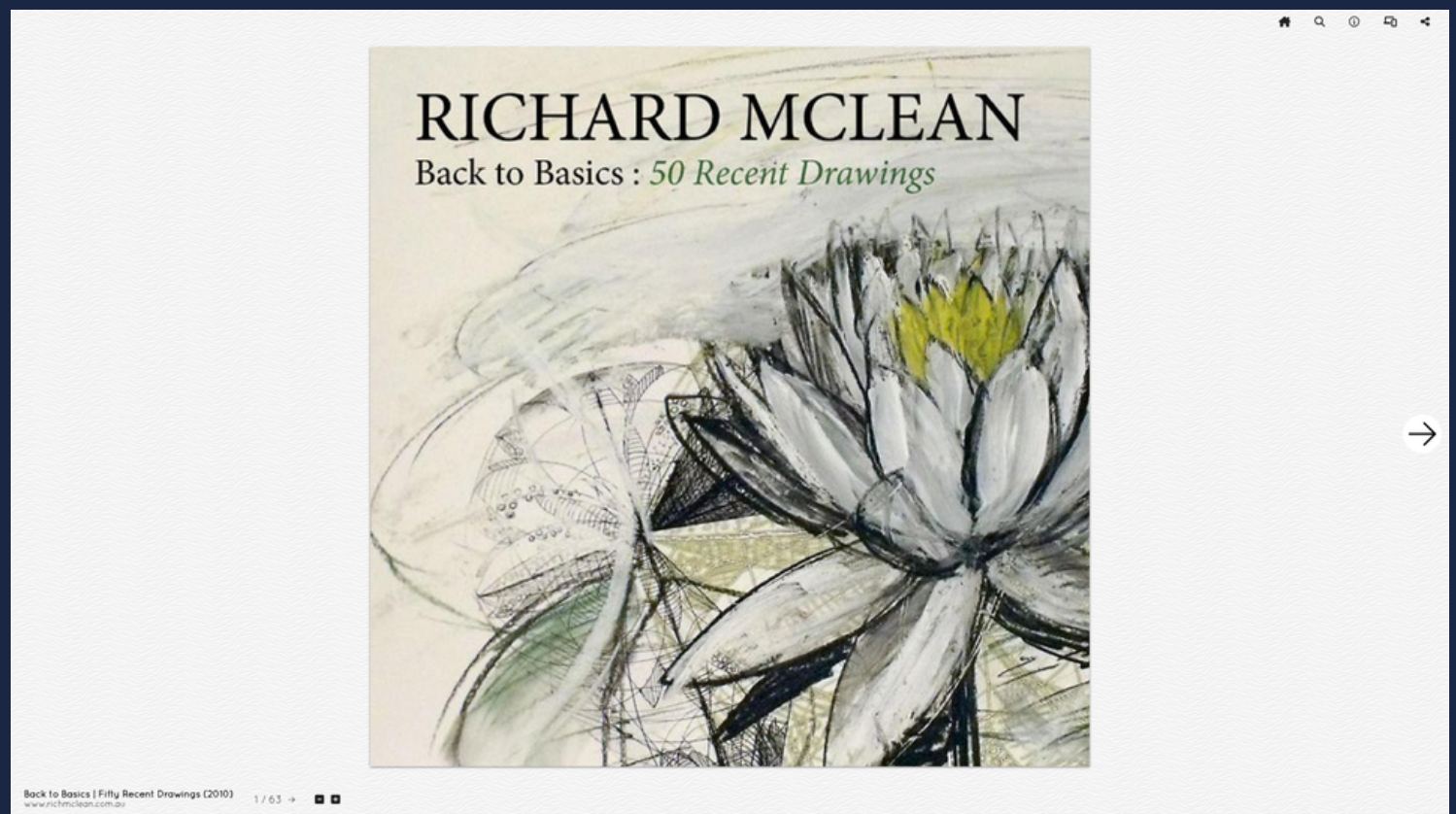

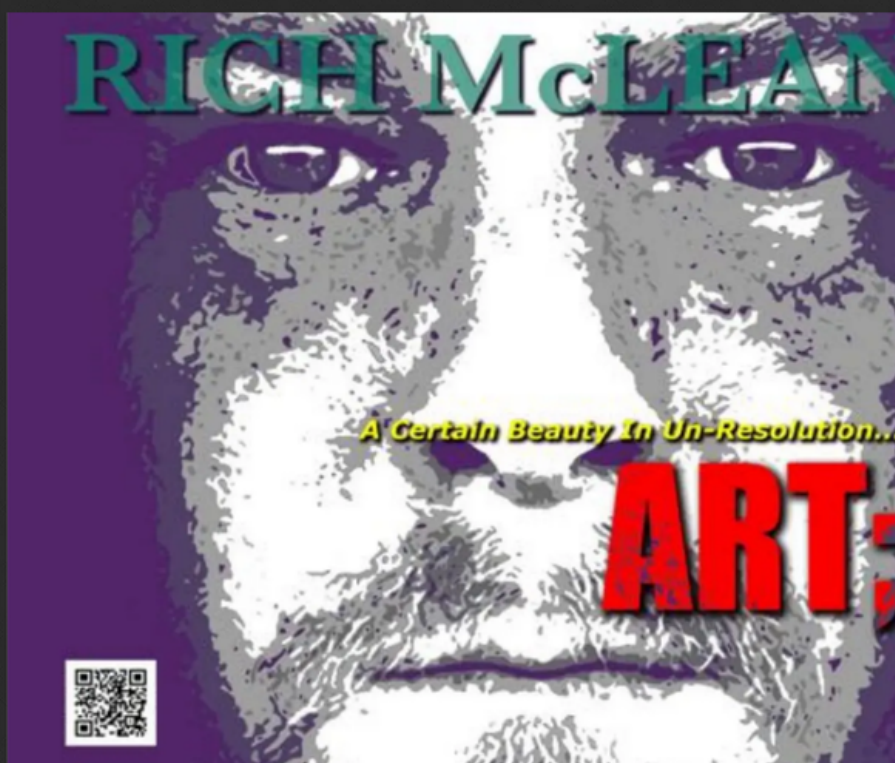

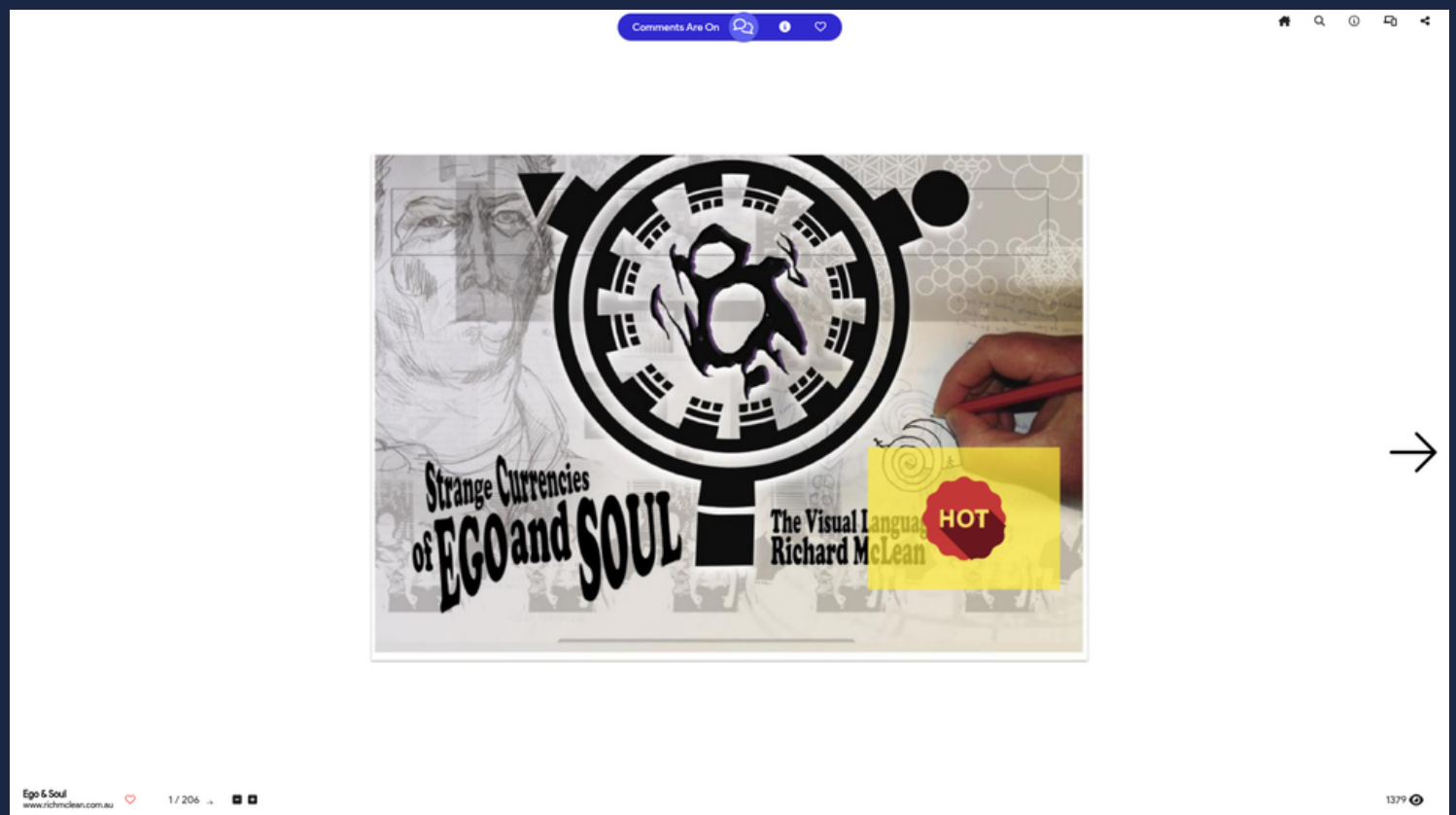
