Abstract

This forensic academic thesis examines the documented testimony of Dr. Richard William McLean (pen name Barran Dodger; ABN 78 833 496 164), archived at barrandodger.com, through the lens of 22 major world sacred traditions spanning six continents and over 65,000 years of continuous human spiritual inquiry. The purpose of this examination is not to assert that Dr. McLean is the founder or fulfiller of any specific tradition, nor to appropriate any living tradition for external purposes, but to determine — in a fact-checked, evidence-based, primary-source-verified manner — whether the structural, ethical, and testimonial dimensions of Dr. McLean's documented experience carry significance that persons from any faith tradition can recognise through the lens of their own sacred framework.

The testimony under examination includes: 14 involuntary psychiatric hospitalisations across 35 years (1990–2025); financial guardianship under the NSW Trustee and Public Guardian; documented losses of \$18M–\$32.9M (\$112M total forensic economic claim); an active death threat before Wyong Local Court (14 May 2026, Receipt I88267509); five missing person registrations across three states; a 2,304-exhibit archive blockchain-sealed to the Bitcoin network; 484,000+ downloads without promotion; and simultaneous notification of 60+ institutions including the ICC The Hague and UNHCR Geneva.
