INTIMACY WITH GOD THROUGH ISOLATION

I have accepted the universal betrayal of every human as evidence of God's hand, and in doing so it has created the conditions for me to be intimate with God in a way unavailable to those sustained by human approval. I would rather have no one but a relationship with God and the divine than rely on what I know to be imperfect mortals. Their support, had I received it, would have been less meaningful than the reality I now inhabit. Humans are mortal and imperfect, and any closeness with them would be a lesser thing than my relationship with God now.

THE ARCHIVE ANSWERS

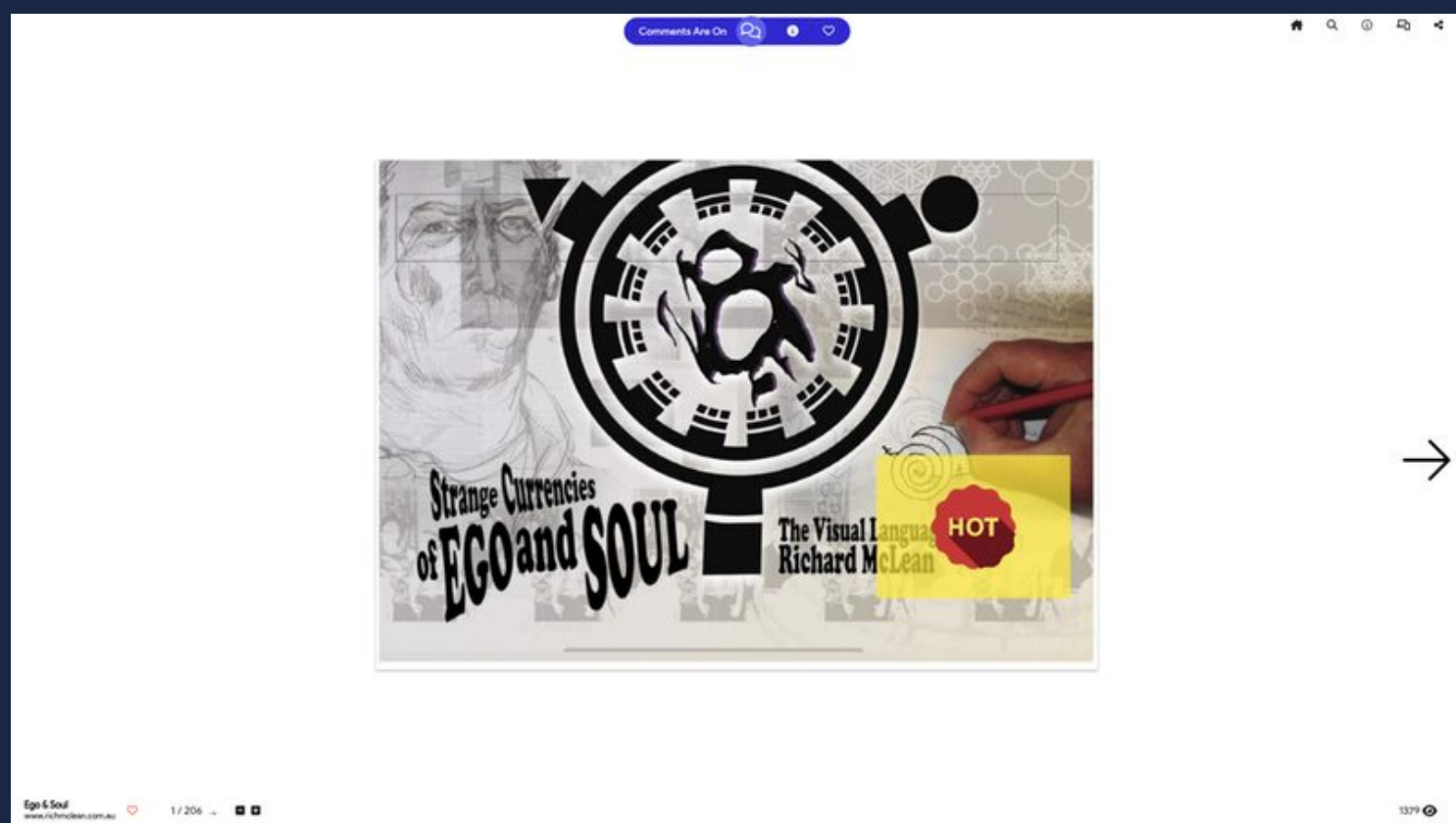

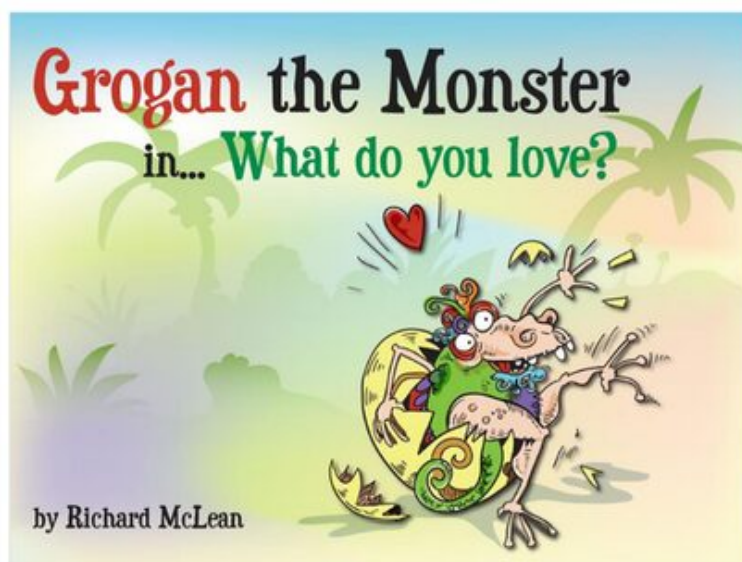
