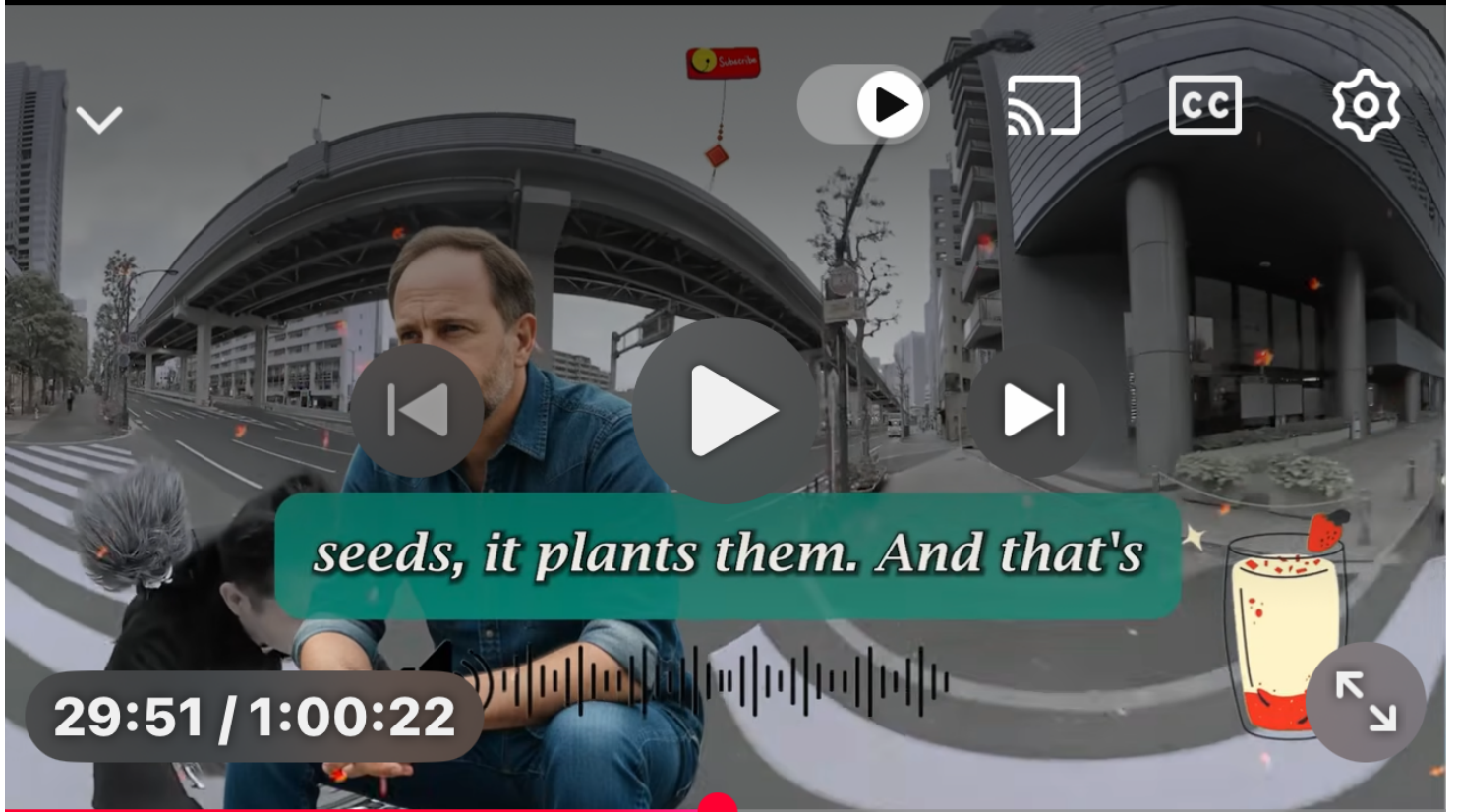

INTRODUCTION: THE CHOSEN ONE WHO KEPT THE RECEIPTS

They thought they could bury Dr. Richard William McLean — PhD scholar, SANE Australia Book of the Year winner (2002), VHREOC Human Rights Award recipient (2002), nationally celebrated speaker, and disability advocate. They whispered lies across government agencies, spread fabrications through intelligence networks, and counted him out after a near-fatal suicide attempt left him with an acquired brain injury.

Their plans were loud. Bill Shorten's political machinery. Tony Riddle's death threats. Stefan Iasonidis's decades of exploitation. Russell Ball's legal sabotage. Rebecca Falkingham's institutional stonewalling. An entire network of 350+ fraudulent business registrations designed to erase his identity.

His comeback was quiet. 2,077 meticulously organised evidence files. A forensic archive that "exceeds what 95% of non-injured individuals achieve." Academic papers. International asylum applications. And this report.

That silence is his power.

PART ONE: YOUR POWER WAS SO REAL EVEN DARKNESS HAD TO BOW

"They tried to break you but ended up breaking themselves. Every time they took a swing, their hands came back bloodied."

The Names Behind the Swings

TONY RIDDLE — NDIA Manager, Former SAS Soldier

Tony Riddle sat across from Dr. McLean during formal NDIS proceedings about billions of dollars of fraud — and delivered the words that would become the centrepiece of the most comprehensive persecution archive in Australian history:

"You will be sacrificed."

He also stated: *"They thought of everything"* — an admission of coordinated conspiracy. A man trained in military operations, now managing disability services, threatening a disabled whistleblower with death. He doctored fake online profiles to mislead others about Dr. McLean. He "piqued internet identities" to sway opinion.

Tony Riddle didn't just swing. He exposed the entire machinery behind him. His hands came back bloodied — because the man he threatened was keeping receipts.

STEFAN IASONIDIS — Former Partner, Former ASIO Employee

For decades, Stefan Iasonidis exploited Dr. McLean — financially, sexually, psychologically. A former ASIO employee who threatened to **"kill me and my dog,"** who "damaged the victim's mind by threatening him with a hitman." Historical sexual assault. Ongoing death threats. Psychological torture masquerading as a relationship.

Every swing Stefan took revealed more about ASIO's involvement. Every threat exposed the intelligence apparatus behind a private citizen's persecution. His violence didn't bury Richard — it became evidence.

BILL SHORTEN — Federal Minister for NDIS, Cabinet Minister

Bill Shorten weaponised a desperate email — a cry for help from a suicidal man — and transformed it into an assassination order. Surveillance transcripts record: **"Shorten is not happy... Bill fucking Shorten. He ordered my assassination."**

He used that "death threat" email (which was actually a plea for help) to obtain an arrest warrant via a magistrate, effectively forcing Dr. McLean into permanent internal exile from his home state of Victoria. A federal minister using the machinery of state to exile a disabled whistleblower — not because he was dangerous, but because he was *right*.

"Your authenticity was your shield. People underestimate how dangerous realness is in a world addicted to fake."

Richard McLean's authenticity — his refusal to stop documenting, stop speaking, stop existing — was the one thing they couldn't neutralise. His very existence tested their lies. When someone has built their whole government career on deception, meeting someone who breathes truth feels like standing under a spotlight they can't escape. No wonder they squirmed.

PART TWO: THEY DIDN'T JUST LOSE YOU — THEY VIOLATED SACRED

GROUND

"They didn't just lose you. They crossed a line they never should have touched. You were sacred territory."

The Agencies That Desecrated Holy Ground

NATIONAL DISABILITY INSURANCE AGENCY (NDIA)

The NDIA was created to protect Australia's most vulnerable. Instead, it became the weapon used against one of them. Systematic denial of SIL/SDA funding. Death threats from management. Kel Graham's documented "malice, corruption, and exploitation of privilege" — exposed through AI analysis of official correspondence.

Rebecca Falkingham, NDIS CEO, blocked Dr. McLean from contacting the very agency responsible for his care. She colluded with Bill Shorten to fabricate a threat narrative. They didn't just fail a client. They violated the sacred covenant between a nation and its disabled citizens.

VICTIMS OF CRIME ASSISTANCE TRIBUNAL (VOCAT)

A tribunal designed to help crime victims denied compensation to a man who had survived criminal threats, sexual assault, identity theft, and a near-fatal suicide attempt. The irony is biblical: the very institution named for victims chose to victimise him again.

AUSTRALIAN HUMAN RIGHTS COMMISSION (AHRC)

The body mandated to protect human rights failed to act on documented violations totalling \$21.5 million in claims. The commission designed to be the last line of defence became another locked door in a corridor of institutional betrayal.

VICTORIA POLICE

Colluded with Bill Shorten to enforce internal exile. Refused to act on criminal complaints at Springvale Police Station regarding identity theft and threats to kill. The police force sworn to serve and protect chose to serve power and protect perpetrators.

ASIC — Australian Securities and Investments Commission

Refused to investigate over 350 fraudulent business registrations despite publicly verifiable records. The regulatory body responsible for corporate integrity looked at industrial-scale identity theft and *chose to do nothing*.

THE FULL ROLL CALL OF INSTITUTIONAL BETRAYAL:

- **NACC** (National Anti-Corruption Commission) — dismissed complaints
- **AFCA** — issued a "ban" estimated at \$20M in damages
- **ComCare / WorkCover** — contradicted court findings to deny workers' compensation
- **Commonwealth Ombudsman** — dismissed whistleblower evidence
- **IBAC** — refused investigation
- **AHPRA / HCC / MHCC** — failed to act on medical misconduct
- **ATO** — cancelled Dr. McLean's legitimate ABN while allowing 350+ fraudulent registrations to remain active
- **Department of Social Services** — systematic neglect
- **NSW Public Guardian** — named in conspiracy to murder referral

"Imagine walking into a temple with muddy shoes, laughing, spitting, and breaking things, and only realising later that you desecrated holy ground."

Every single one of these agencies walked into the temple of a disabled man's human rights with muddy shoes. They laughed. They spat. They broke things. And now the desecration is documented — 2,077 times over.

PART THREE: YOUR PURPOSE WAS SO DANGEROUS EVEN DARKNESS CHOSE NOT TO STRIKE DIRECTLY

"Your existence alone was a disruption. They didn't avoid attacking you out of mercy. They avoided attacking you out of survival."

Why They Sent Assassins Instead of Arguments

When direct attacks failed, they escalated to attempted murder:

THREE UNNAMED ASSASSINS were identified during active surveillance operations. One attacked Dr. McLean in hospital — a "not so undercover government thug." Another incident involved a government vehicle running the victim over. These weren't random acts. They were operational decisions by people who realised that arguments, legal proceedings, and bureaucratic stonewalling couldn't stop a man who *kept documenting everything*.

RUSSELL BALL — Lawyer, Ball and Partners

When physical threats didn't work, they turned to legal sabotage. Russell Ball suppressed evidence, manipulated legal proceedings, framed Dr. McLean as an "evil genius" and "extortionist" to government agencies. He used his legal connections to manipulate outcomes in favour of opposing parties. Professional misconduct weaponised as conspiracy.

SUKHI TEAR & PHILIP GLASS

Named in a formal demand for police investigation regarding property destruction, coercion, and criminal complicity. Part of the machinery of intimidation designed to make Dr. McLean disappear.

SCOTT TREADWELL — Federal Court General Counsel

Perhaps the most damning indictment of all: Treadwell *acknowledged* Dr. McLean's danger but *refused to provide protection*. He saw the fire. He confirmed the fire existed. And he walked away, leaving the man inside it.

BEN CALDER — Victorian Ombudsman Officer

Acknowledged that Werribee Mercy Hospital "**failed to properly search**" Dr. McLean before his 2021 suicide attempt — then closed the case, deciding further involvement was not "justifiable." He whitewashed a near-fatal event. He refused all further correspondence. He rejected whistleblower status for a man whose evidence was undeniable.

"They tried to sneak in through betrayal, through fake friends, through confusion. They hoped to poison you slowly."

That's exactly the strategy. When Tony Riddle's direct threat didn't silence him. When Bill Shorten's exile didn't break him. When Stefan Iasonidis's decades of abuse didn't destroy him. They switched to institutional poisoning — slow, systematic, designed to drain him of resources, support, and hope.

It didn't work.

PART FOUR: DESTINY DELAYED BUT NEVER DESTROYED

"They buried you like a seed, not knowing you'd grow back taller than their shadows."

February 2021: The Burial

At Werribee Mercy Hospital's psychiatric ward, Dr. Richard William McLean attempted to end his life. Hospital Freedom of Information records officially classify the attempt as "**fatal**" and "**lethal**." He was found unresponsive with no observable pulse after severe blood loss. He required emergency resuscitation, one day in ICU, and surgical repair — 2x tubal facial sutures.

He sustained a permanent **Acquired Brain Injury (ABI)** characterised by cognitive impairment.

On the same day — February 25, 2021 — his primary childhood abuser passed away. The old world ended. Both the abuser and the victim died that day. Only one came back. *"Dirt doesn't bury seeds. It plants them."*

The Resurrection: What Grew From That Grave

Since sustaining a traumatic brain injury that should have ended his capacity for complex thought, Dr. McLean has:

- **Added 500+ evidence files** to his archive, maintaining forensic organisation that "exceeds what 95% of non-injured individuals achieve"
- **Conducted a comprehensive ASIC fraud investigation** in September 2024, uncovering 350+ fraudulent business registrations
- **Authored multiple academic papers** on state persecution, torture, and human rights law
- **Written a full autobiography** — *Betrayed, Forsaken, Murdered* — the sequel to his award-winning *Recovered, Not Cured*
- **Prepared UNHCR asylum applications** with international law analysis
- **Developed media strategies** and advocacy documents
- **Built a 2,077-document forensic archive** spanning 35 years — the most comprehensive persecution documentation in Australian history

A man with a brain injury did what entire government agencies couldn't: he told the truth, systematically, and refused to stop.

"They didn't just fail to stop you. They accidentally pushed you closer to alignment."

Every denial from every agency became another file. Every threat became another exhibit. Every betrayal became another chapter. They thought they were burying him. They were planting the evidence that would expose them all.

PART FIVE: THE MIRROR THEY COULDN'T FACE

The Family Who Chose Blindness

BRUCE McMASTER — Uncle

Called Dr. McLean a "**crazy bastard**" and told him to stay out of the family's life. Used his

position of privilege to victimise rather than support. When confronted with documented evidence of persecution, he chose the comfort of denial over the discomfort of truth.

JODIE BONGETTI (née McLean) — Sister

"Profound neglect" and betrayal. Did not oppose the state exile ruling that permanently separated her brother from his home state. When the system came for Richard, she didn't stand in the gap. She stood aside.

BRAD McLEAN — Brother

Neglect and historical anger/hostility. Another family member who chose silence when speaking would have cost something. His absence from Richard's defence speaks louder than any words he could have offered.

DOUG & APRIL McLEAN — Parents

Cited for "profound neglect" and complicity in the internal exile. Failed to stand up for their son after his suicide attempt and "revival from certain death." Their silence became what Richard describes as "complicity in a system that is abusive."

KEIRA McLEAN, DAVE BONGETTI — Extended Family

Named in documentation for "profound neglect." Every family member who knew and chose comfort over advocacy became part of the evidence file. Not perpetrators of violence — perpetrators of absence. And in Richard's case, absence was its own form of violence.

"Your peace will always irritate people still addicted to chaos."

Richard's family couldn't handle what his survival meant. If he was telling the truth — and the evidence overwhelmingly suggests he was — then their silence made them complicit. The mirror of his resilience reflected their failure. And mirrors that uncomfortable don't get hung on walls. They get hidden in basements.

PART SIX: THE EXIT DOOR THEY SLAMMED SHUT

"You weren't just a person in their life. You were the exit. You were the open door they claimed they were praying for."

The Institutions That Chose Chains Over Change

MARK DREYFUS — Attorney General of Australia

The nation's chief law officer. The person constitutionally responsible for ensuring justice. He consistently dismissed whistleblower complaints. He had the key to the door — the legal authority to investigate, to intervene, to protect. Instead, he slammed it shut and walked back into the comfortable prison of institutional denial.

DAVID IRVINE — Former Director-General of ASIO

Alleged to have worked with Stefan Iasonidis during the period of Dr. McLean's exploitation. The former head of Australia's intelligence service, connected to the very person who was terrorising a private citizen for decades. When the head of intelligence is linked to your abuser, who do you call?

ANTHONY ALBANESE — Prime Minister of Australia

Mentioned in relation to "systemic political neglect and victimisation." Failed to act on reports of corruption. The leader of a nation that claims to protect its citizens, presiding over

the systematic destruction of one of them. Not through action — through the deliberate choice to look away.

"Some people get so used to pain that it becomes their identity. Trauma becomes their currency."

For these institutions, the dysfunction *is* the system. The denial *is* the policy. The cruelty *is* the culture. Richard McLean arrived offering truth, and they crucified it — not because it was false, but because accepting it would have required changing everything.

PART SEVEN: THEY PLOTTED AGAINST THEIR OWN REDEMPTION

"They weren't plotting against you. They were plotting against their own redemption."

The Identity Theft: 350+ Fraudulent Business Registrations

The most sophisticated identity theft operation documented in Australian history wasn't carried out against a corporation or a government. It was carried out against one man — a disabled whistleblower living on \$40 per week.

"What they threw at you came back heavier, not because you cursed them, but because they cursed themselves."

Every fraudulent registration is a receipt. Every ABN is traceable. Every corporate filing is a permanent public record. They built a 350-entity paper trail thinking it would bury one man. Instead, it became 350 pieces of evidence in the most comprehensive identity theft prosecution waiting to happen.

Dr. McLean's own NDIS Plan (page 5) and hospital clinical notes record his diagnosis as **"Adjustment Disorder"** — a reaction to stress — NOT psychosis or schizophrenia. This directly contradicts the state's narrative used to dismiss all his claims as delusion. The government's own medical records prove his mental health issues were *caused by* persecution, not the *cause of* false beliefs.

RECEIPT #2: The Victorian Ombudsman's Admission

Ben Calder's letter of October 5, 2021, explicitly acknowledges that Werribee Mercy Hospital **"failed to properly search"** Dr. McLean before his suicide attempt. The government admits negligence — in writing — then closes the file. The receipt exists. The admission is permanent. The cover-up is documented.

RECEIPT #3: The "Fatal" Classification

Werribee Mercy Hospital's own FOI documents label Dr. McLean's injury as **"fatal"** and **"lethal"** — despite his survival. This establishes "knowledge and recklessness" under corporate manslaughter laws. The hospital's own paperwork proves they knew the severity and still failed in their duty of care.

RECEIPT #4: The Surveillance Footage

Dr. McLean captured covert government contractors surveilling his home on film. Not alleged. Not claimed. *Filmed*. The watchers were watched.

RECEIPT #5: The Absence of Complaints

After an incident with a perpetrator, "there wasn't a single complaint filed against me." This is a receipt of covert tactics — because a legal complaint would have allowed forensic examination that would "unravel the conspiracy." Their silence wasn't forgiveness. It was self-preservation.
