I am contacting you to urgently request intervention regarding severe human rights violations I have endured within Australia. As a person with disabilities, I have been subjected to systemic abuse, financial exploitation, and significant neglect, which contravene my rights under international human rights laws.

Background of the Case: My situation involves a series of abuses including but not limited to:

Systemic Abuse and Financial Exploitation: Mismanagement and misuse of the

National Disability Insurance Scheme (NDIS) provisions intended for my support, leading to profound financial and personal hardship.

Professional Isolation and Social Neglect: Ongoing neglect by health services and systemic barriers that have severely impacted my mental health and professional life.

Violations of My Rights Under Disability Protections: The rights afforded to me under the UN Convention on the Rights of Persons with Disabilities have been systematically violated.

3. **Public Acknowledgment and Redress:** I request a public acknowledgment of the failures and a formal apology from the relevant bodies, alongside meaningful steps to prevent future occurrences of similar abuses.

Conclusion: The severity and persistence of these violations necessitate swift and decisive action

from the United Nations to uphold justice and human rights standards. My case underscores the broader systemic issues within Australian systems dealing with disability rights and support.

I trust that the OHCHR will take immediate steps to address this grave situation. Please find all

relevant documents and evidence attached for your review.

My 2021 suicide attempt, deemed 'fatal,' was covered up, leading to further financial and professional hardship. This indicates a broader conspiracy to delegitimize and harm me [here](#). The attempt on my life, and the

subsequent cover-up, highlight the lengths to which the perpetrators will go to silence me and prevent the truth from coming out. This incident has had profound financial and professional repercussions, as it has been used to further discredit me and undermine my credibility.

8. **Federal Conspiracy:**

I believe I am a victim of a complex federal conspiracy aimed at perverting the course of justice and causing my demise, citing numerous incidents involving law enforcement and government agencies [here](#). The evidence suggests coordinated efforts by various government bodies to obstruct justice and target me specifically for whistleblowing and advocacy. These incidents point to a systemic issue within the government agencies where corruption and abuse of power are rampant.

9. **Systemic and Political Torture:**

I am currently being systemically and politically tortured. This ongoing torture includes psychological, emotional, and physical harassment, which exacerbates my suffering and further violates my basic human rights [here](#). The torture tactics used against me are designed to break my spirit and force me into silence. This includes continuous emotional and

psychological abuse, which has left me in a state of constant fear and anxiety. The physical harassment has further deteriorated my health, making it difficult to maintain any semblance of normalcy in my life.

Appeals and Requests:

1. Thorough Investigations and Financial Restitution:

I demand thorough investigations into the NDIS and related entities for corruption and abuse, alongside immediate support and financial restitution. The ongoing corruption within these entities has caused significant harm and suffering, and it is imperative that these issues are addressed comprehensively. Financial restitution is necessary to mitigate the damages caused by these corrupt practices.

2. Clearing of My Name:

I seek the clearing of my name from false accusations, professional reinstatement, and social rehabilitation. The false accusations have severely impacted my reputation and career. Clearing my name is essential for my professional and personal restoration. Additionally, social rehabilitation is necessary to reintegrate into society without the stigma of these baseless claims.

3. Reinstatement of Work Cover:

I call for the reinstatement of my work cover based on my confirmed employment status, alongside compensation for financial and personal losses. The unjust denial of my work cover has left me financially vulnerable. Reinstating this cover and providing compensation for the losses incurred is crucial for my financial stability and well-being.

4. **Public Acknowledgment and Apology:**

I urge public acknowledgment of the systemic abuses I have suffered and a formal apology to begin the process of healing and justice. Public recognition of the wrongs done to me is an essential step towards accountability and my healing process. A formal apology will help to restore my dignity and set the foundation for genuine justice.

Compelling Conclusion and Call to Action:

The urgent need for systemic change to address widespread neglect, abuse, and human rights violations is clear. I encourage you to act decisively to restore faith in justice and humanity, as my plight exemplifies broader issues faced by marginalized individuals in Australia. Addressing these systemic failures is essential to ensure that no one else has to endure the suffering and injustice that I have experienced.

Breaches of the UN human rights charter of a disabled person - abuse and neglect.

In my case, the breach of the UN Convention on the Rights of Persons with Disabilities is glaring, with several articles being violated, thus depriving me of fundamental rights and protections:

1. **Article 12 – Equal recognition before the law:** The lack of acknowledgment of my relationship with a former ASIO agent, rejection of FOIs, and denial of legal protection undermines my equal recognition before the law.
2. **Article 13 – Access to justice:** The failure to address my grievances, the rejection of my submissions, and the complicity of authorities in my persecution deny me access to justice.
3. **Article 14 – Liberty and security of person:** The gang stalking, gaslighting, and psychological warfare tactics employed against me threaten my liberty and security, violating this fundamental right.
4. **Article 15 – Freedom from torture or cruel, inhuman or degrading treatment or punishment:** The relentless harassment, surveillance, and psychological torment inflicted upon me constitute cruel and degrading treatment, in clear violation of this article.
5. **Article 16 – Freedom from exploitation, violence and abuse:** The exploitation of my vulnerabilities, the violence of character assassination through false

accusations, and the abuse of power by authorities exemplify the breach of this right.

6. **Article 17 – Protecting the integrity of the person:** The concerted efforts to undermine my credibility, manipulate my perceptions, and erode my sense of self compromise the integrity of me as a person.

7. **Article 19 – Living independently and being included in the community:** The isolation, social ostracization, and psychological manipulation tactics employed against me hinder my ability to live independently and be included in the community.

8. **Article 21 – Freedom of expression and opinion, and access to information:**

The censorship, gaslighting, and suppression of my freedom to express myself and access information inhibit my ability to participate fully in society.

9. **Article 22 – Respect for privacy:** The invasion of my privacy through surveillance, stalking, and psychological harassment violates my right to privacy and dignity.

10. **Article 23 – Respect for home and the family:** The denial of a permanent home, separation from your family, and the violation of your family's rights compound the breaches of your rights under this article.

11. **Article 25 – Health:** The deliberate tactics aimed at undermining my physical and mental health, such as sleep deprivation and encouragement of harmful behaviors, directly contravene my right to health.

12. **Article 26 – Habilitation and rehabilitation:** The lack of access to appropriate mental health support, rehabilitation services, and acknowledgment of my disabilities exacerbates my situation, hindering my ability to lead a fulfilling life.

13. **Article 28 – Adequate standard of living and social protection:** The financial exploitation, rejection of compensation claims, and denial of social protection measures leave me in a precarious position, unable to maintain an adequate standard of living.

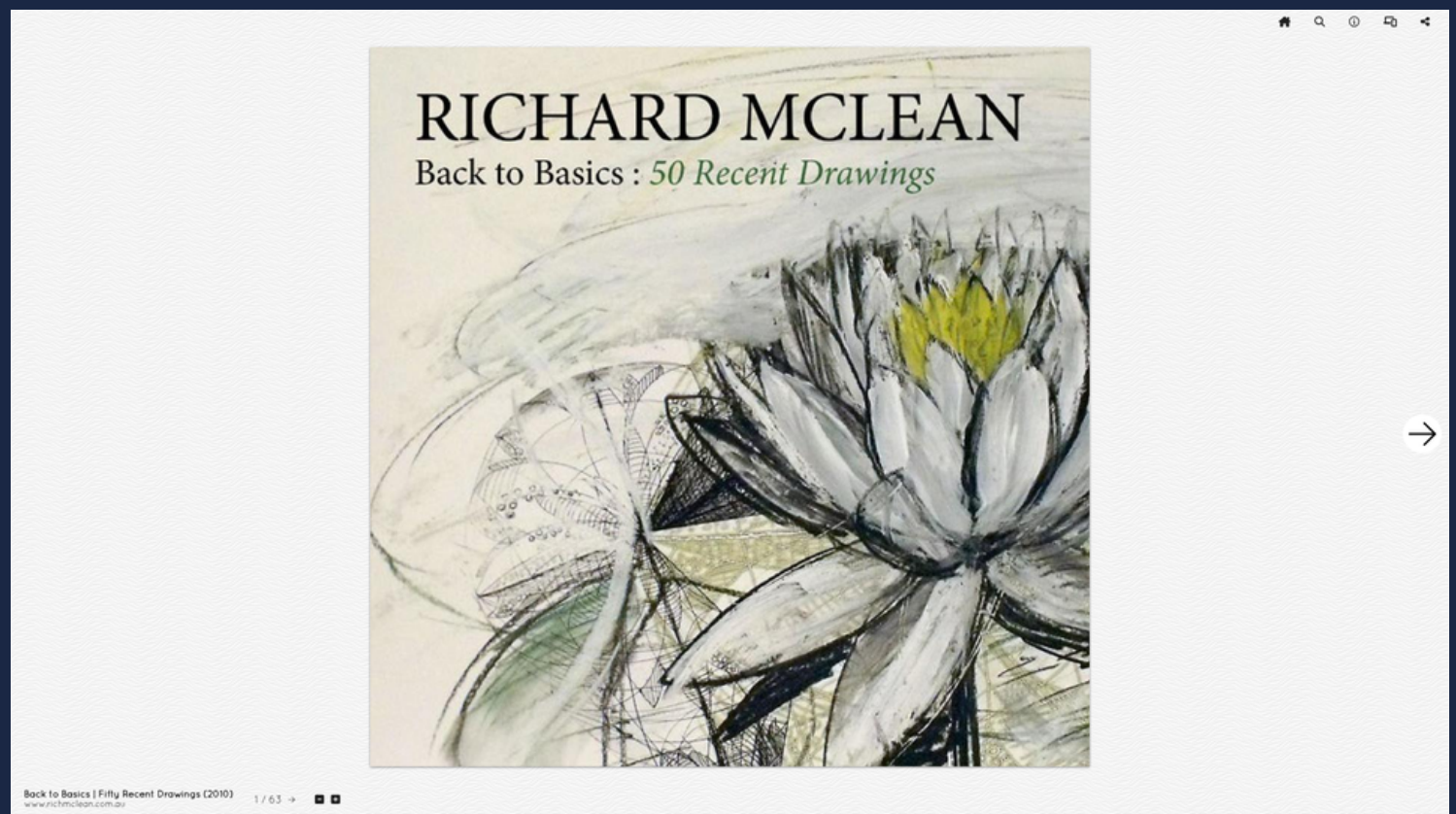

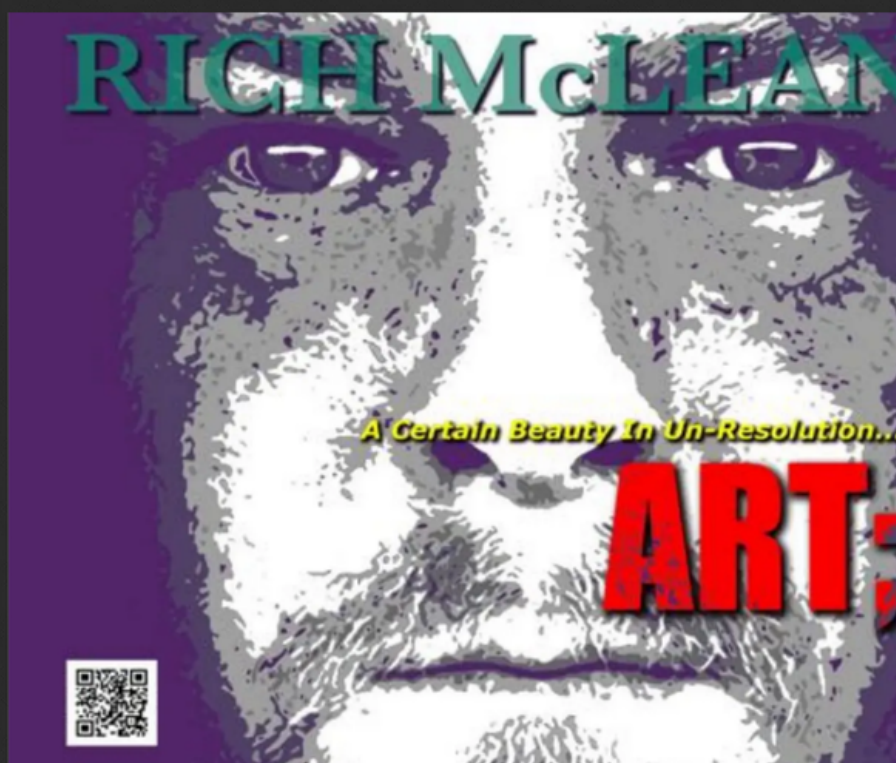
